The Planning Commission meeting of March 4, 2021, was called to order at 9:00 a.m. by Chair Weldy. Commissioner Haughey led the Invocation and Deputy County Counsel Jason Searles led the Pledge of Allegiance.

Due to the guidance from the California Department of Public Health and the Governor's Executive Order to stay home, a limited number of staff was present at the meeting.

Present at the meeting was Chair Jonathan Weldy, Commissioner Tom Haughey, Planning Director Heidi Duron, Deputy County Counsel Jason Searles, Senior Planner Steven Valdez and Administrative Assistant Lupe Biggs.

Participating remotely was Vice Chair Ray Allard, Commissioner Michael Stoffel, Commissioner Kareem Gongora and Applicant Michael Rosenthal.

The meeting was conducted pursuant to the provisions of the Governor's Executive Order N-29-20 dated March 17, 2020, which suspends certain requirements of the Ralph M. Brown Act.
