Approve travel for five Workforce Development Board members to attend the California Workforce Association Meeting of the Minds Conference in Monterey, California from September 3, 2024 through September 5, 2024, with travel initiating on September 2, 2024, at a total estimated cost of \$12,280.

FINANCIAL IMPACT

Approval of this item will not result in the use of Discretionary General Funding (Net County Cost). The total estimated cost of travel and attendance at the California Workforce Association Meeting of the Minds Conference (Conference) is \$12,280, for a per traveler cost of \$2,456, which will be funded through the Workforce Innovation and Opportunity Act (WIOA). The three-day Conference includes breakfast for attendees. Estimated travel costs are outlined in the following chart:

Expense	Amount
Airfare: five members x \$485	\$2,425
Lodging: (\$245/night (including tax) x three nights) five members x \$735	\$3,675
Registration: five members x \$848	\$4,240
Meals: (\$11 Breakfast x one; \$15 Lunch x three; \$24 Dinner x three) five members x \$128	\$640
Airport Parking: (\$15/day x four days) five members x \$60	\$300
Other Costs (taxes, tips, taxi): (\$50/day x four days) five members x \$200	\$1,000
Total	\$12,280

Airfare expenses include roundtrip travel from Ontario Airport to Monterey Airport. Flying into Monterey Airport rather than other destination airports was determined to be the most cost-effective option, as it eliminates the cost of rental vehicles, gas, and hotel parking, as these would not be required.

Sufficient appropriation and revenue have been included in the Workforce Development Department's (WDD) 2024-25 budget (571-2260).

BACKGROUND INFORMATION

WDD is requesting approval for five members of the Workforce Development Board (WDB) to attend the Conference from September 3, 2024 through September 5, 2024, in Monterey, California, with members traveling and arriving on September 2, 2024. During the Conference, WDB members will be given the opportunity to meet with workforce development professionals and leaders from business, government, labor, and education, to gain insights about the current state of California's workforce system. By attending the Conference, the WDB members will gain skills and become equipped to build competitive capacity for the local economy by addressing the needs of businesses and career seekers and refining the workforce system within the region. Additionally, they will learn best practices that will ensure their ability to shape the strategic direction of the County workforce system.

Section 13.0618 of the County Code requires Board of Supervisor approval of travel and expense reimbursement for members of all County boards, commissions, and committees.


