5	The Board of Directors of the San Bernardino County Fire Protection District, State
6	of California, ordains as follows:

8	SECTION 1. The San Bernardino County Fire Protection District hereby
9	designates the Fire Hazard Severity Zones as recommended by the California
10	Department of Forestry and Fire Protection pursuant to Government Code section 51178
11	and as shown in the California Department of Forestry and Fire Protection maps, dated
12	March 24, 2025, which maps are attached hereto as Attachment 1 and incorporated into
13	this ordinance by this reference. Any parcel subject to more than one Fire Hazard Severity
14	Zone classification must satisfy the highest, more stringent, classification applicable to
15	the parcel.
16	
17	SECTION 2. The Board of Directors declares that it would have adopted this
18	ordinance and each section, sentence, clause, phrase, or portion of it irrespective of the
19	fact that any one or more sections, subsections, clauses, phrases or portions of it be
20	declared invalid or unconstitutional. If for any reason any portion of this ordinance is
21	declared invalid or unconstitutional, then all other provisions of it shall remain valid and
22	enforceable.

24	SECTION 3. This ordinance shall take effect on July 21, 2025.
