AMENDMENT NO. 2

This Amendment No. 2 (this "Amendment"), effective as of the date of full execution, is made by and between Nordic Consulting Partners, Inc. ("Consultant") and San Bernardino County on behalf of Arrowhead Regional Medical Center ("County") and modifies the terms of the Agreement between the parties with the effective date of December 1, 2022 ("Contract"), as follows:

- 1. Section F.1 of the Contract is deleted in its entirety and replaced with the following:
 - F.1 The maximum amount of payments under this Contract shall not exceed an aggregate maximum of \$24,311,828, divided among several agreements between the County and various vendors for the Services. This Contract is only one of several agreements to which this aggregate maximum contract amount applies. It is, therefore, understood by Consultant that the payment to Consultant may be only a fraction of this aggregate maximum in accordance with any applicable SOW and the fee schedule in Attachment A. The consideration to be paid to Consultant, as provided herein, shall be in full payment for all Consultant's services and expenses incurred in the performance hereof, including travel and per diem.

Consultant bears the risk that it may not be able to generate its anticipated (or any) profit in completing its performance of all required items of work for the specified level of compensation.
