**AMENDMENT NO. 1
CONTRACT NO. 19-510
VERTICAL TRANSPORTATION SERVICES CONTRACT**

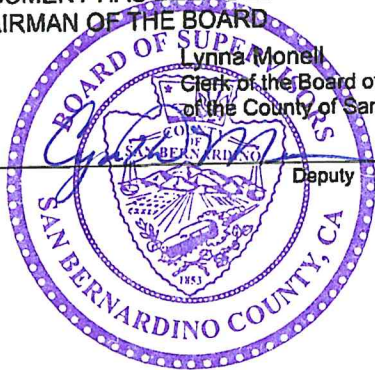
