

Ordinance No.

An ordinance of San Bernardino County, State of California, amending Subsection 13.0619(a) of the San Bernardino County Code of Ordinances, relating to compensation of election workers and payment for polling places.

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Subsection 13.0619(a) of the San Bernardino County Code of Ordinances is amended, to read:

13.0619 Special Services Fees.

(a) *Election Workers and Polling Places/Early Vote Sites.*

Ballot Security	\$ 300 <u>175</u> .00/day
Machine Technician	\$175.00/day
Supervisor	\$ 175 <u>300</u> .00/day
Assistant Supervisor	\$ 135 <u>260</u> .00/day
Clerk	\$ 100 <u>255</u> .00/day
Business Purpose Mileage*	IRS allowable rate
Bilingual Differential	\$ 40 <u>20</u> .00/day
Training Class Stipend	\$ 20 <u>30</u> .00/2-hour session
On-call Stipend	\$ 45 <u>30</u> .00/2 hours
Polling Places/Early Voting Sites	Negotiated by Registrar of Voters

SECTION 2. This ordinance shall take effect thirty (30) days from the date of adoption.
