#### Amendment No. 4

**IT IS HEREBY AGREED AS FOLLOWS:**

The following is Amendment No. 4 to Contract 4400018176 between San Bernardino County (County) and Life Builders Incorporated (Contractor) for Youth Empowerment, Group Therapy and Healing Circles (Services), which first became effective November 1, 2021, is amended and the following changes are hereby made and agreed upon effective October 7, 2025.

**I. SECTION F. 1 under FISCAL PROVISIONS** is hereby deleted and replaced as follows:

**F.1** The amount of payment under this Contract 4400018176 is increased by \$408,000 for a total not to exceed amount of \$958,000 and shall be subject to availability of other funds to the County. The consideration to be paid Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof.

II. All other terms, conditions of Contract No. 4400018176 , and covenants in the original Contract and subsequent amendments remain in full force and effect.

**ELECTRONIC SIGNATURES.** This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein.
