**AMENDMENT NO. 3  
TO THE AGREEMENT BETWEEN THE BIG BEAR AREA  
REGIONAL WASTEWATER AGENCY, CITY OF BIG  
BEAR LAKE, BIG BEAR CITY COMMUNITY SERVICES  
DISTRICT AND ZONE B OF COUNTY SERVICE AREA 53  
(FAWNSKIN), PREVIOUSLY REFERRED TO AS  
IMPROVEMENT ZONE "B" OF SAN BERNARDINO  
COUNTY SERVICE AREA 53, REGARDING PAYMENT  
AND COLLECTION OF TOTAL ANNUAL CHARGE AND  
STANDBY CHARGES**

**1. PARTIES AND DATE:**

- 1.1 Parties:** This Amendment No. 3 ("Amendment No. 3") to the Payment and Collection Agreement ("Agreement") is entered into on this 21 day of April, 2026 by and between the Big Bear Area Regional Wastewater Agency ("BBARWA"), City of Big Bear Lake ("City"), Big Bear City Community Services District ("District"), and Zone "B" of County Service Area 53 (CSA 53B). City, District, and CSA 53B are referred to herein as "Collecting Agencies." The Collecting Agencies and BBARWA are also sometimes referred to herein as the "Parties."
- 1.2 Effective Date:** This Agreement shall not become effective until the last date ("Effective Date") on which it has been approved and executed by each and all of the Parties.

**2. RECITALS**

- 2.1** On or about August 23, 2011, the Collecting Agencies and BBARWA entered into the Agreement in order to provide a new payment schedule for the Total Annual Charge, Service Charge, Infiltration/Inflow Charge, and the Standby Charge, during the term of the Agreement.
- 2.2** This Amendment No. 3 is authorized pursuant to Sections 3.6 and 3.11 of the Agreement.

**3. TERMS**

- 3.1 Term:** The first sentence of Section 3.1 of the Agreement is amended to extend the term of the Agreement until June 30, 2031. The balance of Section 3.1 (sentences 2 through 4) regarding the manner of termination of the Agreement shall remain in full force and effect.
- 3.2** Except as set forth herein, all provisions of the Agreement shall remain in full force and effect, and shall govern the actions of the Parties hereto and the amended provisions as set forth in this Amendment No. 3.

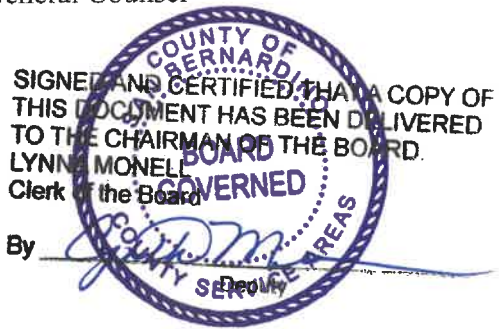
