IT IS HEREBY AGREED AS FOLLOWS:

TENTH AMENDMENT

Contract No. 14-110 to provide supplemental law enforcement services to LIVE NATION is hereby amended, effective July 1, 2022, as follow:

- (1) To update rates for service for 2022-23, by replacing the Schedule A referred to in Section II. A, with the Schedule A attached hereto and incorporated by this reference.
- (2) To replace the first sentence in **Section III** in its entirety with:
 - III. This contract shall be for a period of time commencing on March 1, 2014 through June 30, 2023.
- (3) To modify **Section VII – FULL UNDERSTANDING** by adding the following:
 - A. **ELECTRONIC SIGNATURES**

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

Except as amended all other terms and conditions of this contract remain as stated therein

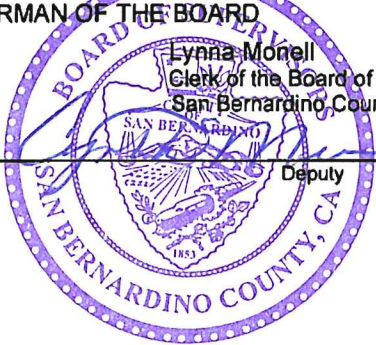

¹ Hourly rates include salary and benefit costs and are subject to change by Board of Supervisors' action. Any increase in the rates will be in the form of an amendment to this contract, signed by both parties. Rates for sworn personnel providing direct services to LIVE NATION includes 37.69% overhead rate which recovers the County's indirect costs, including the cost of sworn staff above the rank of Sergeant and all professional staff.
