

**RESOLUTION NO. 2022-48**  
**RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY**  
**TO ACCEPT ROADS WITHIN TRACT NO. 18805 IN LYTLE CREEK AREA**  
**INTO THE COUNTY MAINTAINED ROAD SYSTEM**

On Tuesday March 15, 2022, on motion of Supervisor Rutherford, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, section 941 of the Streets and Highways Code provides that no public or private road shall become a County highway until and unless accepted by appropriate action of the Board of Supervisors, or the Board’s designee; and

**WHEREAS**, the roads located within the boundary of Tract No. 18805 and hereinafter described, have been constructed, inspected and approved to County standards; and

**WHEREAS**, right-of-way for the roads located within Tract No. 18805 has been dedicated to San Bernardino County; and

**WHEREAS**, the roads located within Tract No. 18805 ensures that the appropriate infrastructure needed to support the existing land use is maintained.

**BE IT RESOLVED**, by the Board of Supervisors of San Bernardino County that the following roads located within Tract No.18805, in the Lytle Creek area, are necessary to public convenience and, therefore, are accepted into the County Maintained Road System:

Rocketcress Lane – Pokeroot Lane East 0.02M	0.02
