IT IS HEREBY AGREED AS FOLLOWS:

TWENTY SECOND AMENDMENT

Contract No. 02-1006 to provide supplemental law enforcement services to the California Speedway Corporation is hereby amended, effective July 1, 2022, as follow:

- (1) To update rates for service for 2022-23, by replacing the Schedule A referred to in Section II. A, with the Schedule A attached hereto and incorporated by this reference.
- (2) To replace the first sentence Section III – TERM AND TERMINATION with:

III. TERM AND TERMINATION

This contract shall be for a period of time commencing upon approval of the County Board of Supervisors through June 30, 2023. This contract may be terminated at any time, with or without cause, by CLIENT or by COUNTY upon written notice given to the other party at least ninety (90) days prior to the date specified for such termination. In the event of termination, each party shall fully pay and discharge all obligations in favor of the other party accruing prior to the date of termination. Each party shall be released from all obligations of performance which would

otherwise accrue subsequent to the date of termination. Neither party shall incur any liability to the other by reason of termination.

(3) To modify **Section VII – FULL UNDERSTANDING** by adding the following:

A. ELECTRONIC SIGNATURES

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

Except as amended all other terms and conditions of this contract remain as stated therein

¹ Hourly rates include salary and benefit costs and are subject to change by Board of Supervisors' action. Any increase in the rates will be in the form of an amendment to this contract, signed by both parties. Rates for sworn personnel providing direct services to the California Speedway includes 37.69% overhead rate which recovers the County's indirect costs, including the cost of sworn staff above the rank of Sergeant and all professional staff.
