**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY  
ESTABLISHING A 20-MILE-PER-HOUR SPEED LIMIT IN SCHOOL ZONES PURSUANT TO  
ASSEMBLY BILL 382 AND THE CALIFORNIA VEHICLE CODE**

On Tuesday, May 5, 2026, on motion of Supervisor \_\_\_\_\_, duly seconded by Supervisor \_\_\_\_\_ and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, San Bernardino County maintains various highways and roadways within the unincorporated areas of the County; and

WHEREAS, the Board of Supervisors is authorized under the California Vehicle Code, including Sections 22352 and 22358.4, and Assembly Bill No. 382 (Stats. 2025, ch.555), to establish reduced speed limits in school zones by resolution or ordinance; and

WHEREAS, Assembly Bill 382 authorizes local authorities, until January 1, 2031, to establish a prima facie speed limit of 20 miles per hour in school zones, as defined by law, when appropriate signage is in place; and

WHEREAS, school zones generally include roadways adjacent to or within approximately 500 feet of school grounds where children are present; and

WHEREAS, reducing vehicle speeds in school zones improves pedestrian safety, reduces the severity of collisions, and supports the safe travel of students, families, and school staff; and

WHEREAS, the Department of Public Works has evaluated County-maintained roadways adjacent to schools and recommends establishing a 20-mile-per-hour speed limit in designated school zones to enhance public safety; and

WHEREAS, the establishment of a reduced speed limit will become effective upon installation of appropriate regulatory signage in accordance with the California Manual on Uniform Traffic Control Devices (CA MUTCD);

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of San Bernardino County does hereby find, determine, and order as follows:

1. Establishment of School Zone Speed Limit

A prima facie speed limit of 20 miles per hour is hereby established on County-maintained roadways within designated school zones in the unincorporated areas of the County, when:

- Children are present;
- Flashing school-zone beacons are activated; or
- During posted school-zone hours.

2. Applicability

This Resolution applies to County-maintained highways and roadways located adjacent to or within school zones identified and designated by the Department of Public Works.

3. Signage and Implementation

The County Road Commissioner, and their designee, is authorized and directed to:

- Identify eligible school zones;
- Install and maintain appropriate regulatory signage and pavement markings;
- Install and activate flashing beacons where applicable; and
- Maintain records supporting enforceability of the established speed limits.

4. Effective Date

The 20-mile-per-hour speed limit established by this Resolution shall become enforceable upon the installation of appropriate signage and traffic control devices.

5. California Environmental Quality Act (CEQA)

The adoption of this Resolution is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3), as it can be seen with certainty that the action will not have a significant effect on the environment, and/or Section 15301 (Existing Facilities). The Department of Public Works is directed to file and post the Notice of Exemption in accordance with CEQA.
