IT IS HEREBY AGREED AS FOLLOWS:

WHEREAS, the INLAND COUNTIES EMERGENCY MEDICAL AGENCY (hereinafter referred to as "ICEMA"), and the WHITE MOUNTAIN FIRE PROTECTION DISTRICT (hereinafter referred to as "PROVIDER") have previously entered an AGREEMENT, Contract No. 19-864, for PROVIDER to provide for the delivery of basic life support and advanced life support ambulance services, when available, within Mono County, California for the initial period of January 1, 2020 through December 31, 2024; and

WHEREAS, ICEMA and PROVIDER desire to extend the term of Contract No.19-864 for an additional five (5) years, for the period commencing January 1, 2025, through December 31, 2029 (the "First Amendment").

NOW, THEREFORE, effective January 1, 2025, in consideration of mutual covenants and conditions set forth herein, the parties agree Contract No. 19-864 is amended as follows:

1. Effective January 1, 2025, the term of this AGREEMENT shall be extended for five (5) years for the period commencing on January 1, 2025, through December 31, 2029. Notwithstanding the foregoing, either Party may terminate this AGREEMENT at any time, upon ninety (90) days written notice to the other Party. In the event that PROVIDER is temporarily unable to meet the terms of this AGREEMENT, PROVIDER's Fire Chief, or designee, shall promptly notify ICEMA. In the event that ICEMA is unable to meet the terms of this AGREEMENT, ICEMA's EMS Administrator shall promptly notify PROVIDER.

- 2. This First Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same First Amendment. The parties shall be entitled to sign and transmit an electronic signature of this First Amendment (whether by facsimile, PDF or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed First Amendment upon request.
- 3. All other provisions and terms of the AGREEMENT shall remain the same and are hereby incorporated by reference. In the event of any conflict between the AGREEMENT and this First Amendment, the provisions and terms of this First Amendment shall control.
