### IT IS HEREBY AGREED AS FOLLOWS:

#### AMENDMENT NO. 1

San Bernardino County (County), through its included Sheriff/Coroner/Public Administrator (Sheriff) and Stephen Shea (Contractor), agree that Contract No. 25-814 (Contract), in which Contractor provides services as a Range Safety Officer for the County, is hereby amended effective January 13, 2026, as follows:

(1) By adding the following sub-section to Section V. COMPENSATION OF CONTRACTOR

P. DEPENDENT CARE ASSISTANCE PLAN (DCAP) AND FLEXIBLE SPENDING ACCOUNT (FSA) PLAN FOR MEDICAL EXPENSE REIMBURSEMENT

Contractor shall be eligible to participate in the County's DCAP and FSA Plans in the same manner as employees in the Administrative Services Unit and per the plan documents. Contractor shall not receive any County match contributions with respect to participation in either plan.

### ELECTRONIC SIGNATURES

This Amendment No. 1, and if applicable, any subsequent amendments, may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 1. The parties shall be entitled to sign and transmit an electronic

signature of this Amendment No. 1 (whether by facsimile, PDF, or other mail transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 1 upon request.

Except as amended, all other terms and conditions of this Contract remain the same.
