

RESOLUTION NO. 2024-62

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE G (WRIGHTWOOD), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone G, therefore, hereby finds and determines:

(a) That on June 3, 2003, the electors of County Service Area 70, Zone G, duly authorized a special tax levy for financing road maintenance services.

(b) That the amount of such tax shall not exceed \$375 per parcel, per year.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone G, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$375 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective on July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.

ATTACHMENT I

Adopt Resolution setting a special tax for County Service Area 70, Zone G (Wrightwood) in the Oak Springs Wrightwood area at \$375 per parcel.

Background: On June 3, 2003, the electorate of County Service Area 70, Zone G (Wrightwood) authorized an annual special tax of \$375 per parcel for the financing of the road improvements and maintenance. There are 436 parcels within the boundary of the district for total revenue of \$163,500 for FY 2024-25, in relation to estimated total proposed appropriations of \$345,472.
