


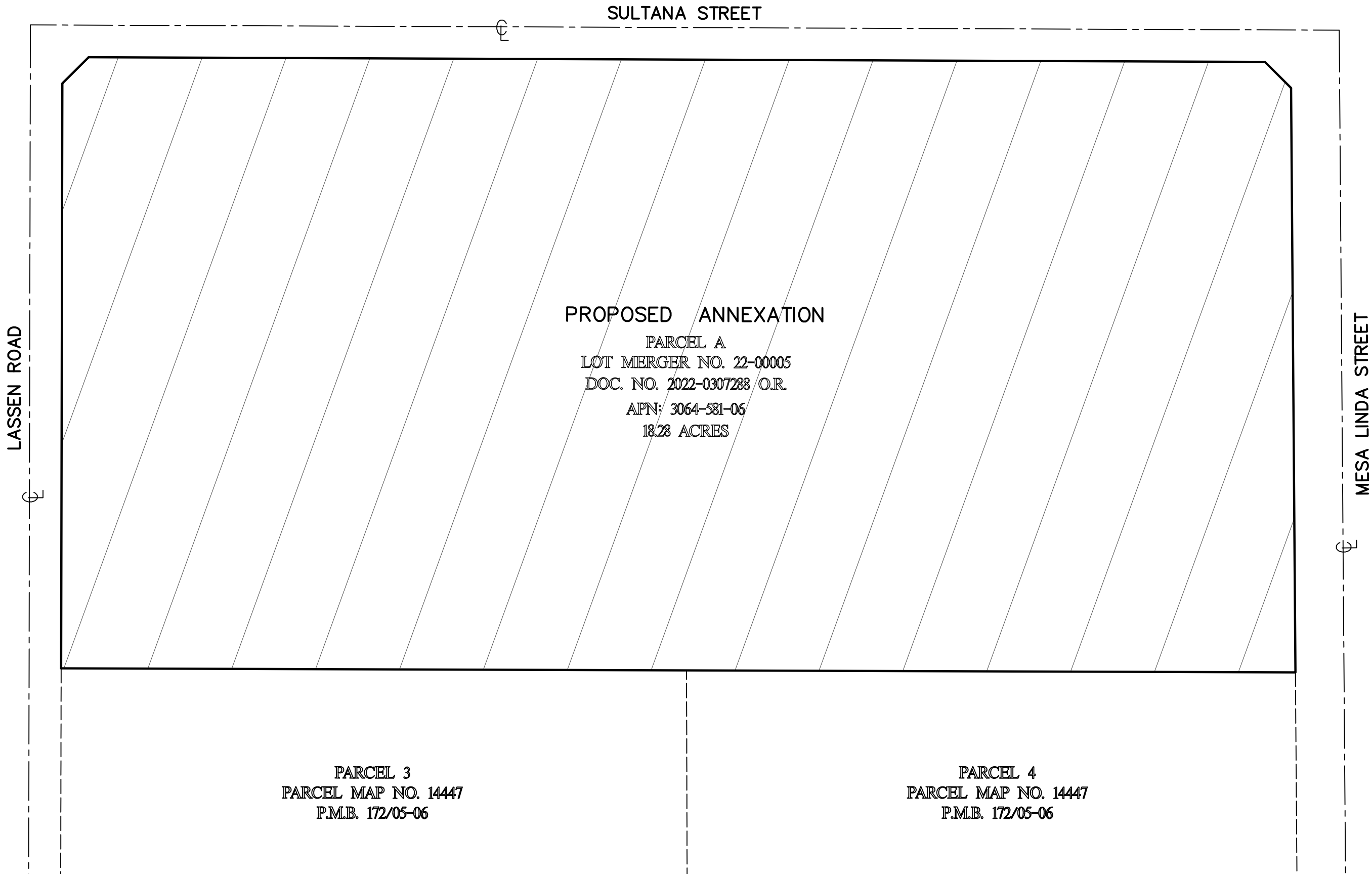
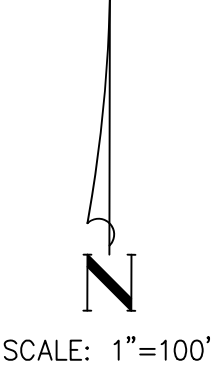

PARCELS 1 AND 2 OF PARCEL MAP NO. 14447, AS SHOWN BY PARCEL MAP ON FILE IN BOOK 172 OF PARCEL MAPS, AT PAGES 5 AND 6, INCLUSIVE THEREOF, RECORDS OF SAID COUNTY, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID PARCEL 1; THENCE SOUTH 89°48'44" EAST ALONG THE SOUTHERLY LINE OF SAID PARCEL 1 AND PARCEL 2, A DISTANCE OF 1270.68 FEET TO THE SOUTHEAST CORNER OF SAID PARCEL 2; THENCE NORTH 00°25'33" WEST ALONG THE EASTERLY LINE OF SAID PARCEL 2, A DISTANCE OF 601.42 FEET TO AN ANGLE POINT THEREIN; THENCE NORTH 45°05'50" WEST A DISTANCE OF 37.96 FEET TO THE NORTHERLY LINE OF SAID PARCEL 2; THENCE NORTH 89°46'07" WEST ALONG SAID NORTHERLY LINE AND THE NORTHERLY LINE OF SAID PARCEL 1, A DISTANCE OF 1211.00 FEET TO A NORTHWEST CORNER OF SAID PARCEL 1; THENCE SOUTH 45°10'24" WEST A DISTANCE OF 38.22 FEET TO THE WESTERLY LINE OF SAID PARCEL 1; THENCE SOUTH 00°06'55" WEST ALONG SAID WESTERLY LINE, A DISTANCE OF 601.99 FEET TO THE POINT OF BEGINNING.
