## MODIFICATION TO CONTRACT

This modification consists of 2 pages.

### 1. RECITALS

- A. The South Coast Air Quality Management District (hereinafter "SCAQMD") and San Bernardino County (Peter Rogers) (hereinafter "CONTRACTOR") have previously executed a Contract No. C25052 for Board Member Consultant services.
- B. The SCAQMD Administrative Committee at their December 13, 2024 meeting approved adjustments to compensation for Board Member Assistants and Board Member Consultants. As a result, adjustments need to be made to compensation for Board Member Assistants/Consultants. Therefore, a modification to this Contract is necessary to increase the maximum amount payable.

### 2. MODIFICATION

The parties therefore agree to modify the existing Contract, as follows:

- A. The amount payable for performance under this modification is increased by Eight Thousand Five Hundred Seventy Dollars and Seven Cents (\$8,570.07). The total amount payable by SCAQMD shall not exceed Nineteen Thousand Nine Hundred Eighty-Six Dollars and Eleven Cents (\$19,986.11), inclusive of the original award as shown in the table below:

- B. Contract Clause 7.A. - PAYMENT is hereby modified to include the following:

CONTRACTOR rate of pay shall be Nine Hundred Forty-One Dollars and Sixty-Seven Cents (\$941.67) per month from July 1, 2024 through November 30, 2024; Two Thousand One Hundred Forty-Five Dollars and Ninety-Two Cents (\$2,145.92) per month for the period of December 1, 2024 through February 28, 2025 and Two Thousand Two Hundred Ten Dollars (\$2,210) per month for the period of March 1, 2025 through June 30, 2025, and shall not exceed Nineteen Thousand Nine Hundred Eighty-Six Dollars and Eleven Cents (\$19,986.11). Said pay rate shall be payable monthly, commencing the first applicable pay period following the commencement of this Contract, if the BOARD MEMBER-approved monthly invoice is received by Finance by the submittal deadline.

- C. All other provisions of the above-referenced Contract shall remain in full force and effect.


