IT IS HEREBY AGREED AS FOLLOWS:

Effective January 25, 2025, San Bernardino County ("County") and Christina Garcia ("Contractor") agree that Contract No. 21-920 is hereby amended as follows:

REPLACE SECTION V. GENERAL PROVISIONS RELATING TO CONTRACTOR, Subsection A., TOUR OF DUTY with the following:

A. TOUR OF DUTY

CONTRACTOR's standard tour of duty (regularly scheduled work week) shall be established by the Third District Supervisor of San Bernardino County, or designee. CONTRACTOR shall be required to work during such hours as necessary to carry out the duties of his/her position, as designated by the Third District Supervisor, and such hours may be varied so long as the work requirements and efficient operations of the County are assured. For each payroll year, the average number of hours worked per pay period from January 25, 2025, through January 24, 2027, is anticipated to be 60 hours. Effective January 25, 2027, for each payroll year, the average number of hours worked per pay period is anticipated to be 50 hours. However, the Third District Supervisor of San Bernardino County, or designee, may modify or change the number of hours in a standard day, tour of duty or shift to meet the needs of the service.

All other terms and conditions of this Contract No. 21-920, including Amendment No. 1, remain unchanged and are incorporated herein by this reference.

This Amendment No. 2 to Contract 21-920 may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment No. 2. The parties shall be entitled to sign and transmit an electronic signature of this Amendment No. 2 (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 2 upon request.
