IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 4:

It is hereby agreed to amend Contract No. 19-99, effective March 12, 2024, as follows:

SECTION III. TERM is amended to read as follows:

This Contract shall be effective March 16, 2019, and is extended from its expiration date of March 15, 2024, to expire on March 15, 2025, subject to the termination provisions below. The Assistant Executive Officer is authorized to execute amendments to the Contract to extend the term. Notwithstanding the foregoing, either party may terminate this Contract at any time, without cause, with a fourteen (14) day prior written notice to the other party. This Contract may be terminated for just cause immediately by the County. Contractor shall serve at the pleasure of the appointing authority, who shall have the full authority and discretion to exercise County rights under this paragraph.

SECTION IV. COMPENSATION OF CONTRACTOR

A. Salary Rate is amended to read as follows:

Contractor shall be compensated for services at a rate of \$17.00 per hour, not to exceed fifty (50) hours per pay period unless expressly authorized. Contractor does not gain probationary or regular status during the term of this Contract. Payment for services shall be made bi-weekly during the term specified in Section III of this Contract.

The Director of Aging and Adult Services Department shall have discretion in initiating salary increases to ensure compliance with state minimum wage standards.

All other terms and conditions of Contract No. 19-99 remain in full force and effect.

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.
