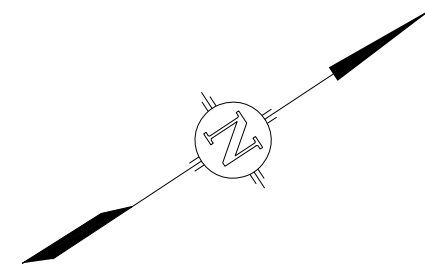

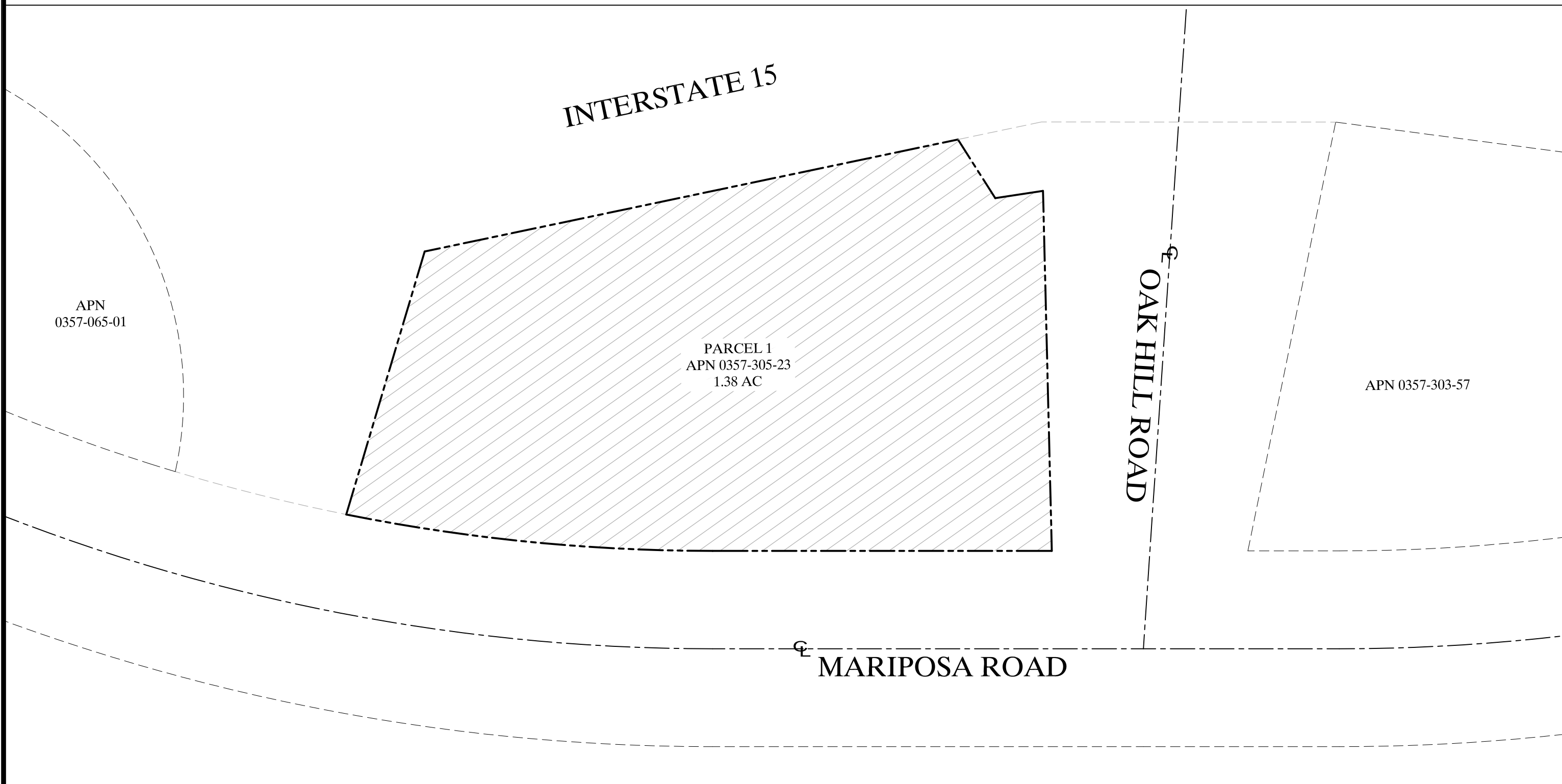
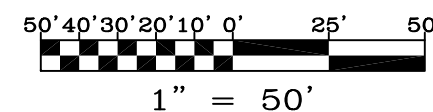

THOSE PORTIONS OF THE WEST ONE-HALF OF SECTION 8 AND THE SOUTHEAST ONE-QUARTER OF SECTION 7, TOWNSHIP 3 NORTH, RANGE 5 WEST, SAN BERNARDINO MERIDIAN, IN THE CITY OF HESPERIA, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACCORDING TO THE OFFICIAL PLAT THEREOF, AS SHOWN ON CALTRANS RIGHT OF WAY MAP NO. 408091, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEASTERLY TERMINUS OF THAT CERTAIN COURSE RECITED AS "NORTH 39°59'16" WEST 119.86 FEET" IN DEED TO THE STATE OF CALIFORNIA RECORDED MAY 26, 1965 IN BOOK 6398, PAGE 379, OF OFFICIAL RECORDS, IN THE OFFICE OF THE RECORDER OF SAID COUNTY; THENCE NORTH 39°59'16" WEST, ALONG SAID COURSE AND ITS NORTHWESTERLY PROLONGATION, 140.19 FEET TO THE SOUTHWESTERLY PROLONGATION OF THAT CERTAIN COURSE DESIGNATED "COURSE 1" OF PARCEL "B" IN SAID DEED; THENCE NORTH 21°32'40" EAST, ALONG SAID "COURSE 1" AND ITS PROLONGATION, 278.27 FEET TO THE SOUTH LINE OF THE NORTHWEST ONE-QUARTER OF SAID SECTION 8; THENCE SOUTH 88°58'37" EAST, ALONG SAID SOUTH LINE, 35.50 FEET TO THE SOUTHEASTERLY LINE OF THE SUPERCEDED STATE HIGHWAY RELINQUISHED TO THE COUNTY OF SAN BERNARDINO BY INSTRUMENT RECORDED MAY 23, 1965 IN BOOK 3946, PAGE 16, OF OFFICIAL RECORDS OF SAID COUNTY; THENCE NORTH 24°42'30" EAST, ALONG SAID SOUTHEASTERLY LINE, 24.69 FEET TO THE SOUTHWESTERLY LINE OF OAK HILL OVERCROSSING AS SHOWN ON CALTRANS RIGHT OF WAY MAP NO. 408091; THENCE SOUTH 57°59'39" EAST, ALONG SAID SOUTHEASTERLY LINE, 183.96 FEET TO THE NORTHWESTERLY LINE OF MARIPOSA ROAD, 100.00 FEET WIDE, AS SHOWN ON SAID RIGHT OF WAY MAP; THENCE SOUTH 33°24'30" WEST, ALONG SAID NORTHWESTERLY LINE, 173.24 FEET TO THE BEGINNING OF A TANGENT CURVE CONCAVE NORTHWESTERLY WITH A RADIUS OF 950.00 FEET; THENCE SOUTHWESTERLY, ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 11°21'23", A DISTANCE OF 188.30 FEET TO THE **POINT OF BEGINNING**.
