AMENDMENT NO. 2:

If is hereby agreed to amend Contract No. 12-778, effective September 12, 2023, as follows:

ENTIRE MEMORANDUM OF UNDERSTANDING

All references to "Loma Linda University Medical Center" and "LLUMC" in the Memorandum of Understanding (MOU) are amended to read "Loma Linda University Children's Hospital" and "LLUCH," respectively. All references to "County of San Bernardino" in the MOU are amended to read "San Bernardino County."

SECTION VI. SPECIFIC PARTNER AGENCY RESPONSIBILITIES

Amend Paragraph F to read as follows:

- F. Loma Linda University Children's Hospital: Will provide management, medical, and forensic support to meet the medical needs of children that are suspected victims of abuse including technical support for digital imaging management for photographic evidence obtained at the CAC. Loma Linda University Children's Hospital will partner with CFS to provide forensic interviews and will partner with DBH to provide mental health services.

SECTION XIII. CONCLUSION

Amend Paragraph B to read as follows:

- B. This MOU may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same MOU. The parties shall be entitled to sign and transmit an electronic signature of this MOU (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed MOU upon request.

IN WITNESS WHEREOF, the Board of Supervisors of the County of San Bernardino has caused this MOU to be subscribed to by the Clerk there of, and each Partner Agency has caused this MOU to be subscribed in its behalf by its authorized officers, the day, month and year written.
