ORDINANCE NO.

An ordinance of San Bernardino County, State of California, to amend Sections 13.0613, ~~and 13.0614, 13.0617c, 13.0617f, 13.0628, 13.0629 and 13.0660~~ of the San Bernardino County Code, relating to compensation and working terms and conditions for the Exempt Group, Elected Officials, Student Interns, Student Nurses, Extra-Help Employment, Recurrent Employment and Public Service Employees ~~and elected official compensation.~~

The Board of Supervisors of the County of San Bernardino, ~~County,~~ State of California, ordains as follows:

SECTION 1. Section 13.0613 of the San Bernardino County Code is amended, to read ~~in its entirety as follows:~~

13.0613 Salaries and Working Conditions of the Exempt Group.

(a) Exempt Group. The Exempt Group consists of employees who formulate and administer significant executive policy, employee relations responsibilities, and/or County confidential proprietary information. Positions are placed in the Exempt Group only by specific approval of the Board of Supervisors.

(b) Definitions. The following definitions apply to the terms used in Section 13.0613 unless another definition is specified.

(1) APPOINTING AUTHORITY refers to the department head of the employee's department as specified in Section 10 of Article II of the County Charter and County Code section 12.2400. It also includes any person who is designated as acting department head, employees acting for the department head during the absence of the department head, and/or employees delegated all authority to act on behalf of the appointing authority on a regular basis.

(2) BASE RATE OF PAY or BASE HOURLY RATE means the employee's base hourly wage, excluding differentials and other pay above the base hourly wage.

1 (3) BASE BIWEEKLY SALARY or BIWEEKLY BASE SALARY means
2 an employee's base hourly rate, excluding any differentials or other pay above the base
3 hourly rate, multiplied by the base hours paid (e.g., REG, SCK, VAC, etc.) each pay
4 period. Base hours paid does not include time without pay or disability payments such
5 as short-term disability or workers' compensation.

6 (4) CALENDAR YEAR refers to pay period 1 through 26, or 27 when
7 applicable, of the same year.

8 (5) COUNTY SERVICE or CONTINUOUS SERVICE refers to the total
9 length of service from an employee's most recent beginning (hire) date in a regular
10 position with no separation from County employment.

11 (6) COUNTY-WIDE ELECTED OFFICIAL refers to a County officer
12 who is elected to a County-wide office pursuant to the law. County-wide elected
13 officials consist of the Assessor/Recorder; Auditor-Controller/Treasurer/Tax Collector;
14 Sheriff/Coroner/Public Administrator; and the District Attorney.

15 (7) DATE OF HIRE or HIRE DATE refers to the effective date of the
16 most recent date of hire in a regular position.

17 (8) DIRECTOR OF HUMAN RESOURCES refers to the incumbent in
18 the Director of Human Resources position. It also includes any person who has been
19 designated as acting Director of Human Resources, employees acting for the Director
20 during the absence of the Director of Human Resources, and/or employees delegated
21 authority approval on a regular basis by the Director of Human Resources.

22 (9) FISCAL YEAR ordinarily refers to pay period 15 of one year
23 through pay period 14 of the following year.

24 (10) PAID HOURS means hours actually worked or the use of accrued
25 leave time such as vacation, sick, holiday, or compensatory time. It does not include
26 unpaid hours or disability payments (excluding Labor Code section 4850 time) such as
27 short-term disability or workers' compensation.

28 (11) PAID STATUS refers to any pay period in which an employee

1 codes paid hours.

2 (12) REGULAR POSITION refers to a position authorized by the Board
3 of Supervisors that may be budgeted at either a full-time or part-time level, and that may
4 be in either the classified or unclassified service. It does not include recurrent, extra-
5 help, ordinance, contract and other contingent positions.

6 (13) REGULAR STATUS refers to the completion of a required
7 probationary and/or trainee period in a regular classified position in the employee's
8 current or prior position, as applicable.

9 (14) SERVICE HOURS refers to paid hours from an employee's most
10 recent date of hire in a regular position and during an employee's regular tour of duty,
11 up to 80 hours per pay period. Time without pay, disability payments (excluding Labor
12 Code section 4850 time), medical emergency leave and overtime hours do not count as
13 service hours.

14 (c) Salary Schedules, Wage Increases, Classifications, and Salary Rates, and
15 Step Advancements.

16 (1) Salary Schedules. The salary schedules for Exempt Group and all
17 non-represented employees are as on file with the Clerk of the Board of Supervisors.

18 ~~Effective July 18, 2020, the County shall add a new top step at~~
19 ~~approximately two and one-half percent (2.5%) above the then current top step for all~~
20 ~~salary ranges, except the no POST range, of Deputy Director Sheriff's Coroner Division,~~
21 ~~Sheriff's Captain, Sheriff's Deputy Chief, Assistant Sheriff, Undersheriff, District Attorney~~
22 ~~Chief Investigator, and District Attorney Assistant Chief Investigator. Employees~~
23 ~~assigned to these classifications who are at the top step of the applicable range shall be~~
24 ~~advanced one step effective July 18, 2020. The initial granting of this top step is subject~~
25 ~~to the discretion of the Chief Executive Officer based on the availability of financial~~
26 ~~resources.~~

27 (2) Wage Increases. The following wage increases shall be included in
28 the salary schedules for Exempt Group employees and all non-represented employees,

1 as are on file with the Clerk of the Board of Supervisors:

2 ~~Effective July 18, 2020, the County shall provide all classifications in the~~
3 ~~Exempt Group with a three percent across the board salary increase.*~~

4 ~~*The initial granting or restoration, in whole or in part, of this across the~~
5 ~~board salary increase is subject to the discretion of the Chief Executive Officer based on~~
6 ~~the availability of financial resources.~~

7 Effective July 31, 2021, the County shall provide all classifications in the
8 Exempt Group with a three percent across the board salary increase, subject to the
9 following:

10 If assessed values are less than a two percent increase in the 2019/2020
11 fiscal year from the 2018/2019 fiscal year and/or if the state or federal governments
12 change funding allocations or reduce funding for the In-Home Support Services
13 program (e.g., the Maintenance of Effort inflation factor is increased above four percent,
14 etc.) then the County may, upon approval of the Board of Supervisors, defer this three
15 percent increase no later than January 1, 2022.

16 Effective July 30, 2022, the County shall provide all classifications in the
17 Exempt Group with a ~~four~~ three percent across the board salary increase, subject to the
18 following:

19 If assessed values are less than a two percent increase in the 2020/2021
20 fiscal year from the 2019/2020 fiscal year and/or if the state or federal governments
21 change funding allocations or reduce funding for the In-Home Support Services
22 program (e.g., the Maintenance of Effort inflation factor is increased above four percent,
23 etc.) then the County may, upon approval of the Board of Supervisors, defer this ~~three~~
24 four percent increase no later than January 1, 2023.

25 ~~Effective February 25, 2023, the County shall provide all classifications in~~
26 ~~the Exempt Group with a three percent across the board salary increase, subject to the~~
27 ~~following:~~

28 ~~If the County's Discretionary "Property Related Revenue", as defined in~~

1 the “Discretionary General Funding and Restricted Funds” section of the County’s
2 Budget Book, are less than a two percent (2.00%) increase in 2021-22 compared to
3 2020-21 and/or if statewide Proposition 172 Sales Tax Collections from Fiscal Year
4 2021-22, representing collections from September 2021 through August 2022, are less
5 than a one percent (1%) increase, then the County may, upon approval of the Board of
6 Supervisors, defer this three percent increase until August 26, 2023.

7
8 Effective February 24, 2024, the County shall provide all classifications in
9 the Exempt Group with a three percent across the board salary increase, subject to the
10 following:

11 If the County’s Discretionary “Property Related Revenue”, as defined in
12 the “Discretionary General Funding and Restricted Funds” section of the County’s
13 Budget Book, are less than a two percent (2.00%) increase in 2022-23 compared to
14 2021-22 and/or if statewide Proposition 172 Sales Tax Collections from Fiscal Year
15 2022-23, representing collections from September 2022 through August 2023, are less
16 than a one percent (1%) increase, then the County may, upon approval of the Board of
17 Supervisors, defer this three percent increase until August 24, 2024.

18 Effective February 22, 2025, the County shall provide all classifications in
19 the Exempt Group with a three percent across the board salary increase, subject to the
20 following:

21 If the County’s Discretionary “Property Related Revenue”, as defined in
22 the “Discretionary General Funding and Restricted Funds” section of the County’s
23 Budget Book, are less than a two percent (2.00%) increase in 2023-24 compared to
24 2022-23 and/or if statewide Proposition 172 Sales Tax Collections from Fiscal Year
25 2023-24, representing collections from September 2023 through August 2024, are less
26 than a one percent (1%) increase, then the County may, upon approval of the Board of
27 Supervisors, defer this three percent increase until August 23, 2025.

28 (3) List of Exempt Group Classifications.

(D) Notwithstanding the salary as established by this chapter, the Board of Supervisors may establish salary, benefits, and other terms and conditions of employment by contract for the classifications listed in this section.

(4) Salary Rates and Step Advancements.

(A) Eligibility for Step Advancement. ~~New~~eEemployees shall be hired at Step 1 of the established base salary range, except as otherwise provided in this subdivision. Variable entrance steps may be established if justified by recruitment needs through Step 7 with the approval of the appointing authority and through the top step with the approval of the Director of Human Resources.

1 Within the base salary range, all step advancements will be made
2 at the beginning of the pay period in which the employee completes the required
3 number of service hours. However, when an employee reaches the required number of
4 service hours with 80 hours in each pay period, the step advancement will be made at
5 the beginning of the next pay period. Approval for advancement shall be based upon
6 completion of the required length of service hours in the classification, satisfactory work
7 performance, and appointing authority recommendation.

8 Completed service hours shall be defined as regularly scheduled
9 hours in a paid status, up to 80 hours per pay period. Overtime hours, disability
10 payments, medical emergency leave, and time without pay shall not count toward step
11 advancements. Unless otherwise approved by the Board of Supervisors, step
12 advancements within a base salary range shall be based upon a one-step increment,
13 approximately two and one-half percent. The employee shall be eligible for step
14 advancements after completion of increments of 1,040 hours until the top step of the
15 range is reached.

16 An appointing authority may request, in limited exceptional
17 circumstances and with adequate justification, the adjustment of the salary step or
18 salary rate of an employee to maintain salary equity within the system, to prevent undue
19 hardship or unfairness due to the application of any rule or policy, or to correct any
20 salary inequity, subject to the recommendation of the Director of Human Resources and
21 the final approval of the Chief Executive Officer or his/her designee. The Director of
22 Human Resources may authorize the adjustment of the salary step or salary rate of an
23 employee to correct any payroll error or omission, including any such action which may
24 have arisen in any prior fiscal year.

25 (B) Implementation of Classification Study Results.

26 (I) Upgrading. An upgrading is the reclassification of a
27 position from one classification to another classification having a higher base salary
28 range. Whenever an incumbent employee is upgraded as a result of such

1 reclassification, pursuant to the Personnel Rules, such employee's step placement in
2 the new salary range shall be governed by the subdivision on "Promotions."

3 (II) Downgrading. A downgrading is the reclassification
4 of a position from one classification to another classification having a lower base salary
5 range. When a position is downgraded, the incumbent employee may continue at the
6 same salary rate where the salary rate is within the new base salary range. Where an
7 incumbent receives a salary rate greater than the maximum of the new base salary
8 range, the Director of Human Resources may authorize continuation of the same salary
9 rate to the incumbent employee that the employee received prior to the downgrading of
10 the position by placing the employee on an "X" step, provided that the employee shall
11 receive no future salary rate increases until the salary range maximum of the new
12 classification exceeds the "X" step.

13 (C) Salary Rate Adjustment. A salary rate (equity) adjustment is
14 a change in the salary range assignment of an existing classification as a result of a
15 compensation study. Step placement for incumbent employees whose classification is
16 assigned to a higher base salary range shall be determined as follows, unless this
17 process is waived by the Chief Executive Officer:

18 (I) If the employee's original base rate of pay is less than
19 Step 1 of the newly designated pay range, the employee shall be placed on Step 1 of
20 the new range. The employee shall be eligible to advance to the next step upon
21 receiving a satisfactory rating on the employee's next annual performance evaluation, in
22 accordance with the requirements of Subsection 13.0613(c)(4)(A). Subsequent step
23 advances shall be administered in accordance with Subsection 13.0613(c)(4)(A).

24 (II) If the employee's original base rate of pay falls within
25 the newly designated pay range, and the salary adjustment granted is at least two
26 salary ranges, the employee shall be placed upon the step in the new range that is
27 approximately a five percent salary increase, not to exceed the maximum step of the
28 new range. If the employee's original base rate of pay falls within the newly designated

1 pay range, and the salary adjustment granted is less than two salary ranges, the
2 employee shall be placed upon the step in the new range that is approximately a two
3 and one-half percent salary increase, not to exceed the maximum step of the new
4 range. The employee shall be eligible to advance to the next step upon receiving a
5 satisfactory rating on the employee's next annual performance evaluation, in
6 accordance with the requirements of Subsection 13.0613(c)(4)(A). Subsequent step
7 advances shall be administered in accordance with Subsection 13.0613(c)(4)(A).

8 (D) Demotion. A demotion is the appointment of an employee
9 from an incumbent position to a position in a different classification for which the
10 maximum rate of pay is lower. An employee demoted for disciplinary reasons shall be
11 placed on the step within the base salary range of the class to which the employee
12 demoted as provided in the order of demotion.

13 An employee demoted for non-disciplinary reasons shall be
14 retained at the same salary rate, provided the salary rate does not exceed the top step
15 of the applicable range, with the approval of the appointing authority and the Director of
16 Human Resources.

17 An employee who demotes to a trainee classification for which the
18 journey level classification is higher than the classification he/she demoted from, shall
19 retain the same salary rate. Such an employee will be placed on the "X" step if
20 necessary, and the employee shall receive no future salary rate increases until the
21 employee has promoted to the journey level classification and the salary rate of that
22 classification exceeds the "X" step.

23 An employee who demotes to a trainee classification for which the
24 journey level classification is lower than the classification he/she demoted from shall
25 retain the same salary rate, provided that the salary rate does not exceed the top step
26 of the journey level classification. If the salary rate is higher than the top step of the
27 journey level classification, the employee shall be placed at the top step of the base
28 salary range of the lower journey level classification.

1 (E) Promotion. A promotion is the appointment of an employee
2 from one classification to a classification having a higher base salary range. A
3 promoted employee shall receive at least the entrance rate of the new range or a two-
4 step or five percent salary increase, (i.e., mathematically closest to five percent)
5 whichever is greater, provided that no employee is thereby advanced in step nor
6 advanced above the top step of the higher base salary range. At the discretion of the
7 appointing authority and with the approval of the Director of Human Resources, an
8 employee may be placed at any step within the higher base salary range. Promotions
9 shall be effective only at the beginning of a pay period unless the Director of Human
10 Resources approves an exception.

11 (d) Job Sharing and Part-time Employment. The County will make
12 reasonable accommodation for employees who desire to share their positions with other
13 qualified employees or eligible persons or to work on a part-time basis. Jobs may be
14 shared on an hourly or daily basis. All benefits for job sharing and part-time employees
15 shall be pro-rated on regularly scheduled hours except as may otherwise be provided.
16 Benefits not subject to proration include the following leaves: blood donation,
17 examination time, and bereavement. Further, where a specific benefit provides a
18 minimum hour requirement (e.g., must be full-time, or scheduled hours) job sharing and
19 part-time employees shall be required to meet the minimum hour requirement in order
20 to receive the benefit.

21 (e) Hours of Work.

22 (1) Employees shall be required to work during such hours as
23 necessary to carry out the duties of their position as designated by the appointing
24 authority, and such hours may be varied so long as the work requirements and efficient
25 operations of the County are assured.

26 (2) The nature of Fair Labor Standards Act (FLSA) exempt
27 employment for certain affected Exempt Group classifications is such that intermittent,
28 occasional overtime is needed to fulfill the responsibilities and requirements of the

1 position. Usually, additional time and effort are proportionate to the importance and
2 level of the responsible position. These factors of time and effort are incorporated when
3 the compensation level of FLSA-exempt positions is established. In those instances in
4 which a position's work extends well beyond the normal hours of employment, the Chief
5 Executive Officer may authorize additional compensation in the form of cash payment or
6 compensating time off, generally on a pre-approved and prescheduled basis.
7 Circumstances for such compensation would include implementation of the intent of a
8 Board of Supervisors approved program or emergency response.

9 (3) For FLSA-covered employees in the Exempt Group classifications,
10 overtime is determined by the legal requirements of the FLSA. For FLSA-covered
11 employees, the following overtime provisions apply.

12 (A) Definition. OVERTIME shall be defined as all hours actually
13 worked in excess of 40 hours a work period. For purposes of defining overtime, paid
14 leave time, excluding sick leave as provided in Subsection 13.0613(e)(3)(B), shall be
15 considered as time actually worked. Overtime shall be reported in increments of full 15
16 minutes and is non-accumulative and non-payable when incurred in units of less than
17 15 minutes. Overtime shall not affect leave accruals.

18 (B) Sick leave that is not pre-approved and sick leave used by
19 employees on leave restriction shall not be considered as time actually worked for the
20 purpose of calculating overtime. PRE-APPROVED shall mean notice to management
21 at least 48 hours prior to the beginning of the leave.

22 (C) Overtime Compensation. Any employee authorized by the
23 appointing authority or authorized representative to work overtime shall be
24 compensated at premium rates, i.e., one and one-half times the employee's regular rate
25 of pay. Payment for overtime compensation shall be made on the first payday following
26 the pay period in which such overtime is worked, unless overtime compensation cannot
27 be computed until some later date, in which case, overtime compensation will be paid
28 on the next regular payday after such computation can be made.

1 In lieu of cash payment, upon request of the employee and
2 approval of the appointing authority, an employee may accrue compensating time off at
3 premium hours. Cash payment at the employee's base rate of pay shall automatically
4 be paid for any compensating time which exceeds 80 hours, for any such time which
5 has not been taken within 26 pay periods after being accrued, or for any hours on
6 record immediately prior to promotion, demotion or termination of employment.

7 (D) Variable Work Schedule. An appointing authority, with
8 agreement of an affected employee, may arrange for that individual to take such time off
9 as necessary to ensure that an employee's actual time worked does not exceed 40
10 hours within a given work period.

11 (E) Work Period. The work period for purposes of overtime
12 commences at 12:01 a.m. Saturday and ends at 12:00 midnight the following Friday of
13 each week. The pay period and workweek may be adjusted in accordance with FLSA
14 requirements.

15 (f) Insurance Programs.

16 (1) Medical and Dental Coverage Insurance.

17 (A) All eligible employees scheduled to work 40 hours or more
18 per pay period in a regular position must enroll in a medical and dental plan offered by
19 the County. Employees who fail to elect medical and dental plan coverage will be
20 automatically enrolled in the medical and dental plan with the lowest biweekly premium
21 rates available in the geographical location of the employee's primary residence.
22 Medical and dental plan coverage will become effective on the first day of the pay
23 period following the first pay period in which the employee is scheduled to work 40
24 hours or more and ~~is be in paid status, received pay for at least one-half plus one hour of~~
25 ~~scheduled hours.~~

26 (B) To continue enrollment in County-sponsored medical and
27 dental plan coverage, an employee must remain in a regular position scheduled to work
28 for a minimum of 40 hours per pay period and ~~be in paid status, have received pay for at~~

1 ~~least one half plus one hour of scheduled hours~~ or be on an approved leave for which
2 continuation of medical and dental coverage is expressly provided under this
3 subdivision, or be eligible for and have timely paid the premium for COBRA continuation
4 coverage.

5 (C) Eligible employees may elect to enroll their dependents upon
6 initial eligibility for medical and dental insurance. Thereafter, newly eligible dependents
7 may be enrolled within 60 days of obtaining dependent status, such as birth, adoption,
8 marriage, or registration of domestic partnership.

9 (D) Notification of a mid-year qualifying event must be submitted
10 to Human Resources in accordance with procedures adopted by Human Resources.
11 Employees are responsible for notifying the County within 60 days of dependent's
12 change in eligibility for the County plans.

13 (E) Dependent(s) must be removed mid-plan year when a
14 dependent(s) becomes ineligible for coverage under the insurance plan eligibility rules,
15 for example, divorce, over-age dependent, or termination of domestic partnership.

16 (F) Enrollment elections must remain in effect for the remainder
17 of the plan year unless an employee experiences an IRS qualifying event.

18 (G) Premiums for coverage will be automatically deducted from
19 the employee's pay warrant. Failure to pay premiums will result in loss of coverage for
20 the employee and/or the dependents. If the employee does not have sufficient earnings
21 to cover the deduction for premiums, the employee must make alternative payment
22 arrangements that are acceptable to Human Resources.

23 (H) Employees eligible for medical plan coverage who are also
24 enrolled in a comparable group medical plan sponsored by another employer or are
25 covered by a spouse, domestic partner, or parent who is also employed with the County
26 may elect to discontinue enrollment in County-sponsored medical plan (opt-out or
27 waive).

28 (I) Employees who, prior to July 9, 2005, elected to opt-

1 out of County-sponsored medical plan coverage and continue to opt-out will receive the
2 following biweekly amount: Employees scheduled for 61 to 80 hours per pay period
3 shall receive \$161.54 per pay period. Employees scheduled for 40 to 60 hours per pay
4 period shall receive \$80.77 per pay period. To receive these amounts, the employee
5 must be in paid status. ~~paid for a minimum of one-half plus one of their scheduled~~
6 ~~hours. For instance, an employee scheduled to work 80 hours must be paid for a~~
7 ~~minimum of 41 hours during a pay period to receive the opt-out or waive amounts.~~

8 (II) Employees scheduled to work 61 to 80 hours who,
9 prior to July 9, 2005, elected to waive medical plan coverage to a spouse, domestic
10 partner, or parent employed by the County and continue to waive will receive \$230.00
11 per pay period; employees scheduled for 40 to 60 hours who continue to waive shall
12 receive \$115.00 per pay period.

13 (III) New opt-outs or waives (i.e., new employees and
14 current employees who opted-out or waived effective July 9, 2005, and any time
15 thereafter) scheduled for 61 to 80 hours per pay period will receive \$40.00 per pay
16 period; new opt-outs or waives scheduled for 40 to 60 hours shall receive \$20.00 per
17 pay period.

18 (I) Employees eligible for County-sponsored dental plan
19 coverage who are also enrolled in a comparable group dental plan sponsored by
20 another employer or are covered by a spouse, domestic partner, or parent who is also
21 employed with the County may elect to discontinue enrollment in their County-
22 sponsored dental plan.

23 (J) The rules and procedures for electing to opt-out of or waive
24 County-sponsored medical and dental plan coverage are established and administered
25 by Human Resources.

26 (I) Employees may elect to opt-out of or waive County
27 medical and/or dental plan coverage(s) within 60 calendar days of the effective date of
28 gaining other employer group coverage. Proof of initial gain of other employer group

1 coverage is required at the time that opt-out or waive is elected.

2 (II) Employees may also elect to opt-out of or waive
3 County medical and/or dental plan coverage during an annual open enrollment period.
4 All employees who are newly opting-out or waiving during an open enrollment period
5 must provide verification of other group coverage.

6 (III) Except as required at the initial opt-out/waive election,
7 employees are not required to provide verification of continued coverage unless
8 requested by the plan administrator.

9 (IV) Employees who voluntarily or involuntarily lose their
10 other employer group medical and/or dental plan coverage must enroll in a County-
11 sponsored medical and/or dental plan within 60 calendar days. Enrollment in the
12 County-sponsored plan will be provided in accordance with the requirements of the
13 applicable plan.

14 (V) There must be no break in the employee's medical
15 and/or dental plan coverage between the termination date of the other employer group
16 coverage and enrollment in a County sponsored medical and/or dental plan. Terms and
17 conditions of the applicable plan will determine the required retroactive enrollment
18 period and premiums required to implement coverage. Failure to notify the County of
19 loss of group coverage within 60 calendar days will require the employee to pay their
20 insurance premiums retroactively on an after-tax basis.

21 (K) For employees assigned to work in the Needles, Trona, and
22 Baker work locations, the County will establish a Needles Subsidy. To be eligible for
23 the Needles Subsidy the employee must be enrolled in a medical plan and receive the
24 MPS. The Needles Subsidy will be paid by the employee's department and will be
25 equal to the amount of the premium difference between the indemnity medical plan
26 offered in these specific work locations and the lowest cost medical plan provided by the
27 County. The applicable subsidy amount shall be paid directly to the provider of the
28 County-sponsored medical plan in which the eligible employee has enrolled. This

1 Needles Subsidy will be established each year when premiums change for the County-
2 sponsored medical plans. The subsidy will be discontinued when the lowest cost
3 medical plan becomes available to the employees.

4 (2) Term Life Insurance.

5 (A) County Paid Life Insurance. The County will pay the
6 premium for a term life policy, the amount of which is based on the eligible employee's
7 scheduled hours. Employees scheduled from 40 to 60 hours per pay period shall
8 receive \$25,000.00 in coverage. An employee scheduled from 61 to 80 hours shall
9 receive \$50,000.00 in coverage. Life insurance will become effective on the first day of
10 the pay period following the employee's first pay period in which the employee is in paid
11 status. For pay periods in which the employee is not in paid status, the employee shall
12 have the option of continuing life insurance coverage at the employee's expense.

13 (B) Voluntary Life Insurance. In accordance with the procedures
14 established by Human Resources, eligible employees may purchase, through payroll
15 deductions, term life insurance subject to carrier requirements. New employees shall
16 become initially eligible to participate in this program on the first day of the pay period
17 following the pay period in which the employee is in paid status. Participation will
18 continue as long as premiums are paid timely. If the employee does not have sufficient
19 earnings to cover the deduction for premiums, the employee must make alternative
20 payment arrangements that are acceptable to Human Resources.

21 (3) Variable Group Universal Life. Eligible employees may purchase,
22 through payroll deductions, variable group universal life insurance subject to carrier
23 requirements and approval. The benefit levels for such insurance shall be equivalent to
24 no more than three times the employee's annual base earnings. Employees who
25 purchase variable group universal life insurance shall be provided a County contribution
26 towards the biweekly premium based on the following schedule:

Benefit Group B	50 percent of the premium of the annual base salary or 100 percent of the premium equal to one-half of the annual base salary

If the employee does not have sufficient earnings to cover the deduction for premiums, the employee must make alternative payment arrangements that are acceptable to Human Resources.

(4) Accidental Death and Dismemberment Insurance. Exempt Group employees may purchase amounts of accidental death and dismemberment insurance coverage for themselves and dependents through payroll deduction. New employees shall become initially eligible to participate in these programs on the first day of the pay period following the first pay period in which the employee is in paid status. ~~works and receives pay for one-half plus one of their regularly scheduled hours.~~ Participation will continue as long as premiums are paid timely. If the employee does not have sufficient earnings to cover the deduction for premiums, the employee must make alternative payment arrangements that are acceptable to Human Resources. The benefits will be provided subject to carrier requirements, and will be administered by Human Resources.

(5) Long-Term Disability Insurance. The County will provide Exempt Group employees with long-term disability insurance subject to carrier requirements and approval. The benefit levels for such insurance shall be those approved by the Director of Human Resources and are subject to carrier requirements. Integration of leave balances (e.g., sick, vacation, etc.), either partially or fully, are ~~not~~ allowed in conjunction with long-term disability benefits.

(6) Short-Term Disability Insurance. The County will provide an employer paid short-term disability insurance plan for Exempt Group employees. This benefit shall apply to Exempt Group employees in regular positions who are regularly scheduled to work 40 hours or more per pay period. The short-term disability insurance

1 plan benefit coverage shall be governed by the plan document that has been approved
2 and adopted by the Board of Supervisors for Exempt Group employees and is subject to
3 carrier requirements and approval. The short-term disability insurance plan benefit
4 coverage shall include a provision for a seven consecutive calendar day waiting period
5 from the first day of disability before benefits begin. Benefits shall be 55 percent of
6 base salary up to a weekly maximum established by a formula that incorporates the
7 State of California for the State Disability Insurance fund maximum. Benefit payments
8 terminate when the employee is no longer disabled or after receiving 180 days of
9 benefits at which time the employee would be eligible for long-term disability benefits if
10 still medically disabled.

11 (7) Vision Care Insurance. Subject to carrier requirements, the County
12 will pay the premiums for vision care insurance for employees who are in paid status
13 and their eligible dependents.

14 (g) Leave Provisions.

15 (1) Sick Leave. Sick leave with pay is an insurance or protection
16 provided by the County to be granted in circumstances of adversity to promote the
17 health of the individual employee. It is not an earned right to time off from work. SICK
18 LEAVE is defined to mean the authorized absence from duty of an employee because
19 of physical or mental illness, injury, pregnancy, confirmed exposure to a serious
20 contagious disease, for a medical, optical, or dental appointment, for certain purposes
21 related to being a victim of domestic violence, sexual assault or stalking, or other
22 purpose authorized herein.

23 (A) Definition.

24 (I) FAMILY MEMBER. A FAMILY MEMBER, as defined
25 by Labor Code section 245.5, is a parent, child, spouse, registered domestic partner,
26 grandparent, grandchild, or sibling. PARENT means a biological, foster, adoptive, or
27 ~~step-parent~~stepparent, a legal guardian, or a person who stood in loco parentis when
28 the employee was a minor child of the employee, or the employee's spouse or

1 registered domestic partner. CHILD means a biological, foster, or adopted child, a
2 stepchild, a legal ward, a child of a domestic partner, or a child to whom the employee
3 stands in loco parentis. DOMESTIC PARTNER is defined by Family Code section 297.

4 (II) EXTENDED FAMILY. EXTENDED FAMILY is
5 defined as, parent/sibling-in-law, aunt, uncle, niece, nephew, or any step relations as
6 defined herein.

7 (B) Accumulation. Employees in regular positions shall accrue
8 sick leave for each payroll period completed, prorated on the basis of 3.69 hours per
9 pay period, except as provided in Subsection 13.0613(g)(14). Earned sick leave shall
10 be available for use the first day following the payroll period in which it is earned.
11 Employees in regular positions paid less than 80 hours per pay period or job-shared
12 positions shall receive sick leave accumulation on a pro rata basis. There shall be no
13 limit on sick leave accumulation.

14 (C) Compensation. Approved sick leave with pay shall be
15 compensated at the employee's base rate of pay. The minimum charge against
16 accumulated sick leave shall be 15 minutes.

17 (D) Administration.

18 (I) Investigation. It shall be the responsibility and duty of
19 each appointing authority to investigate each request for sick leave and to allow sick
20 leave with pay where the application is determined to be proper and fitting, subject to
21 approval of the Director of Human Resources.

22 (II) Notice of Sickness. In 24-hour departments, the
23 appointing authority or designee should be notified at least two hours prior to the start of
24 the employee's scheduled tour of duty of a sickness on the first day of absence and
25 must be notified at least one hour prior to the start of the employee's scheduled tour of
26 duty. In other departments, the appointing authority or designee must be notified within
27 one-half hour after the start of the employee's scheduled tour of duty of a sickness on
28 the first day of absence.

1 It is the responsibility of the employee to keep the appointing
2 authority informed as to continued absence beyond the first day for reasons due to
3 sickness or occupational disability. Failure to make such notification shall result in
4 denial of sick leave with pay. If the employee receives a doctor's off-work order and
5 provides notice of same to the appointing authority, the employee is not required to
6 contact the department daily. If the employee does not have an off-work order or has
7 not notified the appointing authority that one has been issued, the employee shall be
8 required to contact the department daily in accordance with the timeframe above.

9 (III) Review. The Director of Human Resources may
10 review and determine the justification of any request for sick leave with pay and may, in
11 the interest of the County, require information from a doctor to support a claim for sick
12 leave pay.

13 (IV) Proof. A doctor's certificate or other adequate proof
14 shall be provided by the employee in all cases of absence due to illness if requested by
15 the appointing authority. All requests for proof of illness shall be made in compliance
16 with the Labor Code and other law.

17 (V) Improper Use. Evidence substantiating the use of
18 sick leave for willful injury, gross negligence, intemperance, trivial indispositions,
19 instances of misrepresentation, or violation of the rules defined herein will result in
20 denial of sick leave with pay and shall be construed as grounds for disciplinary action up
21 to and including termination.

22 (E) Sick Leave for Other than Personal Illness/Injury.

23 (I) Family Sick Leave. A maximum of one-half of the
24 employee's annual accrual of earned sick leave per calendar year may be used for
25 attendance upon family members who require the attention of the employee. Upon
26 approval of the appointing authority, the employee may use part of this annual
27 allowance for attendance upon members of the employee's extended family residing in
28 the employee's household who require the attention of the employee.

1 (II) Bereavement. A maximum of three days earned sick
2 leave may be used per occurrence for bereavement due to the death of a family
3 member or a member of the employee's extended family, as defined herein, or any
4 relative who resided with the employee.

5 (III) Birth/Adoption. A maximum of 40 hours earned sick
6 leave may be used per occurrence for arrival of an adoptive child at the employee's
7 home. An employee may utilize on an annual basis no more than 40 hours of
8 accumulated sick leave per calendar year for the birth of his or her child.

9 (IV) Medical, Optical or Dental Appointments. The
10 employee may use sick leave for medical, dental or optical appointments; however,
11 every effort should be made to schedule the appointments at a time of day that will
12 minimize the employee's time off work.

13 (F) Return-to-Work Medical Clearance.

14 (I) Under any of the following circumstances, all
15 employees who have been off work due to an illness or injury will report to the San
16 Bernardino County Center for Employee Health and Wellness for a medical evaluation
17 of condition and authorization to return to work before returning to work.

18 (i) Employees whose treating physician or other
19 qualified medical provider has ordered job modification(s) as a condition for either
20 continuing to work or for returning to work after an illness or injury. This applies to both
21 occupational and non-occupational illness or injury.

22 (ii) Employees who have been off work due to
23 communicable diseases such as, but not limited to, chicken pox and measles.

24 (iii) Employees who have been absent on account
25 of serious medical condition, when so directed by appointing authority.

26 (II) Employees are required to attend return-to-work
27 medical appointments at the Center for Employee Health and Wellness on their own
28 time; however, mileage for attending such appointments are eligible for reimbursement

1 pursuant to the expense reimbursement provision, Subsection 13.0613(j).

2 (III) It is the responsibility of the employee to obtain
3 written notice from the medical provider of authorization to return to work with or without
4 job modification. To ensure all necessary and relevant medical information is provided,
5 the County shall make available forms to be completed by the medical provider. It is the
6 responsibility of the employee to provide verbal notice to his or her appointing authority
7 immediately upon receipt of the medical provider's authorization to return to work, and
8 no later than 24 hours after receipt of the notice. The appointing authority or designee
9 will schedule an appropriate medical evaluation for the employee with the Center for
10 Employee Health and Wellness prior to the employee's return to work. The employee
11 shall provide the medical provider's written notice of authorization to return to work to
12 the Center at or prior to the employee's scheduled appointment time.

13 (IV) Exceptions to the above requirements may be made
14 on a case-by- case basis by the Center for Employee Health and Wellness.

15 (V) The employee is obligated to attend the appointment
16 as scheduled under the conditions outlined above. If the employee fails to adhere to the
17 procedure, the employee is required to use sick leave or leave without pay for any work
18 hours missed. If required notice has been provided, and there is a delay between the
19 employee's appointment with the Center and the start of his or her scheduled tour of
20 duty on the day that he or she was released to return to work, the County will pay for
21 work hours missed, without charge to the employee's leave balances.

22 (VI) The final decision on the employee's ability to return
23 to work rests with the medical provider at the Center. In the event the employee is not
24 released to return to work by the medical provider at the Center, the employee's status
25 would continue on sick leave or, where there is no balance, leave without pay.

26 (G) Workers' Compensation. Employees shall receive full salary
27 in lieu of Workers' Compensation benefits and paid sick leave for the first 40 hours
28 following an occupational injury or illness, if authorized off work by order of an accepted

1 physician under the Workers' Compensation sections of the California Labor Code.
2 Thereafter, accumulated paid leave may be prorated to supplement such temporary
3 disability compensation payments, provided that the total amount shall not exceed the
4 regular gross salary of the employee. Employees eligible for salary continuation
5 pursuant to Labor Code section 4850 are not entitled to this paid time.

6 (H) Employees covered by Labor Code section 4850 who are
7 injured in the line of duty are entitled to full salary in lieu of Workers' Compensation
8 benefits and sick leave for a period not to exceed one year. After the employee has
9 used one full year of such "4850 time", said employee may use accumulated sick leave
10 with pay with the approval of the appointing authority to augment temporary disability
11 payments if said employee is still temporarily disabled by order of an accepted
12 physician under the Workers' Compensation sections or until said employee is retired.

13 (I) Separation. Unused sick leave shall not be payable upon
14 separation of the employee, except as provided in the Retirement Medical Trust Fund,
15 Subsection 13.0613(k)(4) and as provided below.

16 Upon the death of an active employee with five or more years of
17 continuous service from the most recent date of hire in a regular position, the estate of
18 the deceased employee will be paid the cash value for the unused sick leave balances
19 according to the sick leave conversion formula below only up to 1,000 hours, and will
20 not go into the Trust.

26 (J) Sick Leave Conversion. While employed by the County,
27 employees who have contributed to a public sector retirement(s) for over five years and
28 have not withdrawn the contribution from the system(s) may exchange accrued sick

1 leave hours in excess of 200 hours for vacation time on the following basis:

Sick Leave Balance at Time of Conversion	Sick Leave to Vacation Leave Conversion Ratio
201 to 599 hours	3 sick hours to 1 hour vacation
600 to 799 hours	2.5 sick hours to 1 hour vacation
800 or more hours	2 sick hours to 1 hour vacation

6 Any such exchange must be made in ten-hour increments of
7 accrued sick leave under the procedures established by the Director of Human
8 Resources. Employees may elect this exchange once per calendar year.

9 (2) Vacation Leave.

10 (A) Definition. VACATION is a right, earned as a condition of
11 employment, to a leave of absence with pay for the recreation and well-being of the
12 employee. If an employee has exhausted sick leave, vacation leave may be used for
13 sick leave purposes upon a special request of the employee and with the approval of
14 the appointing authority.

15 (B) Accumulation. Employees in regular positions scheduled to
16 work 80 hours per pay period shall accrue, on a pro-rata basis, vacation leave for
17 completed pay periods. Such vacation leave shall be available for use on the first day
18 following the pay period in which it is earned, provided an employee has worked six pay
19 periods from the employee's hire date. Employees in regular positions paid less than 80
20 hours per pay period or job shared positions shall receive vacation leave accumulation
21 on a pro-rata basis.

25 The maximum vacation leave accrual balance that may be carried
26 over to a future calendar year shall be 480 hours. However, the maximum vacation
27 leave accrual balance that may be carried over into a future calendar year for an
28 employee with a balance of more than 480 hours at the end of calendar year 2010 shall

1 be such employee's vacation leave balance at the end of pay period 26 of calendar year
2 2010. Thereafter, the maximum vacation accrual balance for those employees with a
3 balance greater than 480 hours at the end of calendar year 2010 shall be adjusted
4 annually at the end of each calendar year, and shall never be increased. Any vacation
5 leave accrual balance in excess of the employee's maximum leave accrual balance at
6 the end of the calendar year shall be cashed out and paid in accordance with
7 Subsection 13.0613(g)(2)(E)(II).

8 (C) Administration.

9 (I) Vacation periods should be taken annually with the
10 approval of the appointing authority at such time as will not impair the work schedule or
11 efficiency of the department but with consideration given to the well-being of the
12 employee.

13 (II) The minimum charge against accumulated vacation
14 leave shall be 15 minutes. Vacation leave shall be compensated at the employee's
15 base rate of pay, except as otherwise provided in this Plan.

16 (III) When a fixed holiday falls within a vacation period,
17 the holiday time shall not be charged against an employee's earned vacation benefits.

18 (IV) Employees not planning to return to County
19 employment at the expiration of a vacation leave, except those retiring, shall be
20 compensated in a lump sum payment for accrued vacation and shall not be carried on
21 the payroll. Retiring employees may elect to use vacation leave to enhance retirement
22 benefits or be compensated in a lump sum payment for accrued vacation leave.

23 (D) Prior Service. New employees hired into the County in
24 regular positions who have been employed by a public jurisdiction or private sector in a
25 comparable position or a position which has prepared such employees for an
26 assignment to a position in the Exempt Group may receive credit for such previous
27 experience in the former agency(s) in determining their vacation accrual rate. Such
28 determination as to the comparability of previous experience and amount of credit to be

1 granted rests solely with the Director of Human Resources or designee. Requests for
2 prior service credit should be made at the time of hire or as soon as possible thereafter
3 but in no event later than one year from the employee's hire date.

4 (E) Conversion of Vacation Leave to Cash.

5 (I) Elective Conversion. An employee may sell back
6 vacation leave at the base hourly rate of the employee as hereinafter provided, upon
7 approval of the appointing authority. Eligible employees may exercise these options
8 under procedures established by the Director of Human Resources. In lieu of cash, the
9 employee may designate that part or all of the value of vacation leave be contributed to
10 the County's 401(k) Defined Contribution Plan or 457(b) Deferred Compensation Plan.
11 In order to sell back vacation leave prior to termination or retirement, an employee may
12 exercise the following options:

13 Option 1. Future Accruals. An employee must make an
14 irrevocable election during the month of December, specifying the number of hours to
15 be sold back from the next calendar year's vacation leave accrual. Such election must
16 be made in increments of not less than ten hours and may not exceed 160 hours. All
17 designated hours remaining at the end of the pay period 25 will automatically be
18 converted into cash in the last period of the calendar year.

19 Option 2. Existing Accruals. Existing accruals may be
20 cashed out in whole hour increments with a minimum cash out of ten hours and will be
21 subject to a ten percent penalty.

22 (II) Automatic Conversion. At the end of the last pay
23 period of the calendar year, an employee shall automatically have any vacation leave
24 accruals in excess of the employee's maximum vacation leave accrual balance
25 converted to cash. Such automatic vacation leave cash out shall be paid in pay period
26 1 of the next calendar year.

27 (3) Holiday Leave.

28 (A) Fixed Holidays. All employees in regular positions except as

1 modified in Subdivision (i) shall be entitled to the following holidays:

2 January 1

3 Third Monday in January

4 Third Monday in February

5 Last Monday in May

6 June 19

7 July 4

8 First Monday in September

9 Second Monday in October

10 November 11

11 Thanksgiving Day

12 Day after Thanksgiving

13 December 24

14 December 25

15 December 31

16 (B) Floating Holidays. Employees in regular positions shall be
17 entitled to a total of eight hours floating holiday time annually provided that the
18 employee is not on unpaid leave for the entire pay period and is in active-paid status
19 ~~on the payroll~~ for the pay period where the floating holiday time is to accrue. Eight
20 hours floating holiday time shall be accrued during the first pay period prior to the third
21 Monday in January.

22 Floating holidays accrued shall be available for use on the first day
23 following the pay period in which they are accrued, with the approval of the appointing
24 authority. Appointing authorities have the right to schedule employees' time off for
25 accrued holidays to meet the needs of the service but with consideration given to the
26 well-being of the employee. Employees in regular positions budgeted less than 80 hours
27 per pay period or job-shared positions shall receive floating holiday accruals on a pro-
28 rata basis.

(C) Maximum Holiday Leave Accrual Balance

(I) The maximum holiday leave accrual balance that may be carried over to a future calendar year shall be 112 hours. However, the maximum holiday leave accrual balance that may be carried over into a future calendar year for an employee with a balance of more than 112 hours at the end of calendar year 2010 shall be such employee's holiday leave balance at the end of pay period 26 of calendar year 2010. Thereafter, the maximum holiday accrual balance for those employees with a balance greater than 112 hours at the end of calendar year 2010 shall be adjusted annually at the end of each calendar year, and shall never be increased.

(II) Effective pay period 1 of calendar year 20223, the maximum holiday leave accrual balance that may be carried over to a future calendar year shall be 120 hours. However, employees with a grandfathered balance of more than 120 hours shall carry over their maximum grandfathered accrual balance in accordance with Subsection 13.0613(g)(3)(C)(I). Any holiday leave accrual balance in excess of the employee's maximum holiday leave accrual balance at the end of the calendar year shall be cashed out and paid in accordance with Subsection 13.0613(g)(3)(G)(II).

(D) When a fixed holiday falls within a vacation period, the holiday time shall not be charged against an employee's earned vacation benefits.

(E) Whenever an employee is required to work on a fixed holiday or the fixed holiday falls on an employee's regularly scheduled day off, the employee shall accrue, on an hour-for-hour basis, up to a total of eight hours floating holiday time.

(F) When a fixed holiday falls on a Saturday, the previous Friday will be observed as the fixed holiday except that when the preceding Friday is also a fixed holiday, the preceding Thursday will be observed as the fixed holiday. When a fixed holiday falls on a Sunday, the following Monday will be observed as the fixed holiday except that when the following Monday is also a fixed holiday, the following

1 Tuesday will be observed as the fixed holiday.

2 (G) Conversion of Holiday Leave to Cash.

3 (I) Elective Conversion. An employee may sell back
4 holiday time at the base hourly rate of the employee as hereinafter provided, upon
5 approval of the appointing authority. Eligible employees may exercise this option under
6 procedures established by the Director of Human Resources. In lieu of cash, the
7 employee may designate that part or all of the value of holiday time to be contributed to
8 the County's 401(k) Defined Contribution Plan or 457(b) Deferred Compensation Plan.

9 In order to sell back holiday time prior to termination or
10 retirement, an employee may exercise the following options:

11 Option 1. Future Accruals. An employee must make an
12 irrevocable election during the month of December, specifying the number of hours to
13 be sold back from the next calendar year's holiday time accrual. Such election must be
14 made in increments of not less than eight hours and may not exceed the annual amount
15 to be accrued for the next calendar year. All designated hours remaining at the end of
16 pay period 25 will automatically be converted into cash in the last pay period of the
17 calendar year.

18 Option 2. Existing Accruals. Existing accruals may be
19 cashed out in whole hour increments with a minimum cash out of eight hours and will be
20 subject to a ten percent penalty.

21 (II) Automatic Conversion. At the end of the calendar
22 year, an employee shall automatically have any holiday leave accruals in excess of the
23 employee's maximum holiday leave accrual balance converted to cash. Such automatic
24 holiday leave cash out shall be paid in pay period 1 of the next calendar year.

25 (H) Grandfathered Holiday Time. An employee promoted from
26 the Safety Management and Supervisory Unit to the Exempt group who has any
27 grandfathered holiday time at the time of promotion, will be allowed to retain such
28 grandfathered holiday time. Such time may be used or compensated at the time of

1 retirement or separation under the same terms and conditions as are applicable to
2 Safety Management and Supervisory Unit employees.

3 (4) Special Leaves of Absence Without Pay.

4 (A) General Provisions. A special leave of absence without pay
5 may be granted to an employee who:

6 (I) Is medically incapacitated to perform the duties of the
7 position;

8 (II) Desires to engage in a relevant course of study which
9 will enhance the employee's value to the County;

10 (III) Takes a leave of absence pursuant to the Federal
11 Family Medical Leave Act (FMLA), the California Family Rights Act (CFRA), and/or
12 Pregnancy Disability Leave (PDL) provisions of the Fair Employment and Housing Act
13 (FEHA);

14 (IV) For any reason considered appropriate by the
15 appointing authority and the Director of Human Resources.

16 (B) Exempt Group employees eligible to receive the automobile
17 allowance, portable communication device allowance, bilingual compensation, or
18 special assignment compensation will have these benefits suspended while on unpaid
19 leave and upon exhausting short-term disability insurance benefits. These benefits will
20 cease the day following the end of the individual's short-term disability insurance
21 benefits. Employees off work without pay for disciplinary reasons shall not receive the
22 above listed benefits until they return to full time status.

23 (C) Type of Leave of Absences. There are four types of leaves
24 of absences. All requests must be in writing and require the approval of the appointing
25 authority or designee and the Director of Human Resources or designee. Upon
26 request, the appointing authority or designee and the Director of Human Resources or
27 designee may grant successive leaves of absence. All benefits shall be administered in
28 accordance with the appropriate section of this code.

1 (I) Leave of Absence with Right to Return. Leaves of
2 absence with right to return may be granted to employees in regular positions for a
3 period not exceeding one year. The employee remains in his or her position.

4 (II) Family Leave. Leaves of absence will be granted in
5 accordance with the FMLA, the CFRA, and/or the PDL provisions of FEHA. This leave
6 can be concurrent with use of paid leave or leave of absence without pay with right to
7 return.

8 An employee on an approved leave of absence without pay
9 under this provision will continue to receive the benefits outlined in Subsection
10 13.0613(k)(1)(B)(III) for a period of six pay periods. Certification from a health care
11 provider is required for all instances of medical leave under this provision. Employees
12 are required to inform supervisors of the need for leave at least 30 days before
13 commencement where possible.

14 In instances where the leave is for the birth or placement of
15 a child and both husband and wife are County employees, both employees are limited
16 to a total of 12 weeks between them.

17 (III) Leave of Absence without Right to Return.

18 (i) Definition. Leaves of absence without right to
19 return may be granted to employees with regular status for a period not exceeding one
20 year. Employees without right to return shall be removed from their position.
21 Retirement contributions shall remain in the system and cannot be requested for
22 distribution until the expiration of the leave. The employee shall be eligible to purchase
23 medical benefits pursuant to federal Consolidated Omnibus Reconciliation Act of 1985
24 (COBRA).

25 (ii) Return Process. An employee may return to
26 the same department in the classification from which the employee took the leave of
27 absence with the approval of the appointing authority and the Director of Human
28 Resources. Alternatively, the employee may apply through Human Resources by the

1 last day of the leave of absence. The employee will be placed on the eligible list for the
2 classification from which he or she took the leave of absence without examination.
3 Placement on the eligible list will be administered in accordance with the requalification
4 provisions of the Personnel Rules. If the employee does not return to a regular position
5 within 90 calendar days of the expiration of such a leave the employee shall be
6 terminated from County service. If reemployed, the employee shall be required to serve
7 a new probationary period. The Director of Human Resources or designee has the
8 discretion to waive the requirement to serve a new probationary period.

9 (iii) Benefits Upon Return. An employee who
10 returns to a regular position within 90 days after the expiration of the leave of absence
11 without right to return shall retain his or her hire date for purposes of leave accruals and
12 step advances; except that the employee will not receive service credit for the period of
13 time the employee is on the leave of absence without right to return. To be reemployed
14 and retain the above benefits, the employee must be appointed to a position no later
15 than 90 calendar days after the date of expiration of the leave of absence. The 90 days
16 shall run concurrently with the first 90 days of the one-year period provided in the
17 reemployment subdivision.

18 (IV) Long-Term Medical Leave of Absence.

19 (i) Definition. An employee with regular status
20 who suffers from a serious condition may be placed on a medical leave of absence for
21 up to one year, only after FMLA, CFRA and/or PDL have been exhausted. However, if
22 an employee meets the service requirements for eligibility for a disability retirement, the
23 long-term medical leave of absence may be extended. The employee is responsible for
24 providing documentation from a qualified health practitioner prior to approval. The
25 County retains the right to request medical documentation regarding the employee's
26 continued incapacity to return to work.

27 The employee will be removed from his or her
28 position so that the department may fill behind the employee. Retirement contributions

1 shall remain in the system and cannot be requested for distribution until the expiration of
2 the leave. The employee shall be eligible to purchase benefits pursuant to the federal
3 Consolidated Omnibus Reconciliation Act of 1985 (COBRA).

4 Upon the employee's ability to return to work or the
5 expiration of the leave of absence, whichever comes first, the employee will have the
6 right to return to the classification within the department from which he or she took a
7 leave of absence when a funded vacancy for which the employee meets the
8 qualifications is available. If the employee does not return to work by the expiration
9 date of the leave, or the soonest date after that for which the department has a vacancy
10 (but in no event later than 90 days following the expiration of the medical leave of
11 absence), the employee relinquishes the right to return.

12 (ii) Upon return from a medical leave of absence,
13 the employee shall retain hire date for purposes of leave accruals and step advances;
14 except that the employee will not receive service credit for the period of time the
15 employee is on the medical leave of absence.

16 (5) Medical Emergency Leave. The particulars of the Medical
17 Emergency Leave policy are as follows:

18 (A) The employee must have regular status with the County or
19 one year of continuous service in a regular position with the County.

20 (B) The employee must meet all of the following criteria before
21 he or she becomes eligible for Medical Emergency Leave donation: (1) be on an
22 approved medical leave of absence for at least 30 calendar days (160 working hours)
23 exclusive of an absence due to a work related injury/illness; (2) submit a doctor's off
24 work order verifying the medical requirement to be off work for a minimum of 30
25 calendar days (160 working hours); (3) have exhausted all useable leave balances prior
26 to initial eligibility for Medical Emergency Leave donations—subsequent accruals will
27 not affect eligibility; and (4) have also recorded at least 40 hours of sick leave without
28 pay during the current period of disability.

1 (C) An employee is not eligible for Medical Emergency Leave if
2 he or she is receiving Workers' Compensation wage replacement (e.g., Coding TTD,
3 etc.). An employee eligible for State Disability Insurance and/or short-term disability
4 must agree to integrate these benefits with Medical Emergency Leave.

5 (D) Vacation, holiday, administrative leave or annual leave, as
6 well as compensatory time, may be donated by employees only on a voluntary and
7 confidential basis, in increments of eight hours (or in the case of holiday leave four
8 hours) not to exceed a total of 50 percent of a donor's annual vacation, holiday,
9 administrative leave, annual leave or compensatory time accrual per employee. The
10 donation may be made for a specific employee on the time frames established by the
11 Human Resources Department. The employee (donee) using/coding the Medical
12 Emergency Leave will be taxed accordingly.

13 (E) The donation is to be utilized for the employee's Medical
14 Emergency Leave only; the donation to one employee is limited to a total of 1,040 hours
15 per fiscal year. The maximum of 1,040 hours shall be prorated for those scheduled less
16 than 40 hours per week. Example: An employee who is regularly scheduled 20 hours
17 per week is eligible for a maximum donation of 520 hours of Medical Emergency Leave.

18 (F) Medical emergency leave shall be administered in
19 accordance with procedures approved by Human Resources.

20 (6) Compulsory Leave. If, in the opinion of the appointing authority,
21 employees are unable to perform the duties of their position for physical or
22 psychological reasons, they may be removed from duty without pay or may use
23 appropriate accrued paid leave for which they are eligible. In addition, such employees
24 may be required to submit to an examination by either a physician or other competent
25 authority designated by the Director of Human Resources or by their own physician or
26 practitioner, as appropriate. If the examination report of the competent authority (e.g.,
27 physician, appropriate practitioner) shows the employee to be in an unfit condition to
28 perform the duties required of the position, the appointing authority shall have the right

1 to compel such employee to take sufficient leave of absence with or without pay, to
2 transfer to another position without reduction in compensation, and/or follow a
3 prescribed treatment regimen until medically qualified to return to unrestricted duty. An
4 employee who has been removed from duty for physical or psychological reasons by
5 the appointing authority, and was required to submit to an examination, may not return
6 to duty until such time as medical clearance has been obtained.

7 Employees shall be required to meet all qualifications for employment
8 (e.g., licensure, certification, etc.). Employees who become disqualified to perform the
9 duties of their position (e.g., fail to maintain required licenses) shall be immediately
10 removed from duty without pay unless permitted to use appropriate accrued paid leave
11 for which they are eligible and may be subject to appropriate disciplinary action.

12 (7) Military Leave. As provided in the California Military and Veterans
13 Code section 395 et seq., and any amendment thereto, and the Federal Uniformed
14 Services Employment and Reemployment Rights Act of 1994, a County employee,
15 regular, extra-help, per diem, or recurrent may be entitled to the following rights
16 concerning military leave:

17 (A) Definition. MILITARY LEAVE is defined as the performance
18 of duty on a voluntary or involuntary basis in a uniformed service under competent
19 authority and includes active duty, active duty for training, initial active duty for training
20 (weekend drills), full-time National Guard duty, and a period for which an employee is
21 absent for the purpose of an examination to determine the fitness of the person to
22 perform any such duty.

23 (B) Notice and Orders. All employees shall provide advance
24 notice of military service unless military necessity prevents the giving of notice or the
25 giving of notice is impossible or unreasonable. Where available, copy of military orders
26 must accompany the request for leave.

27 (C) Temporary Active Duty. Any employee who is a member of
28 the reserve corps of the Armed Forces, National Guard, or Naval Militia shall be entitled

1 to temporary military leave of absence for the purpose of active military training,
2 encampment, naval cruises, special exercises or like activities provided that the period
3 of ordered duty does not exceed 180 calendar days, including time involved in going to
4 and returning from such duty. While on paid status, an employee on temporary military
5 leave shall receive the same vacation, holiday, and sick leave, step advances, and
6 benefits that would have been enjoyed had the employee not been absent, providing
7 such employee has been employed by the County for at least one year immediately
8 prior to the date such leave begins. In determining the one-year employment
9 requirement, all time spent in recognized military service, active or temporary, shall be
10 counted. An exception to the above is that an uncompleted probationary period must
11 be completed upon return to the job. Any employee meeting the above one-year
12 employment requirement shall be entitled to receive his or her regular salary or
13 compensation, pursuant to Subsection 13.0613(g)(7)(E).

14 (D) Full-Time Active Duty. Employees who resign from positions
15 to serve in the Armed Forces for more than 180 days, shall have a right to return to
16 former classification upon serving written notice to the appointing authority, no later than
17 90 days after completion of such service. Returning employees are subject to a
18 physical/psychological examination. Should such employee's former classification have
19 been abolished, then the employee shall be entitled to a classification of comparable
20 functions, duties, and compensation if such classification exists, or to a comparable
21 vacant position for which the employee is qualified.

22 The right to return to former classification shall include the right to
23 be restored to such civil service status as the employee would have if the employee had
24 not so resigned; and no other person shall acquire civil service status in the same
25 position so as to deprive such employee of this right to restoration.

26 Eligible employees are also entitled to the reemployment and
27 benefit rights as further described in the Uniformed Services Employment and
28 Reemployment Rights Act, 38 U.S.C. sections 4301 to 4333. Specifically, a returning

1 employee will receive restoration of original hire and benefit date, salary step, vacation
2 accrual rate, sick leave balance (unless the employee has received payment for unused
3 sick leave in accordance with provisions contained herein), the retirement plan
4 contribution rate, and retirement system contributions (provided the employee complies
5 with any requirements established by the Retirement Board). However, such employee
6 will not have accrued vacation, sick leave, or other benefit while absent from County
7 employment, except as provided in the temporary duty provision.

8 (E) Compensation. This provision does not include an
9 employee's attendance for inactive duty, commonly referred to as weekend reserve
10 meetings, muster duty, or drills. Employees must use their own time to attend such
11 meetings. Should the meetings unavoidably conflict with an employee's regular working
12 hours, the employee is required to use vacation or holiday leave, leave without pay, or
13 make up the time. Employees who are called in for a medical examination to determine
14 physical fitness for military duty must also use vacation leave, leave without pay, or
15 make up the time. Employees cannot be required to use their accrued leave. Any
16 employee meeting the requirements in (C) and (D) shall be entitled to receive their
17 regular salary or compensation for the first 30 calendar days of any such leave. Pay for
18 such purposes shall not exceed 30 days in any one fiscal year and shall be paid only for
19 the employee's regularly scheduled workdays that fall within the 30 calendar days.

20 (F) Extension of Benefits. The County recognizes the increased
21 requirements of the military due to the current threats facing the United States of
22 America and, as such, has established a program under which employees may be
23 eligible for an extension of benefits. Employees who are called to active duty as a result
24 of the activation of military reservists beginning in September 2001, and who are eligible
25 to receive the 30 calendar days^s military leave compensation, and meet the
26 requirements established by the Board shall receive the difference between their base
27 County salary and their military salary starting on the thirty-first calendar day of military
28 leave. The difference in salary shall continue for the period approved by the Board of

1 Supervisors. During this period, the County will continue to provide the employee the
2 benefits and all leave accruals as were provided prior to such active duty. Retirement
3 contributions and service credit will be granted if the employee had enough pay to cover
4 the entire retirement system contribution. If the employee does not receive enough pay
5 to cover the retirement system contribution, no contribution or credit will be given.
6 Employees should note that the accidental death and dismemberment (AD&D) plan
7 contains a war exclusion.

8 If the employee becomes eligible for full County payment for the
9 first thirty days of military leave provided in (C) of this subsection, the extended
10 payments provided under this section shall be suspended and shall be continued after
11 the 30 days compensation has been completed. No compensation shall be paid
12 beyond the thirty days leave period, unless such compensation is expressly approved
13 by the Board of Supervisors. The County may unilaterally extend the benefits of this
14 subsection upon the approval of the Board of Supervisors.

15 (8) Political Leave. Any employee who is a declared candidate for
16 public office (i.e., a candidate who has filed the appropriate documents) shall have the
17 right to a leave of absence without pay with or without right to return for a reasonable
18 period to campaign for the election. Such leave is subject to the conditions governing
19 special leaves of absence without pay contained herein.

20 (9) Jury Duty Leave. Employees in regular positions who are
21 ordered/summoned to serve jury duty including Federal Grand Jury duty shall be
22 entitled to base pay for those hours of absence from work, provided the employee
23 waives fees for service, other than mileage. Such employees will further be required to
24 deliver a "Jury Duty Certification" form at the end of the required jury duty to verify such
25 service. When practicable, the appointing authority will convert an employee's regular
26 tour of duty to a day shift tour of duty during the period of jury duty. Employees required
27 to serve on a jury must report to work before and after jury duty provided there is an
28 opportunity for at least one hour of actual work time. Employees volunteering to serve

1 on a Grand Jury shall be granted a leave of absence without pay to perform the duties
2 of a member of the Grand Jury, in the same manner as provided in Subsection
3 13.0613(g)(4).

4 (10) Examination Time. Employees having regular status in regular
5 positions at the time of application, or employees who do not have regular status but
6 have previously held regular status and continuously remained a County employee,
7 shall be entitled to a reasonable amount of time off with pay for the purpose of attending
8 all examination processes (e.g., selection interviews, etc.) required for selection to a
9 different County position. Employees are responsible for notifying and obtaining
10 approval from their immediate supervisor prior to taking such leave. Examination time
11 off shall not be charged against any accumulated leave balances and shall be
12 compensated at the employee's base hourly rate.

13 (11) Witness Leave. Employees in regular positions shall be entitled to
14 a leave of absence from work when subpoenaed to testify as a witness, such subpoena
15 being properly issued by a court, agency, or commission legally empowered to
16 subpoena witnesses. This benefit shall not apply in any case in which the subpoenaed
17 employee is a party to the action or the subpoena has arisen out of the employee's
18 scope of employment. Witness leave shall not be charged against any accumulated
19 leave balances and shall be compensated at the employee's base hourly rate. This
20 benefit will be paid only if the employee has demanded witness fees at the time of
21 service of the subpoena, and such fees are turned over to the County.

22 (12) Blood Donations. Employees in regular positions who donate blood
23 without receiving compensation for such donation, may have up to two hours off with
24 pay to recover with prior approval of the immediate supervisor for each such donation.
25 This benefit shall not be charged to any accumulated leave; provided, however, if the
26 employee is unable to work, any time in excess of two hours may be charged to
27 accumulated sick leave or be taken as leave without pay. Evidence of each donation
28 must be presented to the appointing authority to receive this benefit.

1 Employees in regular positions who are apheresis donors may have up to
2 four hours off with pay to recover with prior approval of the immediate supervisor for
3 each such donation, provided no compensation is received for such donation. This
4 benefit shall not be charged to any accumulated leave; provided, however, if the
5 employee is unable to work any time in excess of four hours may be charged to
6 accumulated sick leave or be taken as leave without pay. Evidence of each apheresis
7 donation must be presented to the appointing authority to receive this benefit.

8 (13) Bereavement Leave. Employees in regular positions may use up to
9 two days paid leave, not charged to the employee's personal leave balances, per
10 occurrence for bereavement due to the death of an employee's family member as
11 defined in Subsection 13.0613(g)(1)(A)(I). One additional day shall be granted if the
12 employee travels over 1,000 miles from his or her residence to the bereavement
13 service(s). This additional day shall not be charged to the employee's personal leave
14 balances. The appointing authority may request verification of distance traveled.

15 (14) Leave Accruals While on Disability Leave. Employees receiving
16 the benefits of workers' compensation or short-term disability leave receive partial
17 replacement of their income through these benefits. Employees on these types of
18 disability leaves may choose to fully integrate, partially integrate, or not integrate
19 personal leave time with these disability payments.

20 The maximum amount the employee receives from integrating leave time
21 with disability payments shall not exceed 100 percent of the employee's base salary.
22 Paid personal leave time coded on the employee's time and labor report will be limited
23 to the amount of leave necessary to integrate benefits to the level designated by the
24 employee. When the exact amount is not known, a good faith estimate may be made
25 and the amount will be adjusted later as necessary. If any overpayments are made, the
26 employee will be required to repay that amount. An employee who knowingly receives
27 payment in excess of his or her regular base salary is required to report it to his or her
28 Departmental payroll clerk.

1 Employees who are fully integrating accrued leave time with disability
2 benefits and shall be eligible to receive full accruals of vacation and sick leave.
3 Employees who are not fully integrating shall earn pro-rated vacation and sick leave
4 accruals based upon paid leave time coded on the time and labor report only.

5 Employees who are fully integrating paid leave time with disability
6 benefit(s) will be eligible for fixed holiday pay provided that they are on the payroll for
7 the entire pay period and have no unapproved leave for the pay period. Employees
8 who are partially integrating or not integrating paid leave time with disability benefits will
9 be paid for holidays in accordance with the holiday leave provisions in Subsection
10 13.0613(g)(3).

11 (h) Relocation. Employees who are required by order of their appointing
12 authority to change their principal place of residence because of a reassignment to
13 meet the needs of the service or because of layoff will be granted time off with pay not
14 to exceed two work days and up to \$400.00 reimbursement toward the actual cost of
15 relocating their personal furnishings and belongings.

16 (i) Special Assignment Compensation. Increases in pay may be granted to
17 recognize the temporary assignment of additional responsibilities that are significant in
18 nature and beyond the normal scope of the position. No award shall be made in any
19 situation related to a vacation, short-term illness or other relief which is six weeks or
20 less. The duration of such assignments is not intended to exceed one calendar year
21 except in unusual circumstance approved by both the appointing authority and the
22 Director of Human Resources. Employees will normally not be in a probationary status.
23 The employee shall be required to meet standards for satisfactory performance.

24 Compensation shall be awarded in pay period increments, and shall be in the
25 form of a specified percentage of the employee's base pay. The Director of Human
26 Resources will determine the amount in increments of one-half percent from a minimum
27 of two and one-half percent up to a maximum of seven and one-half percent. The
28 additional compensation will be computed at the specified percentage of the current

1 base pay of the employee for each pay period. Such increases in pay shall not affect
2 an employee's step advancement in the base range pursuant to the salary rates and
3 step advancements subdivision.

4 Requests for special assignment compensation may be initiated by the
5 appointing authority or an employee via the appointing authority. The appointing
6 authority and the employee bear mutual responsibility for initiating the compensation
7 request in a timely manner and adhering to the compensation provisions defined in this
8 provision. It is important to obtain Human Resources Department review of the request
9 in advance of the date the employee begins the assignment, since there is no
10 guarantee that the request will be approved. Special assignment compensation is to be
11 effective only with the Director of Human Resources written approval, assignment of the
12 greater level of duties, and signed acceptance by the employee.

13 This provision shall not be utilized to circumvent or provide additional
14 compensation over and above that which may be provided in the subsection on
15 assignment to vacant higher position and the Personnel Rules. These aforementioned
16 provisions are mutually exclusive concepts and as such there shall be no dual or
17 multiple requests based on the same facts.

18 (j) Expenses Incurred in Conducting County Business and Expense
19 Reimbursement.

20 (1) General Provisions. Employees in the Exempt Group shall be
21 reimbursed for all expenses incurred in connection with the conduct of County business,
22 including, but not limited to: 1 travel, lodging, meals, laundering, gratuities, and other
23 related costs. Payment for actual expenses is subject to the approval of the appointing
24 authority. The Chief Executive Officer, Assistant Executive Officers, and County officers
25 with department head status may incur necessary County expenses involved with
26 activities and functions of their departments and arrange for the County to be billed
27 directly for such expenses.

28 The purpose of this subdivision is to define the policy and procedures by

1 which employees shall report and be reimbursed for necessary expenses incurred on
2 behalf of San Bernardino County, except as may be otherwise provided in this code.

3 (2) Responsibilities. It shall be the responsibility of each appointing
4 authority or designee to investigate and approve each request for expense
5 reimbursement. It shall be the responsibility of each employee to obtain prior approval
6 from the appropriate appointing authority or designee to incur a business expense or to
7 exceed maximum allowable amounts provided in Section (7) below.

8 Prior approval may be in the form of standing orders issued by the
9 appointing authority. Failure to obtain prior approval may result in denial of any
10 expense claim (or excess amount) not pre-approved.

11 (3) Travel Authorization.

12 (A) Travel outside the State of California must be approved by
13 the Chief Executive Officer or designee. Requests for such travel shall be submitted to
14 the County Administrative Office on a travel request form.

15 (B) The appointing authority or designee shall initiate travel
16 requests. The Chief Executive Officer and Auditor-Controller/Treasurer/Tax Collector
17 shall be notified in writing of all such designees.

18 (C) The appointing authority or designee is authorized to
19 approve necessary travel within the State of California and use of transportation mode
20 consistent with this subdivision.

21 (4) Authorization for Attendance at Meetings.

22 (A) Appointing authorities may authorize attendance at meetings
23 at County expense when the program material is directly related to an important phase
24 of County service and holds promise of benefit to the County as a result of such
25 attendance.

26 (B) Authorization for attendance at meetings without expense
27 reimbursement, but on County time, may be granted when the employee is engaged on
28 the County's behalf, but from which the gain will inure principally to the benefit of the

1 employee and only incidentally to the County.

2 (5) Records and Reimbursements.

3 (A) Requests for expense reimbursements should be submitted
4 once each month and within one year of the date that the expense was incurred.

5 (B) Receipts or vouchers which verify the claimed expenditures
6 will be required for all items of expense, except:

7 (I) Subsistence, except as otherwise provided in this
8 subdivision;

9 (II) Private mileage (e.g., mileage to the airport);

10 (III) Telephone or other communication-related charges
11 including Wi-Fi and internet access fees if needed to conduct County business;

12 (IV) Other authorized expenses of less than \$1.00.

13 (C) Claims for expense reimbursement totaling less than \$1.00
14 in any fiscal year shall not be paid.

15 (D) Reimbursement shall not be made for any personal
16 expenses such as, but not limited to, entertainment, barbering, personal grooming,
17 alcoholic beverages, etc.

18 (E) Except as otherwise provided in this subdivision, expense
19 reimbursements shall be made on an actual cost basis.

20 (F) If the receipt is unavailable, the employee may submit a
21 signed statement with an explanation of expenses (i.e., itemized list of expenses with
22 location, date, dollar amount, and reason for expenses) and an explanation as to why
23 the receipt is unavailable.

24 (G) Expense reimbursements may be made via electronic fund
25 transfer into the financial institution of the employee's choice or by pay card.
26 Employees who fail to make arrangements for direct deposit shall receive
27 reimbursements via pay card.

28 (6) Transportation Modes.

1 (A) The general rule for selection of a mode of transportation is
2 that mode which represents the lowest expense to the County. Where an employee is
3 given the choice between several means of travel (e.g., use of County vehicle vs. own
4 personal vehicle, flying vs. driving, etc.) and the employee chooses the option that is
5 more costly, the employee shall only be reimbursed for the lesser cost option. For
6 example, if an employee chooses to drive his or her own vehicle when offered a County
7 vehicle, the employee shall not be entitled to any reimbursement. Similarly, if the cost
8 of flying on an airplane is less than the cost of driving, the employee shall only be
9 reimbursed for the amount the County would have paid for the flight.

10 (B) Travel via Private Automobile.

11 (I) Reimbursement for use of privately-owned
12 automobiles to conduct County business shall be at the IRS allowable rate.
13 Reimbursement at this rate shall be considered as full and complete payment for actual
14 necessary expenses for the use of the private automobile, insurance, maintenance and
15 all other transportation related costs. The County does not provide any insurance for
16 private automobiles used on County business. The owner of an automobile is
17 responsible for the personal liability and property damage insurance when the vehicle is
18 used on County business.

19 (II) When employees, traveling on official County
20 business, leave directly from their principal place of residence rather than from their
21 assigned work location, mileage allowed to the first work contact point shall be the
22 difference between the distance from the residence to the assigned work location and
23 the distance from the residence to the first work contact point. If the first work contact
24 point is closer than the assigned work location, no mileage shall be allowed. If the
25 employee departs from the last work contact point directly to the residence, the same
26 principle governs.

27 (III) Employees may have multiple assigned work
28 locations. Mileage allowed is based on the assigned work location for that day. When

1 employees have more than one assigned work location in a standard tour of duty,
2 mileage shall be allowed between assigned work locations. In no case will mileage be
3 allowed between the employee's residence and the assigned work location.

4 (C) Travel via Air.

5 (I) Commercial Aircraft. When commercial aircraft
6 transportation is approved, the "cost of public carrier" shall mean the cost of air coach
7 class rate including tax and security surcharges. Travel via charter aircraft shall be
8 limited to emergencies, or when other types of transportation are impractical or more
9 expensive. Specific prior approval for travel via charter aircraft must be obtained from
10 the Chief Executive Officer or designee.

11 (II) Private Aircraft. When private aircraft transportation
12 is approved by the Chief Executive Officer or designee, reimbursement will be as
13 follows:

14 (i) Reimbursement for use of aircraft owned or
15 rented and flown by County personnel will be for equivalent road miles at the first mile
16 rate of the current private automobile use reimbursement schedule. Landing or tie-
17 down fees will be reimbursed similar to auto parking charges.

18 (ii) Reimbursement for trips to and from the
19 following destinations will be limited to the cost of public carrier except when justified by
20 unusual circumstances as determined by the Chief Executive Officer or designee:
21 Sacramento, San Francisco, Oakland and San Jose.

22 (iii) Authorized charter flights with a licensed
23 charter service providing the aircraft and pilot will be reimbursed at actual cost. Charter
24 flights must be individually approved by the Chief Executive Officer or designee prior to
25 departure.

26 (iv) The employee or owner of the aircraft must
27 maintain on file, with the County's Risk Management Department, a current policy for
28 aviation comprehensive general liability insurance, which includes the County as an

1 additional insured and covers all operations performed by or on behalf of the employee
2 or owner of the aircraft for bodily injury and property damage with a combined single
3 limit of not less than \$1,000,000.00, per occurrence and \$2,000,000.00, general
4 aggregate.

5 (D) Travel via Rental Vehicles. Reimbursement will be provided
6 for the cost of a rental vehicle used for business purposes if such use is approved by
7 the appointing authority. Rental vehicles are covered for liability and vehicle physical
8 damage under the County's self-insurance program. Reimbursement will not be
9 provided for the additional costs incurred if any employee purchased any additional
10 insurance or signs a collision damage waiver (CDW) when renting a vehicle for County
11 business. Requests for reimbursement for gasoline for rental vehicles must be
12 accompanied by a copy of the rental agreement or rental receipt and gasoline receipt.

13 (E) Travel via Ride-Share Service, Taxi, or Public/Mass Transit.
14 Reimbursement will be provided for the cost of using a ride-share service, (e.g., Uber or
15 Lyft), taxi, or public/mass transit (e.g., bus, streetcar, and ferry) if such expenses are
16 incurred for County business and approved by the appointing authority.

17 (F) Incidental Travel Expenses. Reimbursement will be
18 provided for the cost of incidental travel expenses such as bridge tolls, road tolls and
19 parking fees if such expenses are incurred as part of County business and approved by
20 the appointing authority. Valet parking will not be reimbursed unless self-parking is not
21 available or security is a concern.

22 (7) Subsistence.

23 (A) Subsistence allowances for lodging and meals shall not be
24 allowed without prior approval of the appointing authority or designee as necessary for
25 the purpose of conducting County business. Meal and lodging selections should
26 represent a reasonable cost to the County and be generally consistent with the rates
27 established by the General Services Administration (GSA). Excess charges greater
28 than the allowances listed below in Subdivisions (B) and (C) may be authorized under

1 special conditions, such as a convention or conference requirement (e.g., lodging at the
2 hotel where the conference is held) or if County business requires lodging and meals in
3 an area of unusually high cost (i.e., Non-Standard Areas as established by the GSA).
4 Employees may be reimbursed for expenses in high cost areas for the actual cost
5 incurred, but generally not to exceed the per diem amounts established by the GSA for
6 that area and month. Receipts are mandatory to obtain reimbursement for all lodging
7 expenses, and except as provided below, for all meal expenses claimed.

8 (B) An employee may be reimbursed for lodging expenses at
9 actual cost, generally not to exceed the standard lodging per diem rate as established
10 by the GSA, except as otherwise provided in Subdivision (A) above.

11 (C) Except as otherwise provided in Subdivision (A) above,
12 reimbursements for meal expenses for up to three separate meals per day may be
13 provided as follows:

14 (I) With receipts. An employee may be reimbursed for
15 meal expense at actual cost not to exceed eleven dollars (\$11.00) for breakfast; fifteen
16 dollars (\$15.00) for lunch; and twenty-four dollars (\$24.00) for dinner, all plus tax and up
17 to 15 percent gratuity.

18 (II) Without receipts. An employee may be reimbursed for
19 meal expense at per diem rates not to exceed six dollars (\$6.00) for breakfast; nine
20 dollars (\$9.00) for lunch; and nineteen dollars (\$19.00) for dinner, all plus tax and up to
21 15 percent gratuity.

22 (D) Where the cost of a meal is included as part of a registration
23 charge for an event (e.g., continental breakfast at a conference or training seminar) or in
24 the cost of lodging, an employee may not claim reimbursement for that meal.

25 (8) Expense Advances. Advancement of funds for business expenses
26 can be obtained from the Auditor-Controller/Treasurer/Tax Collector's Office through
27 submission of the appropriate form. Advancements shall not exceed the per diem
28 allowances set forth herein. The minimum amount to be advanced is \$50.00.

1 (9) County Credit Cards. The appointing authority may issue a County
2 credit card to an employee and require business expenses be paid for with said card. If
3 unauthorized charges are placed on the card, the employee shall be required to
4 reimburse the County.

5 (k) Medical Insurance and Retirement System Contributions.

6 (1) Medical Insurance Contributions.

7 (A) Section 125 Premium Conversion Plan.

8 (I) Eligible employees shall be provided with a Section
9 125 premium conversion plan. The purpose of the plan is to provide employees a
10 choice between paying premiums with either pre-tax salary reductions or after-tax
11 payroll deductions for medical insurance, dental insurance, vision insurance, voluntary
12 life (to the Internal Revenue Service (IRS) specified limit) and accidental death and
13 dismemberment insurance premiums currently maintained for Exempt Group
14 employees or any other programs(s). The amount of the pre-tax salary reduction or
15 after-tax payroll deduction must be equal to the required insurance premium.

16 (II) Medical and dental coverage elections shall not
17 reduce earnable compensation for purposes of calculating benefits or contributions for
18 the SBCERA.

19 (III) To be eligible for the Section 125 premium conversion
20 plan, an employee must be eligible to participate in medical, dental, vision, AD&D,
21 and/or life insurance and have a premium deduction for these benefit plans.

22 (IV) Election of pre-tax salary reductions and after-tax
23 payroll deductions shall be made within 60 days of the initial eligibility period in a
24 manner and on such forms designated by Human Resources. Failure to timely submit
25 appropriate paperwork will result in after-tax payroll deductions for all eligible premiums
26 for the remainder of the plan year.

27 (V) Once a salary reduction has begun, in no event will
28 changes in elections be permitted during the plan year except to the extent permitted

1 under IRS rulings and regulations, and consistent with the County's Section 125 plan
 2 document. The employee must submit request for a change due to a mid-year
 3 qualifying event within 60 days of the qualifying event.

4 (B) Medical and Dental Subsidies.

5 (I) The County has established a medical premium
 6 subsidy (MPS) to offset the cost of medical and dental plan premiums charged to
 7 eligible employees. The MPS shall be applied first to medical plan premiums and then
 8 to dental plan premiums. The applicable MPS amount shall be paid directly to the
 9 providers of the County-sponsored medical and dental plans in which the eligible
 10 employee has enrolled. In no case, shall the MPS exceed the total cost of the medical
 11 and dental insurance premium for the coverage selected.

(II) The County has established a dental premium subsidy (DPS) for all employees who are enrolled in both County-sponsored medical and dental coverage whose premium costs for medical and dental exceeds the MPS. The amount of the DPS shall be up to \$9.46, but not to exceed the combined total of the employee's out-of-pocket premium expenses.

(III) Eligibility for MPS and DPS While on Leave.

(i) FMLA/CFRA. Employees who are on

1 approved leave, pursuant to FMLA/CFRA law and whose paid hours in a pay period are
2 less than the required number of hours designated in Subsection 13.0613(f)(1) above
3 will continue to be enrolled in a County-sponsored medical plan and receive MPS and
4 DPS in accordance with applicable law.

5 (ii) Pregnancy Disability Leave (PDL). An
6 employee on an approved pregnancy disability leave is eligible for continuation of MPS
7 and DPS in accordance with PDL, Government Code section 12945.

8 (iii) Workers' Compensation. Employees who are
9 on an approved leave based on an approved workers' compensation claim shall
10 continue to receive the MPS and DPS for up to a total of 20 pay periods while off work
11 due to that work injury as long as the employee pays his or her portion of the premiums
12 on time. If any subsequent workers' compensation claims occur during the initial 20 pay
13 periods, the remaining MPS eligibility from the original claim shall run concurrent with
14 any additional approved workers' compensation claims that occur during the initial
15 claim. For example, if the employee is receiving the MPS and DPS for 20 pay periods
16 for an injury and after ten pay periods another workers' compensation claim is approved
17 and the employee is eligible to receive the MPS and DPS for an additional 20 pay
18 periods, ten pay periods will run concurrent with the initial claim, for a total of 30 pay
19 periods. Employees who are still on workers' compensation after the expiration of the
20 initial 20 pay periods shall continue to receive MPS and DPS provided the employee is
21 fully integrating appropriate paid leave time.

22 (iv) Short Term Disability. Employees who are fully
23 integrating paid leave time with short-term disability (STD) insurance provided by the
24 County or State Disability Insurance (SDI) shall continue to receive the MPS and DPS.

25 (v) Per Episode of Illness or Injury. Employees
26 who are on an approved medical leave of absence and whose paid hours in a pay
27 period are less than the required number of hours will continue to receive the benefits of
28 this Subdivision for up to six pay periods per episode of illness or injury.

1 (2) Retirement System Contributions.

2 (A) County Contributions. The County shall pay all required
3 employer contributions to the San Bernardino County Employee's Retirement
4 Association (SBCERA).

5 (B) Employee Contributions. All employee Retirement System
6 contribution obligations shall be "picked up" for tax purposes only pursuant to this
7 section. The Auditor-Controller/Treasurer/Tax Collector has implemented the pickup of
8 such retirement system contributions under Internal Revenue Code subsection
9 414(h)(2).

10 The County shall make member contributions under this
11 subdivision on behalf of the employee which shall be in lieu of the employee's
12 contributions and such contributions shall be treated as employer contributions for
13 purposes of reporting and wage withholding under the Internal Revenue Code and the
14 Revenue and Taxation Code. The amounts picked up under this subdivision shall be
15 recouped through offsets against the salary of each employee for whom the County
16 picks up member contributions. These offsets are akin to a reduction in salary and shall
17 be made solely for purposes of income tax reporting and withholding. The member
18 contributions picked up by the County under this subdivision shall be treated as
19 compensation paid to County employees for all other purposes. County-paid employer
20 contributions to SBCERA under this subdivision shall be paid from the same source of
21 funds used in paying the salaries of the affected employees. No employee shall have
22 the option to receive the retirement system contribution amounts directly instead of
23 having them paid to SBCERA.

24 Until retirement or separation, all contributions picked up under this
25 subdivision will be considered for tax purposes as employer-paid contributions.

26 (C) Special Provisions.

27 (I) Except as provided below, employees who have 30
28 years of service credit shall not be paid in cash seven percent of earnable

1 compensation. Employees with at least 25 years of service as set forth in Government
2 Code section 31625.3 as of June 18, 2011, and who either already have or thereafter
3 attain 30 years of service credit as set forth in Government Code section 31625.3 shall
4 have one opportunity during the employee's employment to receive cash payments of
5 seven percent of earnable compensation for up to 26 consecutive pay periods.

6 (II) Employees who are over the age of 60 at the time of
7 hire, and who are in a regular position, and who choose not to be a member of
8 SBCERA, shall be enrolled in the County's 401(k) Salary Savings Plan. The County
9 shall contribute the applicable percent of the employee's biweekly salary as defined in
10 Subsection 13.0613(gp) to the Plan, and the employee shall contribute a minimum of
11 three percent of biweekly salary to the plan, not to exceed the annual limits of the Plan
12 as defined in the Internal Revenue Code.

13 (D) Survivor Benefits. Survivor Benefits are payable to
14 employed general retirement members with at least 18 months continuous retirement
15 membership pursuant to Government Code section 31855.12. An equal, non-
16 refundable employer and employee biweekly contribution will be paid to SBCERA as
17 provided in the annual actuarial study.

18 (E) Special Provisions for Exempt Safety Employees. The
19 following Subdivision shall apply to all members of the Exempt Group who are safety
20 members of SBCERA as defined in Government Code section 31469.3, on October 1,
21 2003.

22 For Tier 1 safety members of SBCERA, the County adopted a
23 resolution making Government Code section 31664.1 applicable to safety members,
24 effective October 1, 2003. The County also adopted a resolution pursuant to
25 Government Code section 31678.2, applying the formula set forth in Government Code
26 section 31664.1 applicable to all prior safety service credit for every eligible employee
27 under this Subdivision.

28 For Tier 2 safety members, the applicable retirement formula is as

1 provided by applicable law.

2 (3) Flexible Spending Account (FSA) for Medical Related Expenses.

3 (A) General. The County has established a Medical Expense
4 Reimbursement Plan, also known as a Flexible Spending Account (FSA). This plan has
5 been established in accordance with the provisions of Internal Revenue Code section
6 125. Human Resources will serve as the FSA Plan administrator and will administer the
7 FSA in accordance with the County's plan document. The FSA's plan year will coincide
8 with the County's benefit plan year.

9 (B) Eligible employees may contribute to the FSA, on a pre-tax
10 basis, an amount up to the Internal Revenue Code's annual maximum. This annual
11 contribution is made by the employee via equal biweekly payroll deductions. The
12 County will also contribute up to \$40.00 per biweekly pay period, matching Exempt
13 employee contributions dollar for dollar. Effective February 1, 2020, the County will
14 contribute up to an additional \$10.00 per biweekly pay period, matching Exempt
15 employee contribution dollar for dollar, for employees who select the County-sponsored
16 Blue Shield Access + HMO Plan or the Kaiser Choice HMO Plan and elect to enroll in
17 the FSA. FSA participants must elect to enroll each year in order to continue
18 participation. Upon enrolling in the FSA, employees may not change their designated
19 biweekly contribution amount or discontinue making contributions for the remainder of
20 the plan year except as permitted by the Internal Revenue Code. Any unused amounts
21 remaining in an employee's FSA account at the end of the Plan year shall be forfeited
22 except as permitted by the Internal Revenue Code and the County's plan document.
23 Contributions made to the FSA may be used for receiving non-taxable reimbursements
24 of eligible medical expenses not covered by insurance. Eligible reimbursable expenses
25 are those medical expenses that qualify as determined under Internal Revenue Code
26 section 213.

27 (4) Retirement Medical Trust Fund. A Retirement Medical Trust Fund
28 (RMT) has been established. Exempt Group employees with five or more years of

1 participation in SBCERA are eligible to participate. The trust is a Voluntary Employee
2 Benefit Association (VEBA) and will comply with all the provisions of Internal Revenue
3 Code section 501(c)(9).

4 The Retirement Medical Trust Fund will be administered by Human
5 Resources as the plan administrator in accordance with the plan document and
6 applicable law.

7 (A) Sick Leave Conversion Eligibility. Exempt Group employees
8 with five or more years of participation in SBCERA are eligible to participate in the Trust.
9 The purchase of additional retirement credit or other retirement service credit and/or
10 participation in other public sector retirement systems may be counted towards the five
11 year service requirement provided that the employee has not withdrawn their
12 contributions from the system(s) and the employee is also a member of SBCERA.

13 Employees who wish to receive credit for participation in other
14 public retirement systems must provide the Plan Administrator written evidence of
15 participation and that contributions made to the system(s) have not been withdrawn.

16 (B) Sick Leave Conversion Formula. At separation from County
17 service for reasons other than death, all eligible employees will be required to contribute
18 the cash value of their unused sick leave balances to the Trust at the rate of 80 percent
19 of the cash value of unused sick leave hours, up to a maximum of 1,500 hours.

20 (C) County Contribution. The County will contribute to the RMT
21 as follows:

27 (I) Tuition Reimbursement and Membership Dues. The County shall
28 establish an individual, departmental fund in the amount of \$1,000.00 for each fiscal

1 year for each regular employee in the Exempt Group to reimburse employees for tuition
2 costs incurred for job-related education or career development or to reimburse
3 membership dues in professional organization(s), provided each expenditure enhances
4 furtherance of County or continuing educational goals.

5 Requests for reimbursement must be approved in advance by the appointing
6 authority and shall not be paid in increments less than \$10.00 per fiscal year. The
7 individual department fund is in addition to department budgeted and mandated training
8 and memberships. The County shall also pay, in addition to the individual department
9 fund, the membership dues to the State Bar of California for all licensed attorneys in the
10 Exempt Group whose job duties require admission in the State Bar.

11 Employees who successfully complete job-related education or courses may
12 submit a request to be reimbursed beyond the limit of \$1,000.00 to their department
13 head or appointing authority for review. The department head or appointing authority
14 must then request and receive approval from the County Administrative Office to
15 reimburse beyond the limit of \$1,000.00 per fiscal year per employee. In order to be
16 eligible for tuition reimbursement under this provision, the employee must take such
17 course work outside regular work hours, and shall do no productive work for the County
18 while attending the courses.

19 If the reimbursement is approved and paid to the employee, and the employee
20 leaves the County prior to completing two years of County service after completing the
21 job-related education or coursework, the employee will reimburse the County according
22 to the following schedule:

27 Benefits under the Tuition Reimbursement and Membership Dues Subdivision
28 shall be pro-rated for job share and part-time employees.

1 (m) Tuition Loan Repayment. The County shall establish a Tuition Loan
2 Repayment Program to assist the Exempt group with student loan obligations and
3 encourage continued County employment.

4 (1) Eligibility requirements - all requirements must be met before the
5 employee is deemed eligible for loan repayment assistance:

6 (A) The employee is employed in a regular full time exempt
7 classification.

8 (B) The employee fully completes the County's Student Loan
9 Repayment Application.

10 (C) The employee submits proof of the following:

11 (I) A qualifying degree.

12 (II) Current statements from an unpaid loan.

13 (III) The employee is in paid status in the pay period the
14 repayment is made.

15 (IV) The employee is not participating in another tuition
16 loan repayment program. This does not include participation in any loan forgiveness
17 program.

18 (V) Employee's last Work Performance Evaluation rating
19 is a "meets standards" or above and not on an work performance improvement plan.

20 (VI) Employee is not on a current leave restriction plan.

21
22 (2) Terms of Loan Repayment Assistance: Employees with 2 or more
23 years of continuous service with the County may apply for tuition loan repayment.

24 Continuous service is defined as the total length of service from an employee's most
25 recent beginning (hire) date in a regular position with no separation from County
26 employment. Employees must complete a new application and submit supporting
27 documentation for each disbursement for loan repayment. Any additional annual
28 incentive will require completion of new one-year continuous periods of Qualifying

1 Service on and after the date of the implementation of this provision. In no event will the
2 payments be combined. If the application meets County requirements, the payment
3 shall be as follows:

4 (A) After completion of 2 continuous years with the County: A
5 single payment of up to \$1,000.

6 (B) After completion of 3 continuous years with the County: A
7 single payment of up to \$1,500.

8 (C) After completion of 4 continuous years with the County: A
9 single payment of up to \$2,000.

10 (D) After completion of 5 continuous years with the County: A
11 single payment of up to \$2,500.

12 (E) After completion of 6 continuous years with the County: A
13 single payment of up to \$3,000.

14 Payment shall not exceed the total amount of \$10,000 per employee.
15 Eligible employees may receive the payment within thirty ~~(30)~~ days after approval of the
16 required documentation.

17 (3) Restrictions

18 (A) Employee must have one or more qualifying student loans
19 (including private loans provided they qualify pursuant to all applicable State and
20 Federal laws, rules, and regulations).

21 (B) Degree must have been completed and employee must be
22 in active repayment of the loan.

23 (C) Loans must not be in default status. Employees must
24 provide a written statement from their lender(s) substantiating that the loan(s) are not in
25 default, dated within ten ~~(10)~~ business days of the application for payment.

26 (D) Payments made on loans in the year prior to the repayment
27 request that are less than the maximum yearly repayment amount will be eligible for the
28 lesser amount paid only.

1 (E) Employees who separate from County employment are not
2 entitled to prorated payments.

3 (F) The lender information must be verified annually, and must
4 not be older than ten-(10) days prior to the application for payment.

5 (G—) If loans have been consolidated, proof of
6 consolidation must be provided.

7 (H) Employees must show proof of loan payments for each of
8 the prior twelve-(12) consecutive months.

9 (d)(4) Program Details

10 (A) Payment will be made directly to the employee through
11 EMACS. Payment will be subject to all required payroll deductions, and participants will
12 be responsible for any and all applicable taxes resulting from the payments they
13 receive.

14 (B) Qualifying Student Loan shall mean a loan (or the portion of
15 a loan, if consolidated) taken and used to cover the cost of an eligible qualifying degree.
16 The determination of whether or to what extent a loan is a Qualifying Student Loan shall
17 be made based on guidelines established by the Human Resources Department.

18 (C) Notwithstanding the foregoing, reimbursement under this
19 Section shall be made subject to any additional conditions approved by the appointing
20 authority.

21 (nm) Conditions of Employment. Unless in the classified service, employees in
22 this group serve at the pleasure of their appointing authority.

23 Should a classified employee's position be abolished, the County will make
24 reasonable efforts to place the employee in a comparable County position based upon
25 the employee's skills, knowledge and abilities, as well as consideration for the
26 employee's length of service with the County. If reasonable efforts to place an exempt
27 classified employee in a comparable County position are unsuccessful, the employee
28 shall be subject to lay-off by written notification by the appointing authority or the Chief

1 Executive Officer, which notification shall be given at least ten working days prior to the
2 effective date of the layoff. An Exempt Group classified employee does not have any
3 bumping rights to other County positions.

4 (~~OR~~) Automobiles.

5 (1) All County employees in Benefit Groups A and B, Assistant Sheriffs
6 and Sheriff's Deputy Chiefs, and the District Attorney Chief Investigator in a paid status
7 are eligible for a Category I County vehicle under this subdivision with the approval of
8 the Chief Executive Officer.

9 Such employees may use such vehicles for occasional personal use
10 provided they reimburse the County at the current motor pool variable rate per mile for
11 such use. All automobile users shall be taxed for such personal use in accordance with
12 state and federal tax law and regulation.

13 (2) All County employees in Benefit Groups A and B, Assistant Sheriffs
14 and Sheriff's Deputy Chiefs, and the District Attorney Chief Investigator in a paid status
15 shall receive a biweekly automobile allowance in the amount of \$561.54 with no mileage
16 reimbursement, provided they are not assigned a County vehicle pursuant to
17 Subsection 13.0613(~~OR~~)(1) above and they provide a private vehicle for their own use
18 on County business. An employee who becomes eligible or ineligible for this benefit in
19 the middle of a pay period will receive a prorated sum of automobile allowance.
20 Employees selecting this allowance shall be required to have a vehicle available at all
21 times for use on County business. This allowance shall be considered complete
22 reimbursement for the acquisition, insurance, maintenance, repair, upkeep, fuel, and all
23 other costs for the required vehicle.

24 (3) Effective June 20, 2020, the automobile allowance shall be reduced
25 from \$561.54 to \$461.54 per biweekly pay period. The reduced amount (\$100 per
26 biweekly pay period) shall be included in base salary of employees eligible for this
27 automobile allowance, as reflected in the salary schedules and tables as set forth in
28 Section 13.0613(c)(3), and as on file with Clerk of the Board of Supervisors.

1 (~~pe~~) Administrative Leave. Effective pay period 1 of each year, an employee in
2 a regular position who is in paid status will be provided with 80 hours of administrative
3 leave time for the employee's use. An eligible employee in a regular position who is
4 part-time or job-sharing shall be eligible for a prorated number of administrative leave
5 hours based on regularly scheduled hours. Employees newly entering the Exempt
6 Group after the beginning of pay period 1 shall receive a prorated number of hours.
7 Such proration shall be based upon the remaining number of pay periods in the
8 calendar year nearest the employee's appointment. Employees not in paid status in
9 pay period 1 shall receive, upon return to paid status, a prorated number of
10 Administrative Leave hours based on the number of pay periods remaining in the
11 calendar year.

12 Administrative leave may be cashed out at the employee's then current base rate
13 of pay in increments of one hour, upon the approval of the appointing authority, during
14 the calendar year. Any Administrative Leave accrual balances in effect at the end of the
15 last pay period paid in the calendar year will automatically be paid at the employee's
16 then current base rate of pay. Employees may designate that cash outs of
17 Administrative Leave be contributed to the County's 401(k) Plan or 457(b) Deferred
18 Compensation Plan. Upon termination of employment, unused Administrative Leave
19 will be paid at the current rate of pay.

20 All elected officials, i.e., the County-wide elected officials and members of the
21 Board of Supervisors, are not eligible to receive administrative leave.

22 (~~qp~~) Contributions to Salary Savings Plan.

23 (1) Biweekly contributions of Exempt Group employees to the County's
24 401(k) Defined Contribution Plan will be matched by a County contribution on the basis
25 of two times the employee's contribution. The biweekly contributions of Exempt Group
26 employees in Benefit Groups A, B, and C of up to four percent of biweekly base salary
27 will be matched by a County contribution of two times the employee's contribution, not
28 to exceed eight percent of an employee's biweekly base salary. The biweekly

1 contributions of Exempt Group employees in Benefit Group D to the County's 401(k)
2 Defined Contribution Plan of up to three percent of biweekly base salary will be matched
3 by a County contribution of two times the employee's contribution. The County
4 contribution shall not exceed six percent of an employee's biweekly base salary.

5 (2) Biweekly contributions of Exempt Group employees in Benefit
6 Groups A and B to the County's 457(b) Deferred Compensation Plan up to one percent
7 of biweekly base salary will be matched by a County contribution on the basis of one
8 times the employee's contribution. The County contribution shall not exceed one
9 percent of the employee's biweekly base salary. The County contribution shall be
10 deposited in the County's 401(a) Defined Contribution Plan.

11 (3) Biweekly contributions of Exempt Group employees in Benefit
12 Groups C and D to the County's 457(b) Deferred Compensation Plan up to one percent
13 of biweekly base salary will be matched by a County contribution of one-half times the
14 employee's contribution. The County contribution shall not exceed one-half percent of
15 the employee's biweekly base salary. The County contribution shall be deposited in the
16 County's 401(a) Defined Contribution Plan.

17 (rq) Employment Interview Expenses and Moving Reimbursement.

18 (1) Interview Expense Reimbursement. For employees in Benefit
19 Group C and above, the appointing authority may approve reimbursement of interview
20 expenses incurred by external candidates upon proof/receipts provided. Such
21 reimbursement is restricted to airfare, auto mileage, meals, overnight stay, and airport
22 transit. Employees must submit a request for reimbursement for employment interview
23 expenses within 90 days of hire date to be eligible for the reimbursement. Requests
24 submitted for reimbursement after 90 days from hire date will be denied, unless waived
25 by the appointing authority.

26 (2) Moving Expense Reimbursement.

27 (A) The Chief Executive Officer may approve moving expenses
28 up to but not exceeding \$10,000.00 for any employee new to County employment for

1 whom the Chief Executive Officer or the Board of Supervisors is the appointing authority
2 or any department head. The Chairperson of the Board of Supervisors may approve
3 such moving expenses for the Chief Executive Officer. Reimbursement of moving
4 expenses in excess of \$10,000.00 must be approved by the Board of Supervisors.

5 (B) The appointing authority may approve moving expenses up
6 to but not exceeding \$5,000.00 for employees new to County employment in Benefit
7 Group B or Benefit Group C, not covered by Subsection 13.0613(rq)(2)(A), for moving
8 expenses authorized, incurred and documented as a result of accepting the position.

9 (C) For employees in Benefit Group D the following provision
10 applies. To assist with the recruitment and appointment of qualified individuals to hard-
11 to-recruit positions/classifications, upon request of the appointing authority, the Director
12 of Human Resources may authorize reimbursement of a new employee's relocation-
13 related expenses incurred as a result of accepting employment with the County, as
14 follows:

Miles Relocated	Maximum Reimbursement
500 250*—1,000 miles	\$1,000.00
1,001—2,000 miles	\$2,000.00
More than 2,000 miles	\$2,500.00

18 *The 250-mile distance shall only apply if the relocation is from outside San Bernardino
19 County.

20 (D) Reimbursement may be provided to employees covered in
21 Subsections 13.0613(rq)(2)(B) and 13.0613(rq)(2)(C) upon initial employment with the
22 County, provided that the employee: (1) is appointed to a regular position; (2) submits
23 original receipts documenting expenses incurred; and (3) agrees to remain employed in
24 the regular position for at least 12 months. Such employees must submit a request for
25 reimbursement for moving expenses within 90 days of hire date to be eligible for the
26 reimbursement. Requests submitted for reimbursement after 90 days from hire date will
27 be denied, unless waived by the appointing authority.

28 If the employee voluntarily resigns employment prior to completion

1 of 12 months' service, the employee shall be required to reimburse the County for any
2 payment made under this subdivision.

3 (sf) Peace Officer Standards and Training Pay.

4 (1) General. Peace Officer Standards and Training (POST) certificates
5 are awarded to peace offers who achieve increasingly high levels of education, training,
6 and experience in his or her pursuit of professional excellence. POST base rate of pay
7 adjustments will be uniformly maintained for all County employees.

8 (2) Qualification. An Exempt Group law enforcement employee, other
9 than the elected Sheriff, in the Sheriff's Department or District Attorney's Office who
10 obtains an Advanced Certificate shall have his or her base rate of pay increased in
11 accordance with the table and procedures set forth below. An Exempt Group law
12 enforcement employee, other than the elected Sheriff, in the Sheriff's Department or
13 District Attorney's Office who obtains a Supervisory Certificate, or a higher POST
14 certificate, or a master's degree earned through attendance at an accredited university
15 or college, shall have his or her base rate of pay increased in accordance with the table
16 and procedures set forth below. If an employee obtains a Supervisory Certificate and
17 has his or her base rate of pay increased as set forth below, and thereafter obtains a
18 higher POST certificate or a master's degree, the employee will receive no further
19 increase in his or her base rate of pay.

20 (3) Rates.

21 (A) The rates for POST pay are as follows:

1 (B) Effective January 21, 2017, the County added the flat dollar
2 amounts in the table above to the then existing base rate of pay to establish a higher
3 base rate of pay for the employees described in this section who obtained an Advanced
4 Certificate and/or a Supervisory Certificate, or a higher POST certificate, or a master's
5 degree. Once the new higher base rate of pay was established, the County established
6 a new POST Pay of two percent. Effective January 16, 2021, the County shall establish
7 a new POST Pay of three percent. The initial granting of this POST increase to three
8 percent is subject to the discretion of the Chief Executive Officer based on the
9 availability of financial resources. Effective January 29, 2022, the County shall establish
10 a new POST Pay of four percent. Effective January 28, 2023, the County shall establish
11 a new POST Pay of five percent.

12 (C) Effective July 18, 2020, the County shall establish a new
13 POST base pay for employees who obtain a Management POST Certificate. This
14 POST base pay shall be approximately \$1.79 per hour above POST base pay effective
15 July 18, 2020, for a Supervisory Certificate or a master's degree. The initial
16 establishment of this new POST base pay for a Management POST certificate is subject
17 to the discretion of the Chief Executive Officer based on the availability of financial
18 resources.

19 (4) Procedure. The employee shall submit a written request for POST
20 pay to the department with an attached copy of the appropriate POST certificate or
21 official transcript from the accredit university or college. This POST pay shall start the
22 first full pay period following receipt by the County of a valid POST certificate or official
23 transcript. The County shall submit to POST in an expeditious manner, applications by
24 affected employees for the certificates described above.

25 (ts) Dependent Care Assistance Plan. The purpose of this Section 125
26 Dependent Care Assistance Plan (DCAP) is to permit eligible employees to make an
27 election to pay for certain dependent care expenses with salary reduction from
28 compensation contributed to the plan before federal income or social security taxes are

1 paid to the IRS (“Salary Reduction”) in accordance with Internal Revenue Code sections
2 125 and 129 and regulations issued pursuant thereto. The DCAP shall be construed to
3 comply with said code sections and to meet the requirements of any other applicable
4 provisions of law. The DCAP will be administered by Human Resources in accordance
5 with the DCAP plan document and applicable law.

6 (1) To be eligible for this benefit, an employee must be in a regular
7 position.

8 (2) Enrollment in the plan is required every plan year and is limited to
9 the annual open enrollment period or no later than 60 days following the date of
10 becoming eligible due to a mid-year change in status event. Failure to submit a
11 participation agreement within the time frame shall result in an election to not participate
12 in the plan.

13 (3) An employee must elect to contribute to the DCAP through salary
14 reduction on forms approved by Human Resources. An employee election to
15 participate shall be irrevocable for the remainder of the plan year. Once a salary
16 reduction has begun, in no event will changes in elections be permitted during the plan
17 year except to the extent permitted under IRS rulings and regulations and with the plan
18 document.

19 (4) Pursuant to Internal Revenue Code section 125, any amounts
20 remaining in the employee’s account at the end of a plan year must be forfeited except
21 as permitted by the Internal Revenue Code and the plan document.

22 (~~Ut~~) Vacant Higher Position. Employees directed to continuously perform
23 duties in a vacant higher level regular position for which funds have been appropriated,
24 shall be entitled to a salary rate increase to the higher level for the time actually worked
25 in excess of 160 hours, unless specifically waived by the employee; provided, however:

26 (1) The appointing authority certifies to the Director of Human
27 Resources, in writing at the time of appointment, that the employee meets minimum
28 qualifications and is assigned and held responsible to fully perform all of the duties

1 normally associated with the higher level position without limitation as to difficulty or
2 complexity of assignments or consequence of action and that the employee shall be
3 required to meet standards for satisfactory performance normally required at the higher
4 level position; and

5 (2) A written request for salary rate increase to the higher level is
6 directed to the Director of Human Resources for approval; such increase to the higher
7 level shall be determined as if the assignment had been a promotion.

8 It shall be the responsibility of the appointing authority to initiate such
9 requests and to provide a copy of such request to the employee. Written requests may
10 also be made by the employee through the appointing authority in the same manner.
11 Requests for a salary rate increase should be initiated during the first 30 calendar days
12 of such assignment. Requests for retroactive payment of a salary increase must be
13 filed as soon as possible, but not later than one calendar year after assignment of the
14 higher level duties and must be approved by the Director of Human Resources. Failure
15 to meet this time limitation shall waive any and all rights to retroactive pay.

16 The duration of such assignments to vacant higher positions are not
17 intended to exceed one calendar year except in unusual circumstances approved by
18 both the appointing authority and the Director of Human Resources or designee. Such
19 assignments in all circumstances are temporary assignments and at the conclusion of
20 such assignments the respective employee shall be returned to his or her previous
21 classification. Appointments to regular positions of trainees or underfills are exempt
22 from the provisions of this section. Further, this section does not apply to a situation in
23 which there is no vacant higher-level position for which funds have been appropriated.
24 Addition of duties of a higher-level classification to any employee's regular position shall
25 be governed by the Special Assignment Compensation section or the Personnel Rules
26 on Classification, as appropriate. For purposes of this section, a vacant position is
27 defined as an authorized regular position for which funds have been appropriated and
28 which may be: (1) An unoccupied position due to attrition and for which the appointment

1 process has been initiated; (2) A position from which the incumbent is on extended
2 leave of absence; or (3) A new position authorized by the Board of Supervisors for
3 which the appointment process has been initiated.

4 (v) Personnel Rules. Notwithstanding any other provision in the County Code
5 or the Personnel Rules, those serving in classified service positions have appeal rights
6 under the Personnel Rules, except as otherwise provided herein. Any such appeals
7 shall be heard by a hearing officer selected from the Civil Service Commission Hearing
8 Officer list and appointed by the Civil Service Commission or, upon mutual agreement
9 of the appellant and the County, shall be heard by the Civil Service Commission. If the
10 appeal is heard by a hearing officer, the Civil Service Commission shall either accept or
11 reject the hearing officer's findings and recommendations within 30 days of receipt by
12 the Commission.

13 The only grounds for rejection of the hearing officer's decision must be for one of
14 the following and the rejection must include specific detail in writing:

15 (1) The recommendation was procured by corruption, fraud, or other
16 undue means;

17 (2) There was corruption on the part of the hearing officer;

18 (3) The rights of a party were substantially prejudiced by the
19 misconduct of the neutral hearing officer;

20 (4) The hearing officer exceeded his or her powers;

21 (5) The rights of a party were substantially prejudiced by the refusal of
22 the hearing officer to postpone the hearing upon sufficient cause being shown therefore,
23 or by the refusal of the hearing officer to properly include or exclude evidence material
24 to the controversy.

25 Should such be the case, the Commission must state in writing specific
26 reason(s) for the decision (1, 2, 3, 4, or 5) and subsequently conduct and complete a full
27 and fair evidentiary hearing on the appeal within 30 days of rejecting the hearing
28 officer's findings and recommendations unless the hearing cannot for good cause be

1 completed within 30 days.

2 Those serving in unclassified positions do not have civil service appeal
3 rights as they serve at the pleasure of the appointing authority. Positions in the Exempt
4 Group shall not have rights to the classification appeal procedures under the Personnel
5 Rules.

6 (~~WV~~) Reemployment.

7 (1) A regular employee who has separated County employment, and
8 who is subsequently rehired in the same classification in a regular position within one
9 year (i.e., beginning the first day of work by the 365th calendar day), may receive
10 restoration of salary step, vacation accrual rate, and sick leave balance, unless the
11 employee has received payment for unused sick leave in accordance with the
12 Retirement Medical Trust Subdivision, subject to the approval and conditions
13 established by the appointing authority and the Director of Human Resources. Such
14 employees begin accruing vacation and sick leave and may utilize the same
15 immediately. Restoration of retirement contribution rate shall be in accordance with
16 applicable State law and in compliance with any requirements established by SBCERA.
17 The employee shall be required to serve a new probationary period, unless waived by
18 the Director of Human Resources. The employee shall be provided a new date of hire
19 for purposes of County seniority.

20 (2) A regular employee who has separated County employment and
21 who is subsequently rehired to a regular position in the same job family within one year,
22 (i.e., beginning the first day of work by the 365th calendar day), may receive restoration
23 of vacation accrual rate, sick leave, and retirement contribution rate in the same manner
24 as described above. Such employees begin immediately accruing vacation and sick
25 leave and may utilize the same immediately. The employee shall be required to serve a
26 new probationary period, unless waived by the Director of Human Resources. The
27 employee shall be provided a new date of hire for purposes of County seniority.

28 (3) A regular employee who has separated County employment, and

1 who is subsequently rehired to a regular position in another job family within a 90
2 calendar day period, must begin the first day of work within 90 calendar days and
3 beginning the first day of work by the ninety-first day, may receive restoration of salary
4 step (in the instance of rehire in a classification at the same pay range as the position
5 originally held), vacation accrual rate, sick leave and retirement contribution rate in the
6 same manner as described above. The employee shall be required to serve a new
7 probationary period, unless waived by the Director of Human Resources. The
8 employee shall be provided a new date of hire for purposes of County seniority.

9 (4) Reemployment from Layoff. A regular employee who has been laid
10 off from County employment and is subsequently rehired to a regular position shall be
11 reemployed in the same manner as described in the reemployment subdivision.
12 Restoration of retirement contribution rate shall be in accordance with applicable state
13 law and in compliance with any requirements established by SBCERA.

14 (5) For purposes of this subdivision, a regular employee shall mean an
15 employee in a regular position who held regular status in any classification during the
16 previous period of County employment.

17 (xw) Recruitment and Referral Bonus Programs.

18 (1) General. The County shall make available to appointing authorities'
19 recruitment and referral incentive (bonus) programs to assist in the recruitment and
20 appointment of qualified individuals into hard-to-recruit regular positions in the Exempt
21 Group, in accordance with the guidelines established herein.

22 (2) Program Applicability. Appointing authorities may request
23 authorization to apply the recruitment and/or referral incentive program(s) to assist in
24 filling regular positions in their departments. To apply, said position/classification must
25 have had historical/demonstrable recruitment difficulty. The Director of Human
26 Resources shall have the sole authority to determine the applicability and duration of
27 these program(s) to each requested position/classification and shall certify applicability
28 of the program(s) for each position, by assignment, department, and beginning and

1 ending dates. Such determinations shall not be subject to any review or appeal.

2 (3) Recruitment Bonus. An employee hired into a regular
3 position/classification certified for participation in this program shall be eligible to receive
4 recruitment bonuses in accordance with the following:

5 (A) Bonus Amount and Method of Payment.

6 (I) The eligible employee hired into a position/
7 classification that is a department head or for whom the Chief Executive Officer or
8 Board of Supervisors is the appointing authority shall receive \$2,500.00 upon hire and
9 an additional \$2,500.00 upon completion of 2,080 service hours in the
10 position/classification for which the original bonus was granted.

11 (II) The eligible employee hired into a position/
12 classification in Benefit Group B or Benefit Group C, not covered by Subsection
13 13.0613(xw)(3)(A)(I), shall receive \$1,500.00 upon hire and an additional \$1,500.00
14 upon completion of 2,080 service hours in the position/classification for which the
15 original bonus was granted.

16 (III) The eligible employee hired into a position/
17 classification in Benefit Group D shall receive no less than \$500.00 and no more than
18 \$1,000.00 upon hire and an additional \$1,000 upon completion of 2,080 service hours in
19 the position/classification for which the original bonus was granted.

20 (IV) Each bonus payment shall be considered taxable
21 income and subject to withholding.

22 (B) Limitations and Exclusions.

23 (I) No bonus will be paid for any candidate whose name
24 was placed on the eligible list for positions in the classification prior to the beginning
25 date certified by the Director of Human Resources for that classification to be eligible for
26 participation in the referral bonus program. Similarly, no bonus will be paid for any
27 candidate whose name was placed on the eligible list for positions in the classification
28 after the ending date certified by the Director of Human Resources for that classification

1 to be eligible for participation in the referral bonus program.

2 (II) The bonus payment shall not be considered in
3 determining regular rate of pay for purposes of computing overtime compensation.

4 (III) The appointing authority shall have sole responsibility
5 and authority to determine eligibility for the second installment of the recruitment bonus.
6 Such determination shall not be subject to review or appeal.

7 (4) Referral Bonus. Any employee in a regular position who refers a
8 qualified candidate for a position/classification certified for participation in this program
9 who is subsequently hired into the regular position may receive a referral bonus in
10 accordance with the following:

11 (A) Method of Referral. To be eligible for the recruitment bonus,
12 the County application for employment must contain the name of the referring employee
13 on the application.

14 (B) Bonus Amount and Method of Payment. The referring
15 employee shall receive a bonus of \$250.00 for each referred candidate actually hired
16 into an eligible regular position. An additional \$500.00 shall be paid upon that new
17 employee's completion of 2,080 service hours. Said bonus shall be considered taxable
18 income and subject to withholding.

19 (C) Limitations and Exclusions.

20 (I) No bonus will be paid for any candidate whose name
21 was placed on the eligible list for positions in the classification prior to the beginning
22 date certified by the Director of Human Resources for that classification to be eligible for
23 participation in the referral bonus program. Similarly, no bonus will be paid for any
24 candidate whose name was placed on the eligible list for positions in the classification
25 after the ending date certified by the Director of Human Resources for that classification
26 to be eligible for participation in the referral bonus program.

27 (II) Individuals assigned to employee recruitment as a
28 primary function of their position shall not be eligible to receive this bonus.

1 (III) In cases where more than one employee is named as
2 a “referring party,” the referral bonus shall be equally split between the referring
3 employees.

4 (IV) In cases where the referred employee resigns,
5 transfers out of the eligible position, or is terminated prior to completion of 2,080 service
6 hours, the additional \$500.00 shall not be paid.

7 (V) The referral bonus payment shall not be considered in
8 determining regular rate of pay for purposes of computing overtime compensation.

9 (VI) The appointing authority shall have sole responsibility
10 and authority to determine eligibility for the second installment of the referral bonus.
11 Such determination shall not be subject to review or appeal.

12 (~~y~~x) County Counsel Legal Service Classification.

13 (1) Application. This section shall apply to all Deputy County Counsel
14 classifications.

15 (2) Service. The term “service” means service which the appointing
16 authority finds to be good or superior in work performance and conduct.

17 (3) Hiring. With the approval of the County Counsel, experienced
18 attorneys may be hired in a classification and at a variable entrance rate commensurate
19 with demonstrated experience, ability, and the needs of the County. Attorneys without
20 experience may be hired as a Deputy County Counsel I at the appropriate entrance step
21 of the applicable salary range.

22 (4) Deputy County Counsel I. After a period of 1,040 hours of service
23 in a Deputy County Counsel I classification, an attorney shall be advanced one step
24 increment to the next step within the applicable salary range. After an additional 1,040
25 hours of service, the Deputy County Counsel I shall be promoted to a Deputy County
26 Counsel II classification. The Deputy County Counsel I shall be terminated if it is found
27 that such promotion is not merited. An attorney hired as a Deputy County Counsel I at
28 some step other than step 1 because of experience, ability, or needs of the County may,

1 after 1,040 hours of service, be promoted to a Deputy County Counsel II classification
2 upon the recommendation of the appointing authority.

3 (5) Deputy County Counsel II. After a period of 1,040 hours of service
4 in the Deputy County Counsel II classification, an attorney shall be advanced one step
5 increment. After an additional period of 1,040 hours of service, the Deputy County
6 Counsel II shall be advanced one step increment. After an additional period of not less
7 than 1,040 hours nor more than 2,080 hours of service, the Deputy County Counsel II
8 shall be promoted to a Deputy County Counsel III classification, or the Deputy County
9 Counsel II shall be terminated if it is found that such promotion is not merited.

10 (6) Deputy County Counsel III. After a period of 1,040 hours of service
11 in the Deputy County Counsel III classification, an attorney shall be advanced one step
12 increment. After an additional period of 1,040 hours of service, the Deputy County
13 Counsel III shall be advanced one step increment. After an additional period of not less
14 than 1,040 hours nor more than 2,080 hours of service, the Deputy Counsel III shall be
15 promoted to a Deputy County Counsel IV classification or the Deputy County Counsel III
16 shall be terminated if it is found that such promotion is not merited.

17 (7) Deputy County Counsel IV. After a period of 1,040 hours of service
18 in the Deputy County Counsel IV classification, an attorney shall be advanced one step
19 increment. Step advancements shall be in one step increments after completion of
20 each additional period of 1,040 hours of service until the top step for the classification is
21 reached.

22 (8) Attorneys shall be on probation for the entire time of service below
23 the Deputy County Counsel IV level. An attorney hired as a new employee in the
24 Deputy County Counsel III or Deputy County Counsel IV classification shall serve a
25 combined probationary and training period of 2,080 hours of service. Those promoted
26 to Deputy County Counsel IV from Deputy County Counsel III shall immediately acquire
27 regular status in the higher classification.

28 (9) Deputy County Counsel V. A Deputy County Counsel IV at the top

1 step of the Deputy County Counsel IV level may be promoted to a Deputy County
2 Counsel V. Eligibility for promotion to Deputy County Counsel V shall be pursuant to
3 criteria approved by the appointing authority. Employees promoted to Deputy County
4 Counsel V shall not obtain regular status as a Deputy County Counsel V as such
5 employee shall serve in a probationary status for the duration of the appointment as a
6 Deputy County Counsel V and may be removed from a Deputy County Counsel V
7 classification by the appointing authority at any time without any right to review or
8 appeal. Additionally, there shall be an annual review by the appointing authority of the
9 performance of each Deputy County Counsel V, and it shall be discretionary with the
10 appointing authority whether to continue each employee's Deputy County Counsel V
11 status. An employee who is removed as a Deputy County Counsel V shall be returned
12 to Deputy County Counsel IV status.

13 (10) Exceptional Service. An additional two range increase or an
14 additional four range increase in salary may be paid to attorneys for outstanding ability
15 or work for a period not to exceed 2,080 hours if such increase is: (1) jointly
16 recommended by the appointing authority and the Chief Executive Officer or his/her
17 designee, ~~and (2) approved by the Board of Supervisors.~~ Such additional
18 compensation may be renewed each year and shall be designated Exceptional Service
19 Compensation. Employees in the classification of Deputy County Counsel V shall not
20 be eligible for compensation under this subdivision.

21 (11) Removal from Operation of Section. Upon request of the
22 appointing authority and the approval of the Civil Service Commission, an attorney may
23 be removed from the operation of this section.

24 (zy) Bilingual Compensation. Upon the approval of the Director of Human
25 Resources or designee, employees in the Executive Assistant category of the Exempt
26 Group required by the appointing authority or designee to perform bilingual translation
27 involving the use of English and a second language (including American Sign
28 Language) as a condition of employment, shall be eligible for bilingual compensation in

1 the amount of \$45.00 per pay period. Such compensation shall apply regardless of the
2 total time required per day for such translation. Such employees must be certified as
3 competent in translation skills by Human Resources to be eligible for compensation.

4 (~~aaz~~) (Repealed by Ord. 4270, passed - -2015).

5 (~~bbaa~~)(Repealed by Ord. 4270, passed - -2015).

6 (~~cbbb~~) Portable Communication Device Allowance. All County employees in
7 Benefit Groups A and B in a paid status, shall receive a biweekly portable
8 communication device allowance in the amount of \$92.31. An employee who becomes
9 eligible or ineligible for this benefit in the middle of the pay period will receive a prorated
10 amount.

11 The employee shall purchase a portable communication device capable of
12 sending and receiving cellular telephone calls, and capable of sending and receiving e-
13 mails to and from the County e-mail system. The County shall pay for any license and
14 set up expense for the device if any, and the employee shall pay for the equipment and
15 monthly voice and data plans.

16 (~~ddee~~) Probationary Period. Unless a longer probationary period is otherwise
17 provided, all classified employees in the Exempt Group shall serve a probationary
18 period of one year or 2,080 hours.

19 (~~eedd~~)(Repealed by Ord. 4306, passed - -2016).

20 (~~ffee~~) Perfect Attendance. Employees in regular, full-time positions in Benefit
21 Groups C and D who do not utilize any sick leave, any leave (e.g., vacation) in lieu of
22 sick leave, or benefits in lieu of sick leave (e.g., workers' compensation, short-term
23 disability partial/full integration, etc.), in a payroll calendar year (i.e., pay period one
24 through pay period 26 or 27, when applicable, of the same year), and who do not record
25 any sick leave without pay or absent without pay, medical emergency leave, or military
26 leave as provided by law during that year, shall accrue 16 hours of perfect attendance
27 leave, for use in the next calendar year. Failure to utilize perfect attendance leave
28 within the calendar year shall result in forfeiture of the same. Perfect attendance leave

1 may not be cashed out.

2 (ggff) Healthy Lifestyles Program. The healthy lifestyle program is available to
3 employees in the Exempt Group. Under this program, Exempt Group employees are
4 eligible for reimbursement for health club membership up to \$324.00 on an annual
5 basis. Exempt Group employees are also eligible for an annual physical examination
6 through the Arrowhead Regional Medical Center.

7 (hhgg) Voluntary Time Off. The Voluntary Time Off (VTO) Program is intended to
8 provide Exempt Group employees a means of taking unpaid (i.e., non-compensated)
9 time off work, without losing the following benefits: medical premium subsidy, dental
10 premium subsidy, opt-out/waive amount, vision care, retirement medical trust employer
11 contribution, and life insurance which depend on the employee being in a paid status.
12 The following conditions apply:

13 (1) VTO may be taken in the same manner as vacation time except
14 that VTO must be used in one-hour increments and is limited to 80 hours per calendar
15 year.

16 (2) When VTO is taken, leave accruals continue as if the employee
17 was on paid time. VTO time counts as time worked toward satisfying the minimum hour
18 requirement to receive benefits, such as medical premium subsidy, dental premium
19 subsidy, opt-out/waive amount, County-paid life insurance, and County-paid vision care.

20 (3) VTO does not count as hours worked for purposes of computing
21 overtime, if applicable. County contribution to the retirement system under the
22 retirement system contributions subsection will only be paid if the employee is in a paid
23 status in any pay period in which VTO is used and the employee receives enough
24 earnings to pay his or her retirement contribution in that pay period.

25 Pursuant to applicable law, Tier 1 retirement system members are eligible
26 for full service credit for the pay period in which VTO is used and the employer
27 contribution would be based on the employees' normal compensation earnable.

28 Pursuant to applicable law, Tier 2 retirement system members are eligible

1 for a reduced service credit amount for the pay period in which VTO was used and the
2 employer contribution would be based on the employees' actual earnings for that pay
3 period.

4 (4) VTO may not be used for situations that would otherwise require
5 leave without pay, such as an employee on short-term disability, or in conjunction with
6 leave without pay.

7 (5) VTO is an entirely voluntary program. No employee may be
8 required to take VTO.

9 (6) VTO may be taken by request of the employee and upon approval
10 of the appointing authority.

11 (iih) Retirement Incentive. Eligible employees in identified classifications that
12 meet the requirements for a service retirement from the San Bernardino County
13 Employees' Retirement Association (SBCERA) and who retired on or before June 30,
14 2009, are eligible to receive a retirement incentive in the amount of \$250.00 for each
15 completed quarter of a year of current continuous service in a regular position with the
16 County, payable in five annual payments after retirement. Such annual payments shall
17 be made in July of each year. The Chief Executive Officer may exclude from eligibility
18 classifications or positions assigned to organizational units that must remain filled.

19 Unless waived by the Chief Executive Officer, vacant positions created by those
20 employees receiving the retirement incentive shall not be filled for a period of five years.
21 Alternatively, departments may fill vacated positions if other positions with an equivalent
22 cost savings remain vacant for a period of five years.

23 Payments to an eligible employee under this program who returns to work for the
24 County in any capacity after retiring shall be temporarily suspended until the employee
25 again separates from employment with the County.

26 (jj#) (Repealed by Ord. 4306, passed - -2016).

27 (kkj) ~~Longevity Retention Pay (formerly Longevity Pay)~~. Exempt Group
28 employees, except those persons who qualify for ~~transitional~~ Probation Retention pay

1 under Subsection 13.0613(~~oon~~), shall be eligible for longevity retention pay above the
 2 base rate of pay, as indicated below, based on total hours of completed continuous
 3 service with the County. Longevity Retention pay shall be paid on all paid hours up to
 4 an employee's standard hours, and shall not be considered when determining the
 5 appropriate rate of pay for a promotion or demotion.

- 20 • Auditor-Controller/Treasurer/Tax Collector Division Chief
- 21 • Auditor-Controller/Treasurer/Tax Collector Manager
- 22 • Chief Administrative Analyst
- 23 • Chief Deputy Treasurer
- 24 • County Chief Financial Officer
- 25 • Deputy Executive Officer
- 26 • HS Auditing Chief
- 27 • Principal Administrative Analyst
- 28 • Public Health Chief Financial Officer

- 1 • Public Works Chief Financial Officer
- 2 • Sheriff's Financial Manager

3 The annual CPA stipend shall be paid in a lump sum to eligible employees in
4 regular positions who are licensed CPAs and are in paid status in the pay period that
5 includes July 1 of each year. An eligible employee in a regular position who is part-time
6 or job-sharing shall be eligible for a prorated lump-sum payment based on regularly
7 scheduled hours. An employee who is licensed as a CPA after July 1, or who is
8 appointed after July 1, shall receive a prorated CPA stipend payment at the time of
9 licensure or appointment, as applicable. Such proration shall be based upon the
10 remaining number of pay periods in the fiscal year nearest his or her appointment.

Audits must have resulted in the preparation of reports indicating the audits were conducted in accordance with the AICPA, IIA, IFAC, GAGAS, SSAE or PCAOB or other comparable national or international organization or state or federal regulation standards and/or regulations. Eligibility for this differential is at the discretion of the appointing authority.

~~(nnmm)~~ Behavioral Health Medical Director Differential. The Behavioral Health Medical Director shall receive a five percent differential above the employee's base rate of pay provided such employee is certified as a Diplomate by the American Board of Psychiatry and Neurology. The differential shall be paid for all hours actually worked up to 80 hours per pay period.

~~(oonn)~~ Transitional-Probation Retention Pay. The Chief Probation Officer, Assistant Chief Probation Officer and Deputy Chief Probation Officers who fall within the definition of "safety member" under Government Code section 31469.4 and have completed 15 or more years of continuous completed service hours in a regular position shall receive transitional-Probation Retention pay above their base rate of pay, as indicated below, based on the total hours of continuous completed service in a regular position with the County. Transitional-Probation Retention pay shall be paid on all paid hours up to an employee's standard hours and shall be excluded when determining the appropriate rate of pay for promotion or demotion. Employees who qualify for transitional-Probation Retention pay shall begin to receive the pay following completion of the required service hours.

17 (B) Employees may choose to enroll in the MBO at hire or
18 during the annual open enrollment period, and may choose to change to the traditional
19 benefit option during subsequent open enrollment periods.

20 (C) Employees who select the Modified Benefit Option must
21 commit to work a minimum of 1,560 hours per calendar year.

22 (D) In order to receive the benefits and wage differential of the
23 MBO, the employee must specifically choose the Option.

24 (2) Modified Benefit Option Wage Differential.

25 (A) Employees who select the MBO shall receive a wage
26 differential of 4% above the base rate of pay. The wage differential shall be paid on all
27 paid hours (e.g., REG, PTO, etc.).

28 (B) The wage differential shall be considered as part of the base

1 hourly rate when calculating the following: County contribution to the employee's
2 Retirement Medical Trust (RMT) account, County match to employee's contribution to
3 457(b) Deferred Compensation Plan, County match to employee's contribution to
4 County's 401(k) Defined Contribution Plan, differentials paid on a percentage basis
5 (e.g., ~~longevity~~Retention Pay, POST), sick leave conversion cash-out pursuant to
6 Subsections 13.0613(g)(1)(l) and 13.0613(k)(4), and other leave cash-outs if any.
7 Provided below is an example of how the County's contribution to the RMT would be
8 calculated:

9 Example: Employee with 17 years of continuous County service
10 and an 80-hour per pay period schedule selects the MBO. The employee's base hourly
11 rate is \$70 per hour. This employee is eligible for a County contribution to the RMT
12 equal to 3.75% of the employee's base bi-weekly salary. The County contribution to the
13 RMT is calculated as follows:

21 leaves that employees who select the traditional benefit option receive.

22 (A) Medical Coverage. Employees who select the MBO shall
23 have the same medical plan options as employees who select the traditional benefit
24 option (e.g., Blue Shield HMO, Kaiser HMO, Blue Shield Access + HMO, Kaiser Choice
25 HMO, and Blue Shield PPO).

26 (B) Medical Premium Subsidy (MPS).

27 (l) Employees who select the MBO shall receive MPS in
28 the following amounts per pay period:

16 (A) Definition. Employees who select the MBO shall be granted
17 Paid Time Off (PTO) in lieu of any other Vacation or Sick accrual leave provisions.

*The employee's maximum PTO accrual that may be carried over to a future calendar year may not exceed 272, 362, or 452, as applicable. Additionally, the maximum combined vacation and PTO accrual that may be carried over to a future calendar year for an employee who has a grandfathered maximum vacation accrual balance of more than 480 hours as allowed in Subsection 13.0613(g)(2)(B) shall be this employee's grandfathered maximum vacation accrual balance plus 106 PTO hours. For example, if employee's grandfathered maximum vacation accrual balance is 600 hours, the maximum combined vacation and PTO accrual that may be carried over to a future calendar year shall be 706 hours (600 vacation hours plus 106 PTO hours). Any PTO accrual balance at the end of the calendar year in excess of employee's maximum PTO accrual that may be carried over to a future calendar year shall be automatically cashed out and paid in accordance with Subsection 13.0613(~~qqpp~~)(4)(E)(II). Additionally, any combined vacation/PTO accrual balance at the end of the calendar year in excess of the employee's allowed maximum combined vacation/PTO balance, in which vacation accruals do not exceed employee's allowed

1 maximum vacation accrual balance, shall be cashed out in PTO hours paid in
2 accordance with Subsection 13.0613(~~ggpp~~)(4)(E)(II). For example, if an employee with
3 a maximum combined accrual balance of 586 has 480 vacation hours (i.e., employee's
4 vacation maximum accrual balance) and 200 PTO hours for a combined accrual
5 balance of 680 hours, 94 PTO hours shall be automatically cashed out in accordance
6 with Subsection 13.0613(~~ggpp~~)(4)(E)(II).

7 (C) Administration.

8 (I) PTO for Vacation Leave Purposes. When PTO has
9 been requested for vacation leave purposes, PTO shall be administered according to
10 Subsection 13.0613(g)(2)(C).

11 (II) PTO for Sick Leave Purposes. When PTO has been
12 requested for sick leave purposes, PTO shall be administered according to Subsection
13 13.0613(g)(1)(D).

14 (D) Separation. Employees separating from County
15 employment shall have any unused PTO administered in the same manner that
16 Vacation Leave is administered at separation according to Subsection
17 13.0613(g)(2)(C)(IV).

18 Exempt employees who are subsequently hired into a position in a
19 bargaining unit that does not contain the MBO, shall carry over their existing PTO
20 balance and begin accruing vacation, floating holiday, and sick leave immediately.

21 (E) PTO Cash-Out.

22 (I) Elective Conversion. An employee may sell back
23 PTO at the base hourly rate of the employee as hereinafter provided, upon approval of
24 the appointing authority. Eligible employees may exercise these options under
25 procedures established by the Director of Human Resources. In lieu of cash, the
26 employee may designate that part or all of the value of PTO be contributed to the
27 County's 401(k) Defined Contribution Plan or 457(b) Deferred Compensation Plan. In
28 order to sell back PTO prior to termination or retirement, an employee may exercise the

1 following options:

2 Option 1. Future Accruals. An employee must make an
3 irrevocable election during the month of December, specifying the number of PTO hours
4 to be sold back from the next calendar year's PTO accrual. Such election must be
5 made in increments of not less than ten hours and may not exceed 160 hours. All
6 designated hours remaining at the end of the pay period 25 will automatically be
7 converted into cash in the last period of the calendar year.

8 Option 2. Existing Accruals. Existing PTO accruals may be
9 cashed out in whole hour increments with a minimum cash out of ten hours and will be
10 subject to a ten percent penalty.

11 (II) Automatic Conversion. At the end of the last pay
12 period of the calendar year, an employee shall automatically have any PTO accruals in
13 excess of the employee's maximum PTO accrual balance converted to cash. Such
14 automatic PTO cash out shall be paid in pay period 1 of the next calendar year.

15 (F) Accrual Carryover Following Benefit Change.

16 (I) Traditional Benefit Option to Modified Benefit Option.

17 (i) Employees who convert from the traditional
18 benefit option to the MBO shall carry over and may utilize their existing vacation,
19 holiday, and sick leave balances; provided, however, that the employee shall no longer
20 accrue vacation leave, sick leave, and a floating holiday after converting to the MBO.
21 After converting to the MBO the employee shall be immediately eligible to accrue PTO.

22 Any vacation leave accrual balance carried over to
23 the MBO that is in excess of the employee's allowed maximum vacation leave accrual
24 balance at the end of the calendar year shall be cashed out and paid in accordance with
25 Subsection 13.0613(g)(2)(E)(II). For example, an employee with a maximum vacation
26 leave accrual balance of 480 hours begins MBO in pay period 16 and carries over 572
27 vacation hours. This employee then uses 20 vacation hours and has 552 vacation
28 hours at the end of the last pay period of the calendar year. In this example, 72

1 vacation hours shall automatically cash out in pay period 1 of the next calendar year
2 such that 480 vacation hours carries over to the next calendar year (552 hours – 72
3 hours = 480 hours).

4 (ii) Vacation Cash-Out. Employees who met the
5 eligibility requirements for the vacation cash-out prior to selecting the MBO, and
6 predesignated to cash-out vacation leave during the required pre-designation period
7 while in the traditional benefit option, shall remain eligible to cash-out vacation leave.
8 However, employees enrolled in the MBO shall not be eligible to pre-designate to cash-
9 out vacation leave while enrolled in the MBO unless employee intends to convert to the
10 traditional benefit option during next calendar year's open enrollment period and start
11 accruing vacation that calendar year.

12 Additionally, employees who select the MBO will
13 continue to have the option to cash-out existing vacation accruals according to
14 Subsection 13.0613(g)(2)(E).

15 (II) Modified Benefit Option to Traditional Benefit Option.

16 (i) Employees who convert from the MBO to the
17 traditional benefit option shall carry over and may utilize their existing PTO balance (if
18 any) and begin accruing vacation, floating holiday, and sick leave immediately;
19 however, the maximum combined PTO and vacation accrual that may be carried over to
20 a future calendar year shall not exceed this employee's allowed maximum vacation
21 accrual balance at the end of the calendar year as established in Subsection
22 13.0613(g)(2)(B). Any combined excess leave hours at the end of the calendar year
23 shall be cashed out as PTO hours and paid in accordance with Subsection
24 13.0613(~~ggpp~~)(4)(E)(II). For example, an employee with a maximum vacation accrual
25 balance of 480 hours begins the traditional benefit option in pay period 16 and carries
26 over 150 PTO hours and 375 Vacation Leave hours and accrues an additional 68
27 vacation hours through pay period 26 (i.e., total combined leave at the end of calendar
28 year equals 593 hours). In this example, 113 PTO hours shall automatically cash out in

1 pay period 1 of the next calendar year such that 480 total combined vacation/PTO hours
2 carries over to the next calendar year (593 hours – 113 hours = 480 hours). If
3 employee has a grandfathered maximum vacation accrual balance, the grandfathered
4 vacation accrual balance shall be the maximum combined vacation and PTO balance
5 that may be carried over.

6 (ii) PTO Cash-Out. Employees who met the
7 eligibility requirements for the PTO cash-out prior to converting from the MBO to the
8 traditional benefit option, and pre-designated to cash-out PTO during the required pre-
9 designation period while in the MBO, shall remain eligible to cash-out PTO. However,
10 employees enrolled in the traditional benefit option shall not be eligible to pre-designate
11 to cash-out PTO while enrolled in the traditional benefit option unless employee intends
12 to convert to the MBO during next calendar year's open enrollment period and start
13 accruing PTO that calendar year.

14 Additionally, employees who convert from the MBO to
15 the traditional benefit option will continue to have the option to cash-out existing PTO
16 according to Subsection 13.0613(~~qqpp~~)(4)(E)(I).

17 ~~(rr)qq~~ The Director of Human Resources shall have the authority, with the
18 approval of the County's Chief Executive Officer, to provide Exempt Group employees
19 who participated in major COVID-19 initiatives up to the 40 hours of COVID Leave
20 consistent with the COVID leave provided to the represented bargaining units.

21 ~~(ss)rr~~. The Director of Human Resources shall have the authority, with the
22 approval of the County's Chief Executive Officer, to provide Exempt Group employees
23 who provide proof of vaccination up to 32 hours of COVID Vaccine Leave Incentive
24 consistent with the COVID Vaccine Leave Incentive provided to the represented
25 bargaining units.

26 (tt) The Director of Human Resources shall have the authority, with the
27 approval of the County's Chief Executive Officer, to provide Exempt Group employees
28 with COVID-19 Premium Pay consistent with COVID-19 Premium Pay provided to the

1 majority of representedthe- bargaining units.

2 SECTION 2. Section 13.0614 of the San Bernardino County Code is amended,
3 to read ~~in its entirety as follows:~~

4 **13.0614 Salaries and Working Conditions of the Elected Officials.**

5 (a) Compensation.

6 (1) Board of Supervisors. Section 1 of Article VI of the County Charter
7 establishes the annual compensation (including salary and benefits) of members of the
8 Board of Supervisors and provides that compensation is re-evaluated, and adjusted if
9 necessary, every four years.

10 (2) County-Wide Elected Officials. Section 1 of Article VI of the County
11 Charter establishes the annual salaries of County-wide elected officials, as defined in
12 section 13.0613(b), except that of the Superintendent of County Schools, and provides
13 that salary is re-evaluated, and adjusted if necessary, every year.

14 (b) Benefits—County-Wide Elected Officials.

15 (1) Notwithstanding any other provisions of the County Code, County-
16 wide elected officials shall receive the same benefits provided to Exempt Group
17 employees in Benefit Group A, or as otherwise specified, in Subsections (f), (j), (k), (l),
18 (~~on~~), (~~qp~~), (~~ts~~), (~~ccbb~~), (ff) ~~and~~, (~~ssrr~~), and (tt) of Section 13.0613, and as otherwise
19 specified by law or the County Code and as modified below.

20 (A) County-wide elected officials are not required to enroll in
21 County-sponsored medical and dental coverage as described in Subsection
22 13.0613(f)(1). A County-wide elected official who does not participate in a County-
23 sponsored medical plan will receive an amount of \$161.54 per pay period.

24 (B) County-wide elected officials shall not receive the benefits
25 described in Subsection 13.0613(f)(6) related to short term disability.

26 (C) County-wide elected officials shall not receive the benefits
27 described in Subsection 13.0613(k)(1)(B)(III) related to eligibility for MPS and DPS while
28 on leave.

(D) County-wide elected officials shall not receive the benefits described in Subsections 13.0613(k)(4)(A) and 13.0613(k)(4)(B) related to sick leave conversion to Retirement Medical Trust Fund (RMT). County-wide elected officials shall be eligible to participate in the RMT upon taking office. The County will contribute to the RMT as follows for County-wide elected officials:

Total Years of Service	Percentage of Base Salary*
Elected —0-9 years	2.00%
Elected —10-15 years	2.75%
Elected —16 or more years	3.75%
*For purposes of the RMT contribution, base salary is as defined in the RMT plan document.	

(E) In addition to the benefits described in Subsection 13.0613(~~on~~)(1) related to automobiles, County-wide elected officials shall be entitled to have a Category I County vehicle assigned to them for use on County business and they will not be required to reimburse the County for occasional personal use. County-wide elected officials shall be taxed for any such personal use in accordance with state and federal tax law and regulation. County-wide elected officials shall not receive the automobile allowance described in Subsection 13.0613(~~on~~)(3) and will receive the \$561.54 per biweekly pay period.

(I) In lieu of other benefits provided to Exempt Group employees, County-wide elected officials shall have five percent of their base salary contributed by the County on their behalf on a biweekly basis to either (1) the County's 457(b) Deferred Compensation Plan, or (2) the County's 401(a) Defined Contribution Plan.

(II) Tier 1 County-wide elected officials shall have \$442.53 contributed by the County on their behalf on a biweekly basis to either (1) the County's 457(b) Deferred Compensation Plan, or (2) the County's 401(a) Defined Contribution Plan.

(c) Benefits—Board of Supervisors. Members of the Board of Supervisors

1 shall receive only the following benefits.

2 (1) Retirement System Contributions.

3 (A) The County will contribute to the San Bernardino County
4 Employees' Retirement Association (SBCERA) all required employer contributions for
5 members of the Board of Supervisors. All mandatory employee retirement contributions
6 shall be paid by the Board members.

7 (B) All such mandatory employee retirement contributions made
8 to SBCERA, although designated as employee contributions under the County
9 Employees Retirement Law of 1937 and although deducted from the compensation of
10 Board members, shall be picked up by the County for tax purposes in accordance with
11 Internal Revenue Code section 414(h)(2) and shall be treated by the County as paid by
12 the County to SBCERA in lieu of contributions by Board members who are members of
13 SBCERA, as authorized by County Resolution 2008-249. The amounts picked up by
14 the County under this subsection shall be treated as compensation paid to Board
15 members for all other purposes. County paid employer contributions to the County's
16 Retirement System under this subsection shall be paid from the same source of funds
17 used in paying the salaries of the affected Board members. No Board member shall
18 have the option to receive the Retirement System contribution amounts directly instead
19 of having them paid to the County Retirement System. Until retirement or separation,
20 all contributions picked up under this subsection will be considered for tax purposes as
21 employer-paid contributions.

22 (C) Survivor Benefits are payable to employed general
23 retirement members with at least 18 months continuous retirement membership
24 pursuant to Government Code section 31855.12. An equal, non-refundable employer
25 and employee biweekly contribution will be paid to SBCERA as provided in the annual
26 actuarial study.

27 (2) Medical and Dental Coverage Insurance.

28 (A) Except as provided in subsection (C) below, all Board

1 members must enroll in a medical and dental plan offered by the County. Board
2 members who fail to elect medical and dental plan coverage will be automatically
3 enrolled in the medical and dental plan with the lowest biweekly premium rates available
4 in the geographical location of the Board member's primary residence.

5 (B) Enrollment elections must remain in effect for the remainder
6 of the plan year unless a Board member experiences an IRS qualifying event. Board
7 members may elect to enroll their dependent(s) upon initial eligibility for medical and
8 dental insurance. Thereafter, newly eligible dependents may be enrolled within 60 days
9 of obtaining dependent status, such as birth, adoption, marriage, or registration of
10 domestic partnership. Notification of a mid-year qualifying event must be submitted to
11 Human Resources, in accordance with procedures adopted by the County. Board
12 members are responsible for notifying the County within 60 days of dependent's change
13 in eligibility for the County plans. Dependent(s) must be removed mid-plan year when a
14 dependent(s) becomes ineligible for coverage under the insurance plan eligibility rules,
15 for example, divorce, over-age dependent, or gain of coverage on spouse's or domestic
16 partner's employer-provided insurance, or termination of domestic partnership.
17 Premiums for coverage will be automatically deducted from the Board member's pay
18 warrant. Failure to pay premiums will result in loss of coverage for the Board member
19 and/or the dependents.

20 (C) Board members eligible for medical plan coverage who are
21 also enrolled in comparable group medical plan sponsored by another employer or are
22 covered by a spouse or domestic partner who is also employed with the County may
23 elect to discontinue enrollment in County-sponsored medical plan (opt-out or waive).
24 Board members who either elect to opt-out of County-sponsored medical plan coverage
25 or waive coverage to a spouse or domestic partner who is also employed with the
26 County will not receive any medical premium subsidy, and will instead receive the
27 biweekly amount of \$40.00 per pay period. Board members eligible for dental plan
28 coverage who are also enrolled in a comparable group dental plan sponsored by

1 another employer may elect not to participate in a County-sponsored dental plan. The
2 rules and procedures for electing to opt-out of County-sponsored medical and dental
3 plan coverage are established and administered by Human Resources.

4 (3) Medical and Dental Subsidies.

5 (A) The County will establish a medical premium subsidy (MPS)
6 to offset the cost of medical and dental plan premiums charged to Board members. The
7 MPS shall be applied first to medical insurance premiums and then to dental plan
8 premiums. The applicable MPS amount shall be paid directly to the providers of the
9 County-sponsored medical and dental plans in which the Board member has enrolled.
10 The MPS shall not be considered compensation earnable for purposes of calculating
11 benefits or contributions for the San Bernardino County Employees' Retirement
12 Association. In no case, shall the MPS exceed the total cost of the medical and dental
13 insurance premium for the coverage selected. The County will establish a MPS, if
14 applicable, in the following amounts:

Coverage Level	MPS Amount
Board member only	\$230.00
Board member + 1	\$352.23
Board member + 2	\$482.64

18 (B) The County has established a dental premium subsidy
19 (DPS) for Board members whose premium costs for medical and dental insurance
20 exceeds the MPS, in an amount up to \$9.46 but not to exceed the combined total of the
21 Board member's out-of-pocket expenses. For example, a Board member who selects
22 "Board member only" coverage for medical and dental with a combined per pay period
23 premium cost of \$234.00 will receive a DPS in the amount of \$4.00 per pay period.

24 (4) Vision Insurance. Subject to carrier requirements, the County will
25 pay the premiums for vision care insurance for Board members and their dependents.

26 (5) Expense Reimbursement.

27 (A) General Provisions. The purpose of this subsection is to
28 define the policy and procedures by which Board members shall report and be

1 reimbursed for necessary expenses incurred on behalf of San Bernardino County. As
2 elected officials, Board members shall assure that expenses submitted for
3 reimbursement are reasonable and necessary expenditures. No other approval is
4 required.

5 (B) Records and Reimbursements.

6 (I) Requests for expense reimbursements should be
7 submitted once each month, except if the amount claimable for any month does not
8 exceed \$25.00, the submission may be deferred until the amount exceeds \$25.00
9 quarterly, or until June 30 during the current fiscal year, whichever occurs first. At the
10 end of the fiscal year, expense reimbursement claims for July 1 and beyond, must be on
11 a separate claim from those expenses claimed for June 30 or earlier.

12 (II) Receipts or vouchers which verify the claimed
13 expenditures will be required for all items of expense, except:

14 (i) Subsistence, except as otherwise provided in
15 this subsection;

16 (ii) Private mileage;

17 (iii) Taxi, streetcar, bus, and ferryboat fares; bridge
18 and road tolls; and parking fees;

19 (iv) Telephone and other communication – related
20 charges;

21 (v) Other authorized expenses of less than \$1.00.

22 (III) Claims for expense reimbursement totaling less than
23 \$1.00 in any fiscal year shall not be paid.

24 (IV) Reimbursement shall not be made for any personal
25 expenses such as, but not limited to: entertainment, barbering, etc.

26 (V) Except as otherwise provided in this subsection,
27 expense reimbursements shall be made on an actual cost basis.

28 (C) Transportation Modes.

1 (I) The general rule for selection of a mode of
2 transportation is that mode which represents the lowest expense to the County.

3 (II) Travel via Private Automobile. Board members who
4 travel by use of a private automobile for which they receive an automobile allowance or
5 who use a County-provided vehicle pursuant to Subsection 13.0614(c)(6) below, will not
6 also be reimbursed for mileage.

7 (III) Travel via Air. All travel that requires air
8 transportation shall be made by commercial aircraft. When commercial aircraft
9 transportation is approved, the "cost of public carrier" shall mean the cost of air coach
10 class rate including tax and security surcharges. Travel via charter aircraft shall not be
11 allowed, unless other types of transportation are impractical or more expensive.

12 (IV) Travel via Rental Vehicles. Reimbursement will be
13 provided for the cost of a rental vehicle used for business purposes. Rental vehicles
14 are covered for liability and vehicle physical damage under the County's self-insurance
15 program. Reimbursement will not be provided for the additional costs incurred if any
16 Board member purchased any additional insurance or signs a collision damage waiver
17 (CDW) when renting a vehicle for County business. Requests for reimbursement for
18 gasoline for rental vehicles must be accompanied by a copy of the rental agreement or
19 rental receipt and gasoline receipt.

20 (D) Subsistence.

21 (I) Claims for lodging and meals which do not exceed the
22 allowances listed below do not require receipts.

23 (II) The allowance for lodging is the maximum lodging
24 rate identified in the Maximum Federal Per Diem Rates table in IRS Publication 1542.

25 (III) The allowance for meals is the Meal and Incidental
26 Expense (M&IE) Rate identified in the Maximum Federal Per Diem Rates table in IRS
27 Publication 1542. If less than three meals in a day are being claimed, the allowance per
28 meal is 22 percent of the M&IE Rate for breakfast, 30 percent of the M&IE Rate for

1 lunch, and 48 percent of the M&IE Rate for dinner.

2 (IV) Meal allowances for a business meeting/conference
3 including meals are the actual costs.

4 (E) Expense Advances.

5 (I) Advancement of funds for business expenses can be
6 obtained from the Auditor-Controller/Treasurer/Tax Collector through submission of the
7 appropriate form. Advancements shall not exceed the per diem allowances set forth
8 herein. The minimum amount to be advanced is \$50.00.

9 (II) County Credit/Debit Cards. The County may issue a
10 County credit or debit card to a Board member and require business expenses be paid
11 for with said card. If unauthorized charges are placed on the card, the Board member
12 shall be required to reimburse the County. If the Board member fails to reimburse the
13 County within 15 calendar days, the Auditor-Controller/Treasurer/Tax Collector may
14 recover any unauthorized charges from the Board member's pay.

15 (F) Compliance. The following provisions and policies comply
16 with Government Code section 53232 et seq.:

17 (I) When reimbursement is otherwise authorized by
18 statute, the County may reimburse Board members for actual and necessary expenses
19 incurred in the performance of official duties.

20 (II) The types of occurrences that qualify a Board
21 member to receive reimbursement of expenses relating to travel, meals, lodging, and
22 other actual and necessary expenses include the following:

23 (i) Communicating with representatives of
24 regional, state and national government on County adopted policy positions;

25 (ii) Attending educational seminars designed to
26 improve officials' skill and information levels;

27 (iii) Participating in regional, state, and national
28 organizations whose activities affect the County's interests;

1 (iv) Attending County events;
2 (III) All other expenditures require approval by the Board
3 of Supervisors.

4 (IV) The reasonable reimbursement rates for travel,
5 meals, and lodging, and other actual and necessary expenses are those set out in San
6 Bernardino County Code Subsection 13.0614(c)(5).

7 (V) If the lodging is in connection with a conference or
8 organized educational activity, lodging costs shall not exceed the maximum group rate
9 published by the conference or activity sponsor, provided that lodging at the group rate
10 is available to the Board member at the time of booking. If the group rate is not
11 available, the Board member shall use comparable lodging.

12 (VI) Board members shall use government and group
13 rates offered by a provider of transportation or lodging services for travel and lodging
14 when available.

15 (VII) All expenses that do not fall within this policy or the
16 IRS reimbursable rates shall be approved by the Board of Supervisors, in a public
17 meeting before the expense is incurred, or ratified after the expense is incurred, when
18 prior action is not possible due to the urgency of the requirement for the expense.

19 (VIII) Expense Reports. The County Auditor
20 Controller/Treasurer/Tax Collector shall provide expense report forms to be filed by the
21 members of the Board of Supervisors for reimbursement of actual and necessary
22 expenses incurred on behalf of the local agency in the performance of official duties.

23 (i) The expense reports shall document that the
24 expenses meet this policy, and all other applicable County policies, for expenditure of
25 public resources.

26 (ii) Board members shall submit expense reports
27 to the County Auditor-Controller/Treasurer/Tax Collector within a reasonable time after
28 the expense is incurred, and the reports shall be accompanied by the receipts

1 documenting each expense.

2 (iii) Board members shall provide brief reports on
3 any meeting, as defined in the Ralph M. Brown Act under Government Code section
4 54952.2, attended at the expense of the County at the next regular Board meeting.

5 (iv) All documents related to reimbursable County
6 expenditures are subject to disclosure under the California Public Records Act,
7 Government Code section 6250 et seq.

8 (IX) Penalties. Penalties for misuse of public resources or
9 falsifying expense reports in violation of Subsection 13.0614(c)(5) or other applicable
10 law may include, but are not limited to, the following:

11 (i) The loss of reimbursement privileges;

12 (ii) Restitution to the County;

13 (iii) Civil penalties for misuse of public resources,
14 pursuant to Government Code section 8314;

15 (iv) Prosecution for misuse of public resources
16 pursuant to Penal Code section 424.

17 (6) Automobiles.

18 (A) All Board members shall be entitled to have a Category I
19 County vehicle assigned to them for use on County business. Board members may use
20 such vehicles for occasional personal use provided they reimburse the County at the
21 current motor pool variable rate per mile for such use.

22 (B) Board members electing not to obtain a County vehicle
23 pursuant to the previous paragraph shall receive a biweekly automobile allowance in the
24 amount of \$561.54 with no mileage reimbursement, provided they provide a private
25 vehicle for their own use on County business. The First District Supervisor shall receive
26 a 50 percent addition to the biweekly amount provided to Board members. Board
27 members selecting this allowance shall be required to have a vehicle available at all
28 times for use on County business. This allowance shall be considered complete

1 reimbursement for the acquisition, insurance, maintenance, repair, upkeep, fuel, and all
2 other costs for the required vehicle.

3 (7) Flexible Spending Account (FSA) for Medical-Related Expenses.

4 (A) General. The County has established a Medical Expense
5 Reimbursement Plan, also known as a Flexible Spending Account (FSA). This plan has
6 been established in accordance with the provisions of Internal Revenue Code section
7 125. Human Resources will serve as the FSA Plan administrator and will administer the
8 FSA in accordance with the County's plan document. The FSA's plan year will coincide
9 with the County's benefit plan year.

10 (B) Board members may contribute to the FSA, on a pre-tax
11 basis, an amount up to the Internal Revenue Code's annual maximum. This annual
12 contribution is made by the board member via equal biweekly payroll deductions. The
13 County will not make any matching contributions on behalf of Board members. Board
14 member participants must elect to enroll each year in order to continue participation.
15 Upon enrolling in the FSA, Board members may not change their designated biweekly
16 contribution amount or discontinue making contributions for the remainder of the plan
17 year except as permitted by the Internal Revenue Code. Any unused amounts
18 remaining in a board members FSA account at the end of the Plan year shall be
19 forfeited except as permitted by the Internal Revenue Code and the County's plan
20 document. Contributions made to the FSA may be used for receiving non-taxable
21 reimbursements of eligible medical expenses not covered by insurance. Eligible
22 reimbursable expenses are those medical expenses that qualify as determined under
23 Internal Revenue Code section 213.

24 (8) Defined Contribution and Deferred Compensation Plans. Board
25 members shall be eligible to contribute to the County's 401(k) Defined Contribution Plan
26 and 457(b) Deferred Compensation Plan. The County shall not make any matching
27 contributions to any defined or deferred contribution plan on behalf of Board members.

28 (9) Voluntary Insurance Programs. In accordance with the procedures

1 established by the Human Resources Division Chief, Board members may purchase,
2 through payroll deductions, term life insurance in \$10,000.00 increment amounts to a
3 maximum benefit of \$700,000.00. Board members may purchase amounts of
4 accidental death and dismemberment insurance coverage for themselves and
5 dependents through payroll deduction. Board members may purchase, through payroll
6 deductions, variable group universal life insurance subject to carrier requirements and
7 approval. The benefit levels for such insurance shall be equivalent to no more than
8 three times the Board member's annual base salary. There shall be no County
9 contribution toward the Board member's purchase of variable group universal life
10 insurance.

11 (10) Healthy Lifestyles Program. The Healthy Lifestyle program is
12 available to Board members. Under this program, Board members are eligible for
13 annual prepaid memberships with health clubs that participate in the program, or
14 reimbursement for other comparable health club membership up to \$324.00 on an
15 annual basis. Board members are also eligible for an annual physical examination
16 through the Arrowhead Regional Medical Center.

17 (11) Tuition Reimbursement and Membership Dues. The County shall
18 establish an individual fund in the amount of \$1,000 for each fiscal year for each Board
19 member to reimburse Board members for tuition costs incurred for job-related education
20 or career development or to reimburse membership dues in professional
21 organization(s), providing each expenditure enhances furtherance of County or
22 continuing education goals.

23 (12) Dependent Care Assistance Program. Board members are eligible
24 to participate in the Dependent Care Assistance Program (DCAP). The purpose of the
25 DCAP is to permit Board members and eligible County employees to make an election
26 to pay for certain dependent care expenses with salary reduction from compensation
27 contributed to the plan before federal income taxes are paid to the IRS ("Salary
28 Reduction") in accordance with Internal Revenue Code sections 125 and 129 and

1 regulations pursuant thereto. The DCAP shall be construed to comply with said code
2 sections and to meet requirements of any other applicable provisions of law. The DCAP
3 will be administered in accordance with procedures established by Human Resources,
4 and consistent with the plan document.

5 (13) Term Life Insurance. The County will pay the premium for a term
6 life insurance policy with \$50,000 in coverage for Board members.

7 (14) Long-Term Disability Insurance. The County will provide Board
8 members with long-term disability insurance subject to carrier requirements and
9 approval. The benefit levels for such insurance shall be those approved by the Director
10 of Human Resources.

11 (15) Portable Communication Device Allowance. Board members shall
12 receive a biweekly portable communication device allowance in the amount of \$92.31, if
13 the following conditions are met: (1) The Board member shall purchase a portable
14 communication device capable of sending and receiving cellular telephone calls, and
15 capable of sending and receiving e-mails to and from the County e-mail system; (2) Any
16 portable communication device to be utilized for sending and receiving e-mail shall be
17 selected from a list as approved by the Information Services Department; and, (3) The
18 County shall pay for any license and set up expense for the device, if any, and the
19 Board member shall pay for the equipment and all monthly charges including all voice,
20 text, and data plans.

21 (16) Retirement Medical Trust. The County will contribute to the San
22 Bernardino County Retirement Medical Trust one percent of an eligible Board member's
23 biweekly salary for Board members with zero to nine years of participation in SBCERA,
24 one and three-quarters percent of an eligible Board member's biweekly salary for Board
25 members with 10 to 15 years of participation in SBCERA, and two and three-quarters
26 percent of an eligible Board member's biweekly salary for Board members with 16 or
27 more years of participation in SBCERA. The trust will establish individual accounts for
28 each Board member. All of the contributions to the trust fund will be treated for tax

1 purposes as employer, non-elective contributions. The purchase of additional
2 retirement credit or other retirement service credit shall count as years of participation
3 for determining eligibility. Participation in other public sector retirement systems may
4 also be counted towards the service requirement provided that the Board member has
5 not withdrawn his or her contributions from that system and is also a participant in
6 SBCERA.

7 (c) (Repealed by Ord. 3953, passed - -2005).

8 (d) (Repealed by Ord. 3953, passed - -2005).

9 (e) Employment Status. A County employee in a regular County position
10 becoming an elected official of San Bernardino County shall be compensated, at the
11 time of termination from regular employment to the time of assuming office, for unused
12 vacation, holidays, and sick leave conversion, if eligible. Should such an elected official
13 return to County employment in a regular position, such employee shall be treated as a
14 new employee and receive a new benefit date except as hereinafter provided. A person
15 that has served as an elected official of the County and who returns or has returned to
16 County employment in a regular position within 90 days after leaving an elected office of
17 the County, shall be entitled for purposes of vacation accrual rates to count all prior
18 County employment, including the time as an elected official of the County. The
19 effective date of any vacation accrual rate adjustment shall not precede the effective
20 date of this amendment.

21 (f) Salary Adjustments. The County Administrative Office, in concurrence
22 with County Counsel, shall conduct the compensation and salary surveys required in
23 Section 308 of Article III of the County Charter, and shall report to the Auditor-
24 Controller/Treasurer/Tax Collector and the Board of Supervisors concerning appropriate
25 adjustments to be implemented as required by Section 308 of Article III of the County
26 Charter. The Auditor-Controller/Treasurer/Tax Collector shall implement any required
27 adjustments effective December 1 of the applicable year based on the report of the
28 County Administrative Office.

6 (a) *Wages.* The following classes are hereby established: Student Intern
7 and Graduate Student Intern. Student Interns shall be compensated at salary range
8 ~~4M1M~~ of the MOU applicable to the Administrative Services Unit and Graduate
9 Student Interns shall be compensated at salary range ~~5M4M~~ of the MOU applicable
10 to the Administrative Services Unit. Student Interns and Graduate Student Interns
11 shall receive step advances in the same manner as employees in the Administrative
12 Services Unit except that there shall be no right to review or appeal. Advanced step
13 placement may be approved by the Director of Human Resources.

16 (b) *Working Conditions.*

17 (1) *PST Deferred Compensation Plan.* Employees covered by this
18 section shall participate in the County's PST deferred compensation plan in lieu of
19 participation in any other retirement plan, program, or benefit. Said employees shall

21 compensation up to seven and one-half percent of the employee's maximum
22 covered wages for Social Security purposes. The employee's contributions to PST

18 **§ 13.0617f Salaries and Working Conditions of the Student Nurses.**

20 (a) Wages. Student nurses shall receive an hourly rate of pay that is within
21 Salary Range 1M of the Craft, Labor, and Trades Unit.
22

23 (b) Working Conditions. The student nurse classification is for training
24 purposes, and the class is in the unclassified service. The salary rates and step
25 advancement provisions applicable to the Craft, Labor, and Trades Unit shall also apply
26 to student nurses. Student nurses shall be compensated on an hourly rate basis only for
27 hours actually worked and shall receive no other compensation or benefit. Overtime
28

1 shall be defined as all hours actually worked in excess of 40 hours per work period,
2 except that with mutual consent of the appointing authority, student nurses may define
3 overtime as hours worked over eight in one day, or 80 in a 14-day work period. Any
4 student nurse authorized by the appointing authority or authorized representative to
5 work overtime shall be compensated at premium rates, i.e., one and one-half times the
6 employee's regular rate of pay.
7

8 (1) PST Deferred Compensation Plan. Employees covered by this
9 section shall participate in the County's PST deferred compensation plan in lieu of
10 participation in any other retirement plan, program, or benefit. Said employees shall
11 contribute seven and one-half percent of the employee's biweekly base compensation

12 vacation, holiday or sick leave relief; and, other situations involving a fluctuating staff.

16 in institutions, special projects, and annually recurring seasonal peak workloads.
17 Recurrent employees may remain on the payroll system year-round for an indefinite
18 period of time, and may be scheduled to work as needed over the course of one or
19 more years. Employees may not exceed 1,547 hours in a year without the express
20 approval of the Director of Human Resources. Recurrent employees shall be
21 compensated on an hourly basis only for hours actually worked unless otherwise
22 provided or required by law. A recurrent employee's salary shall be within the then-
23 current base salary range established for a job classification with commensurate duties.
24 Recurrent employees may be hired up to the midpoint of the appropriate base salary
25 range with the approval of the appointing authority and through the top step of the
26 appropriate base salary range with the approval of the Director of Human Resources;
27 provided, however, that regular employees appointed to a recurrent position of the
28 same classification shall be compensated at the same step in the recurrent position as

1 they are in their regular position. Exceptions may be made subject to the approval of
2 the Director of Human Resources. Notwithstanding any other provision in this code,
3 step advances are at the discretion of the appointing authority after completion of not
4 less than 1,040 hours worked for each step.

5 Under unusual circumstances and with the approval of the appropriate appointing
6 authority or authorities and the Director of Human Resources, an employee in a regular
7 position may choose to work in a recurrent capacity for the same or another appointing
8 authority and be compensated as such pursuant to this section.

9 Recurrent employees shall participate in the County's PST deferred
10 compensation plan in lieu of participation in any other retirement plan, program, or
11 benefit. Said employees shall contribute seven and one-half percent of the employee's
12 biweekly base compensation up to seven and one-half percent of the employee's
13 maximum covered wages for Social Security purposes. The employee's contributions
14 to PST deferred compensation shall be automatically deducted from employee's
15 earnings. Employees shall enroll in the plan on forms approved by Human Resources.
16 This subdivision shall not apply to any employee who is otherwise covered by the

24 **13.0660 Public Service Employees.**

25 The class of Public Service Employee (PSE) is hereby established. Positions in
26 the PSE class may be assigned to entry level duties in a variety of fields and
27 occupations. Positions may only be allocated as extra-help or recurrent and, as such,
28

1 are in the unclassified service. For layoff purposes, PSE positions are deemed to be
2 the same classification as those positions performing substantially the same duties.

3 A PSE range is established with a starting step at the state minimum wage per
4 hour and steps progressing at \$0.25 per hour up to a maximum of \$17.00 per hour.

5 PSEs may be hired at any step within the pay range as determined by the
6 appointing authority commensurate with their education and/or training and duties to be
7 performed; provided, however, that the PSE salary is consistent with that of employees
8 in regular positions of the same or similar type or nature, and shall be subject to the
9 review and approval of the Director of Human Resources or his/her designee.
10 Notwithstanding any other provision in this code, step advances are at the discretion of
11 the appointing authority after completion of not less than 1,040 hours worked for each
12 step.

13 The Director of Human Resources shall have the authority, with the approval of
14 the County's Chief Executive Officer, to provide Public Service employees with COVID-
15 19 Premium Pay consistent with COVID-19 Premium Pay provided to the majority of the
16 bargaining units.

19 SECTION 8. All portions of this ordinance, except for Section 2, those that
20 amend section 13.0614 of the County Code shall take effect immediately from the date
21 of adoption. Section 2 will be effective 30 days from the date of final passage.
