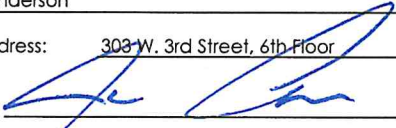

The proposed budget provides funding in the amount of \$942,718 for a County Victim Services Program with 6.2 full-time staff members. Six full-time Victim Advocate II's, committed at 100 percent of their time, paid for by the grant, will provide direct services to victims. One full-time Staff Analyst committed at 20 percent of their time will provide administrative support by preparing and submitting grant applications, budget modifications, grant claims and reports. Four of the Advocates will be located within the community in Police Stations, one Advocate will be located within the San Bernardino Children's Assessment Center along with a Facility K9, and one Advocate will be located at Loma Linda University Children's Hospital to better provide immediate services to victims of crime.

Advocates are qualified with the experience, skills and training to perform a variety of direct and indirect services for crime victims. Advocate II's are expected to have an education equivalent to an Associate's degree in psychology, sociology, criminal justice, behavioral or social science, as well as two years' experience providing advocacy services.

The total budget includes \$754,174 in grant funds and \$188,544 in District Attorney cash match. Of the total budget, \$284,376 in grant funds and \$71,096 in District Attorney cash match will provide salaries for 6.0 FTE Victim Advocate II's.

Grant funds of \$11,148 and \$2,788 in District Attorney cash match will provide for 20 percent of a Staff Analyst II salary. For the XC22 grant cycle, benefits are projected to equal \$203,802. The full amount of benefit expense is not being claimed, benefits in the amount of \$176,194 are included, \$35,236 in cash match and \$140,958 in grant funding.

Ongoing operating expenses will be paid from both grant funds and from the District Attorney's general fund, demonstrating the commitment to minimize administrative costs and support direct services. \$20,000 will be used to directly assist victims with financial needs such as paying for lodging, clothing, utilities, transportation, and other needs, plus emergency gift cards will be used to assist victims with everyday necessities. Of the \$20,000 for direct assistance, \$16,000 will be from grant funds and \$4,000 will be from District Attorney cash match. Vehicle maintenance is budgeted at \$8,100 per year to cover maintenance and fuel for 3 vehicles. Of that budgeted amount, \$6,480 is from grant funds and \$1,620 is from District Attorney grant match. The Facility K9 expenses are budgeted at \$9,000. Of that budgeted amount, \$7,200 is from grant funds and \$1,800 is from District Attorney grant match. Costs include veterinarian care, pet insurance, dog food, grooming, and pet supplies.

Lastly, \$355,016 is budgeted for the subrecipient Partners Against Violence to administer their Crime Survivor Services Program (CSS) that provides 24/7 trauma informed crisis intervention, accompaniment services, follow-up, case management and information/referrals to community resources to victims of crime and their families, administered by trained crisis response advocates and community volunteers. Additional, Partners Against Violence-CSS will provide awareness programming in the community. Of the \$355,016 budgeted, \$284,012 is from grant funds and \$71,004 is funded from District Attorney cash match.

A one-time equipment expense will be paid from both grant funds and from the District Attorney's general fund. The cost of outfitting a vehicle to meet the needs of transporting a Facility K9 is estimated at \$5,000. Of the \$5,000, \$4,000 is from grant funds and \$1,000 is from District Attorney cash match.

Project Narrative

Problem Statement

San Bernardino County is the largest county in the contiguous United States, encompassing 24 incorporated cities and 12 unincorporated communities within an area of over 20,000 square miles and a population of over 2.2 million residents. The county has three distinct areas: the west valley, central, and desert region. Crime victims often live many miles from the nearest victim witness assistance center in dense sprawling urban communities, remote isolated desert areas, and insular mountain ranges hours from the nearest courthouse or victim services center. Historically, victims living in the rural area of Needles travel up to 2 ½ hours and victims living in the rural area of Barstow travel up to an hour to receive services from a victim services center; Both areas have residents that have a significant need for local victim assistance.

In San Bernardino County, over 2,500 children are removed from their homes and placed into foster care each year due to suspected abuse and/or neglect allegations. The Loma Linda University Hospital (LLUH) sees the most complicated, tragic and difficult cases of child abuse both in the Children's Hospital and at the Children's Assessment Center (CAC) of San Bernardino. better serve these children and to increase the number and type of services offered, the Resiliency Institute for Childhood Adversity (RICA) was created. Children seen at the RICA location receive timely medical examinations (within 72 hours) in a multidisciplinary clinic. Each of these children will be offered appointments coordinated through their county social workers; children living near the clinic location can continue with ongoing medical care at the institute and will have the opportunity to have dental evaluations, OT/PT/Speech assessments, developmental assessments, mental health assessments, hearing and vision screenings and treatment. Due to the number of children seen at the hospital there is a significant need for a victim advocate to be placed at this location to provide immediate emergency services and long-term victim needs. According to the San Bernardino County 2020 Community Indicators report 51% of the total San Bernardino County population are Latino, who may be of any race and are the largest race and ethnic group in the County; 30% of the population are White, 8% are Black/African American, 7% are Asian/Pacific Islander, 2% are two or more races and 1% are Native American. The age group of residents from 25-44 made up 28% of the County's population, 45-64 at 23%, 6-17 at 17%, 65+ at 8%, 18-24 at 12% and 0-5 at 8%.

San Bernardino County reported in their 2020 Community Safety Indicators Report that the County's five-year violent crime trend had increased between 2015 and 2019; the violent crime rate increased by 15% between 2018 and 2019; The report further provided detailed information on specific crimes, rape crimes increased 38%, robberies increased 4%, aggravated assaults increased 24% and the homicide rate increased 31%. In 2019 it was reported that there was a total of 147 homicides in San Bernardino County. Considering the geographical size, population and crime rate, the County has not experienced a decline in the number of victims needing assistance. The funding from the XC grant will provide an opportunity to increase the number of victim advocate staff that will provide services to victims of crime in all areas of San Bernardino County which will include one new location for 2023, the Children's Assessment Center (CAC) of San Bernardino. Victims will continue to be able to access services 24/7 and receive additional support services from our partner agency, that historically has provided services to victims of crime.

The San Bernardino County District Attorney's Office Victim Witness Assistance program was established in 1980 to provide direct victim services to respond to the emotional, psychological and physical needs of victims and their families. The program is managed by the Bureau of Victim Services Chief who is part of

District Attorney Jason Anderson's Executive Leadership Team. The department has a successful history of collaboration with other agencies including law enforcement, community-based organizations and other governmental agencies through our advocacy work. The Bureau of Victim Services victim advocate staff are currently located in the regional San Bernardino County District Attorney offices (San Bernardino, Victorville, Rancho Cucamonga, and Joshua Tree), the Children's Assessment Center of San Bernardino, Arrowhead Regional Medical Center, the San Bernardino County Sheriff's Department Headquarters, Barstow Police Department, Rialto Police Department, Chino Police Department and Ontario Police Department. Victim advocates are required to complete the Cal-OES mandated CCVAA Entry Level and Advanced Victim Advocate trainings as well as Crisis Response training; Additional trainings include Brady evidence and disclosure policies, Critical Incident Stress Management, Restitution 101, Self-care as well as other office mandated trainings to ensure that best practices are followed and to lessen the impact of secondary trauma. Penal Code section 13835 et seq. provides for the District Attorney's Victim/Witness Assistance Program to provide all mandatory and optional services to victims including crisis intervention and support services, emergency assistance with funeral/burial expenses, temporary lodging and

relocation, food and clothing, case management and follow up services, referrals to other agencies, orientation to the criminal justice system to include case updates and court accompaniment which includes arranging for travel to court and criminal justice offices if the case is filed by the District Attorney's office and assisting the victim with the completion of the California Victim Compensation Board program application. Victim advocates work closely with court staff, law enforcement, deputy district attorney's, the District Attorney's Victims of Crime Claims units and the community-based victim services agencies in our County, to assist victims with various services to lessen the impact of the crime. Referrals to our victim services program are received by police departments, sheriff's substations, fire departments, Loma Linda University Children's Hospital, the Children's Assessment Center of San Bernardino, Arrowhead Regional Medical Center and various local hospitals, Children and Family Services, Adult Protective Services, city and county schools, and deputy district attorneys from all regional offices. Our services also extend to the Native American community; Services are offered to the Chemehuevi, Fort Mojave and San Manuel tribes. The Bureau of Victim Services provided direct assistance to 10,391 victims of crime and their families in 2021 and 155,313 services. The demographics of the people served were as follows: Males: 3,438, Females:

6,862; Ages 0-12: 753, 13-17: 345, 18-24: 1,052, 25-59: 6,690, 60 & older: 1,083 and 397 were not reported. The program also captured the following demographics of the community we served: American Indian/Alaska Native residents: 31, Asian: 122, Black/African American: 1,320, Hispanic or Latino: 3,718, Multiple Races: 47, Native Hawaiian or Other Pacific Islander: 31, White Non-Latino Caucasian: 2,258, Other Race: 143, and not reported: 2,721 residents. The Bureau of Victim Services victim advocate staff provide assistance to adult victims of physical and sexual assault, child victims of physical abuse, neglect, sexual abuse and assault; Victims of domestic violence, driving under the influence, elder abuse or neglect, hate crimes, human labor and sex trafficking, identity theft, kidnapping, mass violence, hit and run vehicular crimes, robbery, stalking, and survivors of homicide victims.

Plan

The primary program goal of the San Bernardino County District Attorney's Bureau of Victim Services is to provide services expeditiously to victims of all crime types in areas of the County that have been identified as underserved or where there are service gaps to mitigate the negative impact of crime upon the victim and their families. The San Bernardino County District Attorney's Office will

administer the XC Grant Subaward and will act as the single point of contact for the grant. The District Attorney's Office will partner with Partners Against Violence/Crime Survivor Services (Formerly San Bernardino Sexual Assault Services) to provide direct victim services, community outreach and crisis response to victims of crime. Partners Against Violence (PAV) was established under the umbrella of Family Services Agency in 1973 and has been successful in serving victims of sexual violence in the San Bernardino service area for 45 years. PAV is led by a diverse Board of Directors and the Executive Director. PAV has three Rape Crisis Centers and four satellite offices to meet the needs of our geographical area. PAV provides a 24/7 crisis hotline, emergency on-site response, crisis intervention, advocacy, accompaniment, counseling, and group counseling for victims of sexual assault. Community outreach and awareness is also provided to the general community to promote agency information and services. In 2018, PAV opened *Crime Survivor Services (CSS)*, for all victims of crime. The CSS office is based in Rancho Cucamonga but serves the entire county of San Bernardino. The purpose of this program is to provide 24/7 services and access to care for victims of violent crimes. PAV has established a 24/7 crisis hotline and office location for victims of violent crimes to receive direct client services from crisis response advocates. Crisis response advocates

are available to provide 24/7 onsite services at the location that best meets the need of the client. These services address a need for crisis intervention for primary and secondary victims of violent crimes in the County of San Bernardino, which will respond to the emotional and physical needs of the victims. The Bureau of Victim Services staff and PAV/CSS staff will meet on a quarterly basis to discuss the progress of the grant, provide statistics for the Office for Victims of Crime (OVC) Performance Measurement Tool and billing documents.

The Victim Services Steering Committee (VSSC) convened and agreed that the priority would be to have victim advocates and crisis response advocates placed throughout the County to provide trauma informed victim services in areas where there are service gaps and underserved victims. In 2021, to accomplish our goal of providing comprehensive assistance to crime victims living in remote areas and who do not have a local victim services center, the District Attorney's Office placed a victim advocate at the Barstow Police Department. We will continue to fund this position through the XC grant for calendar year 2023. In addition to placing a victim advocate at the Barstow Police Department in 2021, we placed a victim advocate in the city of Needles in January 2022; although the advocate was not placed within the Needles Sheriff's Department, the victim advocate is working closely with the

department's staff. Our new initiatives for 2022 included placing victim advocates at both the Chino and Rialto Police Departments. Residents in all these cities now have access to receive services from a victim advocate without having to travel a distance to the nearest victim assistance center. Victim advocate response, soon after a crime, is essential to assist victims and witnesses that may be experiencing a wide range of emotions and feelings who may also need emergency services such as crisis intervention and resources, food, temporary housing and clothing; these positions will also continue to be funded through the XC grant for calendar year 2023. A 5th location where service gaps have been identified is the Loma Linda University Hospital (LLUH) which includes the Children's Hospital (LLUCH) and Resiliency Institute for Childhood Adversity (RICA), LLUH's newest institute; a victim advocate will be placed at this hospital location once an office can be assigned after the hospital renovations are completed. The LLUH victim advocate will be housed temporarily at the Children's Assessment Center of San Bernardino (CAC) and will respond to the hospital when services are needed for victims of crime who present at the hospital. The victim advocate assigned to the Loma Linda University Hospital will employ the following best practices to streamline the delivery of services to all victims of crime who present at the hospital and minor

victims at the RICA. When a victim arrives at the LLUH, LLUCH or the RICA and when it's deemed the appropriate time, the victim advocate will introduce themselves and offer comprehensive services immediately. A thorough needs assessment will be completed by the victim advocate, after which the victim advocate will make applicable referrals to both emergency resources and to community-based programs. The victim advocate will provide crisis intervention and support services, assistance with temporary lodging and relocation, food and clothing, case management and follow up services, orientation to the criminal justice system, arrange for travel and accompaniment to court and criminal justice offices if the case is filed by the District Attorney's office, referrals to local resources for mental health assistance and other services needed, and assistance with the California Victim Compensation Board application (Cal VCB). The victim advocate will accompany the victim during the medical exam and/or law enforcement interviews at the victim's request. If the victim is admitted to the hospital as an in-patient, the victim advocate will follow up with the victim each day they are in the hospital, and if necessary, will provide further crisis counseling and needs assessment. If the victim is not admitted to the hospital, the victim advocate will provide follow-up services as needed. All victims receive a Marsy's card which lists all their rights under Marsy's law and all

questions regarding their rights as victims will be answered by the victim advocate. Following the above best service protocol has proven to be most effective in providing comprehensive services to crime victims.

The Children's Assessment Center of San Bernardino is a public/private partnership between San Bernardino County and Loma Linda University Children's Hospital. The CAC is a multi-disciplinary child advocacy center whose purpose is to facilitate an objective and forensically sound evaluation of child abuse and neglect investigations. The new initiative for 2023 will be to assign a victim advocate to the CAC who will be responsible for handling a facility dog. The San Bernardino County District Attorney's Office is committed to protecting our most vulnerable victims, our children. Since the inception of our Special Victims K-9 Unit in June of 2015, our office has been successfully providing facility dogs to support and accompany children to alleviate the trauma that children may experience when they are part of the criminal justice system. The facility dog assigned to the CAC will be used primarily to support children during the forensic interview and or medical exam. However, if there is a need for the handler to respond with the facility dog to the LLUCH, the advocate/handler will be able to respond to provide support to the minor victim. The victim advocate

assigned to handle the facility dog will be specially trained and certified through Assistance Dogs International.

In addition, PAV/CSS crisis response advocates will continue to provide assistance to victims of crime in the various regions of the County to ensure that we are providing services that are reasonably accessible.

All victim advocates will participate in community outreach activities on a regular basis to promote the services available to victims of crime and their families. Victim advocates will attend meetings and participate in outreach events at local colleges, community centers, senior centers, the county fair, local civic gatherings and will participate in National Crime Victims' Rights Week and National Night Out. Victim advocates will provide presentations on the services available through the District Attorney's Bureau of Victim Services program to county and city department staff, community-based organizations, law enforcement and school district staff.

The District Attorney's Information Technology Department developed and maintains a comprehensive database (Microsoft Dynamics CRM) which tracks the number of victims assisted and types and number of services provided in compliance with the requirements set forth by the Office for Victims of Crime

(OVC) for the Performance Measurement Tool. The database will be used to track services provided to all victims of crime and the performance measures can be easily collected from the database; CRM will also be used to measure the number of referrals provided to victims to other victim service agencies for immediate crisis intervention and resources; The referring agency name; Barriers to receiving services that victims have overcome such a transportation and child care; We will also measure the barriers to receiving services that victims were not able to overcome . The supervising victim advocates, victim advocates and office assistants update the database each time contact is made with a victim and services have been provided. For each victim, the database contains their name, address, e-mail address, telephone number, date of birth, crime type and services provided. Any supervisor, victim advocate or office assistant that has contact with a victim will be able to immediately identify when and what type of previous contact has been made and what services have been provided to the victim. The information will be used for reporting performance measures for the grant. Supervisors can monitor the database for quality assurance and run reports as needed for performance measures. Caseloads are monitored throughout the grant year to assess needs and determine where advocates are needed. Additionally, our advocates can

assist victims in remote areas, hours away from the nearest regional victim services center, with our Microsoft office cloud-based tenant licensing platform (remote video and audio) to provide critical services to remote inhabitants in our desert and mountain regions.

Volunteers will be recruited by the District Attorney's Office and Partners Against Violence/Crime Survivor Services (CSS) to assist the program in meeting the XC grant objectives. The San Bernardino County District Attorney's website has information on our volunteer program where interested candidates can also apply. Volunteers will be recruited through the outreach efforts made by our staff at local community centers, various college and university campuses and at resource and community fairs. Individuals interested in volunteering are contacted by the Bureau of Victim Services Volunteer Coordinator and are provided complete information and instructions as to the process of volunteering and what the volunteering position entails. All prospective volunteers are required to complete an application that is screened by the volunteer coordinator. The volunteer coordinator and a supervising victim advocate will interview the volunteer, asking a series of questions regarding their interest in our program and experience they have working with victims of crime. The District Attorney's Bureau of Investigations conducts a background check

on qualified candidates and the individual is fingerprinted by the San Bernardino County Sheriff's Department. Once the applicant has received background clearance, they are then required to attend a 4-hour CLETS/Computer use training. The volunteers receive the office mandated training that includes an orientation to the criminal justice system provided by deputy district attorneys who also teach Brady evidence and disclosure policies. Volunteers are paired up with victim advocates to learn how to provide trauma informed services to all victims of crime. Volunteers assist by requesting police reports, contacting victims for missing information for claims, updating case information, translating, sending victim contact letters and assisting the victim advocates in court. Volunteers are required to complete a monthly time sheet, which is then approved by their supervisor and submitted to the volunteer coordinator.
