FINANCIAL IMPACT

Approval of this item will not result in the use of Discretionary General Funding (Net County Cost) as this Affiliation Agreement (Agreement) with the U.S. Department of Veterans Affairs (VA) is non-financial in nature.

BACKGROUND INFORMATION

This Agreement will allow Arrowhead Regional Medical Center's (ARMC) resident physicians to obtain specialized clinical experience at the VA healthcare facilities in Loma Linda.

Resident physicians typically acquire specialty clinical knowledge at other medical facilities. These medical facilities offer the opportunity for resident physicians to gain experience caring for patients and performing procedures in specialties that ARMC may not offer or have too few patients to provide appropriate experience.

ARMC operates several accredited residency programs. Each program has specific requirements as to the numbers and types of patients that a resident physician must provide care. To meet these requirements, with respect to volume and type, it is necessary to provide educational opportunities at other facilities to supplement those available at ARMC.

The Agreement is the VA's standard affiliation agreement that is non-negotiable and omits all of the standard County contract terms.

ARMC recommends approval of this Agreement with the VA to enable ARMC's resident physicians to obtain specialized clinical experience at VA facilities to help provide for the safety, health and social service needs of County patients.
