

RESOLUTION NO. 2024-54

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BOARD OF COUNTY SERVICE AREA 70, ZONE P-6 (EL MIRAGE PARK), FIXING THE SPECIAL TAX RATE FOR FISCAL YEAR 2024-25

On Tuesday, June 11, 2024, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone P-6, therefore, hereby finds and determines:

(a) That on March 5, 1991, the electors of County Service Area 70, Zone P-6, duly authorized a special tax levy for recreation and park services.

(b) That the amount of such tax shall not exceed \$9 per parcel, per year.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing board of County Service Area 70, Zone P-6, therefore, hereby resolves and orders:

(a) That in order to meet the proposed appropriations, the special tax for Fiscal Year 2024-25 shall be set at \$9 per parcel.

(b) That following the adoption of this resolution, the Clerk of the Board shall cause a copy of same to be published once in a newspaper of general circulation within the district.

(c) That this resolution shall be effective July 1, 2024.

(d) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.

ATTACHMENT A

Adopt Resolution setting a special tax for County Service Area 70, Zone P-6 (El Mirage) at \$9 per parcel, per year.

Background: On March 5, 1991, the electorate of County Service Area 70, Zone P-6 (El Mirage) authorized a special tax levy for recreation and park services of \$9 per parcel, per year.

The district currently consists of approximately 3,486 parcels. The tax is anticipated to generate \$31,374 for FY 2024-25, in relation to estimated total proposed appropriations of \$41,770. Estimated operating costs and funding for continuing maintenance projects require the special tax be set at \$9 per parcel.
