1. SECTION E – SPECIAL CONDITIONS

Contractors are advised of the following change as it appears within <u>Section E., Special Conditions</u> of the Specifications

A. Contractors are advised that Section G, Contract Drawings section of the bid package issued on August 15, 2024 (as amended) shall be replaced with:

2. PROJECT SUMMARY OF QUESTIONS AND ANSWERS

A. All the plans do not have a foundation detail except the last one with the curved shelter. It shows a 4" concrete slab over the foundations and bolts. Are the other foundations going to be the same?

The column/footing detail on all other shade structures will be the same. The detail is provided for bidding purposes only and the final size of the footing will be determined by the engineer. There will be no 4" slab over the foundation, please disregard.

B. At the job walk there was no talk about concrete slabs how long and wide would they be.

There will be no 4" slab over the foundation, please disregard.

C. Is this structure rated for the snow load requirements needed for this area?

Yes, snow and wind load will be taken into consideration when stamped engineered drawings and calculations are being completed by engineers at Scenic Shelter.
