

## RESOLUTION NO. 2024-91

### RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, ZONE R-22 TWIN PEAKS, REPEALING PORTIONS OF RESOLUTION NO. 89-282, 95-159, AND 2002-216 AND AUTHORIZING AN INCREASED PROPERTY RELATED SERVICE CHARGE FOR ROAD MAINTENANCE AND SNOW REMOVAL SERVICES

On Tuesday, June 25, 2024, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing body of County Service Area 70, R-22 Twin Peaks hereby finds and determines:

- a) A mailed ballot election, pursuant to Proposition 218 and Cal. Const. art. XIII D, § 6(c), of property owners within County Service Area 70, Zone R-22 Twin Peaks regarding the proposed increase to property related service charge from \$100 per parcel to \$268.42 per parcel, with an annual inflationary increase of up to 3%, effective Fiscal Year 2024-25, for road maintenance and snow removal services.
- b) The election date of March 8, 2024, or any day thereafter, was established as date for the mailed ballot election, for vote by the property owners within County Service Area 70, Zone R-22 Twin Peaks, with the election conducted by an independent election service provider.
- c) Ballots were mailed by an independent election provider on March 9, 2024, were returned and received by the election date of April 30, 2024, and the proposed increased property related service charge was approved by a majority vote (53 Approve, 31 Reject, for an approval of 63.1%) of the properties subject to the service charge.

SECTION 2. The Board of Supervisors of San Bernardino County, acting in its capacity as the governing body of County Service Area 70, therefore, hereby resolves and orders:

- a) The Board hereby adopts the certified election results for the proposed increased property related service charge, which was approved by a majority vote of the property owners of the property subject to the service charge.
- b) That pursuant to the property owner approval, there is hereby established an annual service charge of \$268.42 per parcel, per year, with an annual inflationary increase of up to 3%, effective Fiscal Year 2024-25 on real property within the boundaries of the District and said service charge shall be collected on the tax bills for the affected properties beginning in FY 2024-25, subject to the California State Board of Equalization approval.
- c) That those portions of Resolution No. 89-282, 95-159, and 2002-216 initially establishing an annual property related service charge of \$100 per parcel, per year for road maintenance and snow removal services is hereby repealed.
- d) The Clerk of the Board is hereby directed to certify the passage of this resolution and to file the copies of same and a map or plat indicating the boundaries of the affected territory with the County Assessor and the California State Board of Equalization; the Clerk is further directed to request the recordation of this resolution in the official records of San Bernardino County and to forward copies of this resolution and the map or plat to the following: The Registrar of Voters of the San Bernardino County, the Surveyor of the San Bernardino County, and the Auditor-Controller/Treasurer/Tax Collector of the San Bernardino County.

e) That the Auditor-Controller/Treasurer/Tax Collector is directed to place the direct charge levies on the applicable tax roll.
