

AMENDMENT No. 2

To the Manifest Medex Arrowhead Regional Medical Center Participation Agreement

This Amendment No. 2 to the Agreement (as defined below) is made and entered into as of the last date of signature (“Effective Date”), by and between San Bernardino County on behalf of Arrowhead Regional Medical Center (“Participant”), Inland Empire Health Information Organization, a California nonprofit public benefit corporation (“HIO”), and Manifest MedEx, a California nonprofit public benefit corporation (“MX”). HIO and MX are referred to collectively as “HIE Provider”.

WHEREAS, Participant and HIE Provider have entered into that certain Participation Agreement effective April 17, 2018, as amended (“Agreement”), which sets forth their respective rights, obligations and duties regarding the Agreement;

WHEREAS, Participant has received a notice that beginning January 1, 2024, Inland Empire Health Plan (“IEHP”) may no longer pay Participant’s Subscription Fees.

WHEREAS, Participant wishes to continue its participation in MX.

NOW, THEREFORE, the Parties agree as follows:

1. Term. Paragraph 3 of the Participation Agreement, “Term” is deleted in its entirety and replaced with the following:

“3. The term of this Agreement shall commence on the Effective Date and continue until December 31, 2024 unless otherwise terminated as set forth herein.”

2. Fees. The following shall be added as Section 2(b) of Exhibit 2.c., “IEHP Fee Subsidy”:

“2(b) IEHP Fee Subsidy. Inland Empire Health Plan (“IEHP”) shall pay Participant’s Subscription Fees for the year 2024, subject to final approval by IEHP’s Board of Directors in its December meeting. In the event that IEHP does not receive approval to pay Participant’s Subscription Fees as set forth above, MX shall waive Participant’s Subscription Fees for 2024 contingent upon Participant:

- i. Entering into a good faith negotiation, beginning no later than April 1, 2024, of a revised Participation Agreement either with solely Participant or Participant and San Bernardino County more broadly that will include fees; and
- ii. Engaging in primary source verification (“PSV”) as reasonably requested by MX. The PSV process verifies that the information sent to MX by the Participant matches the information documented in the Participant’s electronic health record as the original primary source of the information.

This Amendment is hereby incorporated into the Agreement by reference. All other terms, conditions and obligations of the Agreement are hereby ratified, reaffirmed and remain in full force and effect. Signatures submitted electronically including by means such as DocuSign or scanned PDFs shall be deemed original signatures of the parties and shall be valid and binding upon the parties hereto.
