RESOLUTION NO. 2020- 156

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70, APPROVING FORMATION OF ZONE SL-11 BLOOMINGTON OF COUNTY SERVICE AREA 70, AND PROVIDING FOR THE COLLECTION OF A SERVICE CHARGE ON THE TAX ROLL

On Tuesday, July 28, 2020, on motion of Supervisor Gonzales, duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

SECTION 1. That County Service Area 70 is organized and operated under the authority of Government Code Section 25210.1 et seq. and is authorized to provide streetlight services.

- (a) That the proceedings for formation of certain described territory into a zone of County Service Area 70, to be known as Zone SL-11 Bloomington, were initiated by petition to this Board from the affected property owners.
- (b) That the exterior boundaries of the territory proposed to be formed into the said zone are described and set forth in Exhibit "A", attached hereto and incorporated herein by this reference.
- (c) That boundaries are definite and certain, as described herein, and do not split any lines of ownership as shown on the last equalized assessment roll or by documents of record.
- (d) That the territory herein above described is in need of streetlight services and will benefit thereby; that said services may be extended to such territory and can most conveniently be provided to such territory by formation of said zone.
- (e) The proposed zone would provide general additional revenue to finance the streetlight services in the form of a service charge on all parcels within the zone.
- (f) That the Board called for a public hearing on the proposed formation to be held on July 28, 2020 at 10:00 a.m. at the Chambers of the Board of Supervisors, County Government Center, 385 North Arrowhead Avenue, First Floor, San Bernardino, California.
- (g) That a public hearing was held on said date and all parties desiring to be heard have been heard and testimony and evidence for and against the proposed formation, if any, were duly considered.
- (h) That County staff has determined that this action is exempt from environmental review under the California Environmental Quality Act.

SECTION 2. The Board of Supervisors of the County of San Bernardino, acting as the governing body of County Service Area 70, hereby resolves and orders:

- (a) That the territory described on Exhibit "A" should be, and it hereby is, ordered formed into Zone SL-11 Bloomington with the power to provide streetlight services therein.
- (b) That there is hereby established an annual service charge of \$1,544.00 with an inflationary increase up to 4% annually, per parcel on real property within the boundaries of SL-11 and

annual service charge shall be collected on the bills for the affected properties beginning in the 2020-2021 fiscal year.

- (c) That the Clerk of the Board is hereby directed to certify to the passage of this resolution and to files copies of same and a map or plat indications the boundaries of the affected territory with the County Assessor and the State Board of Equalization; the Clerk is further directed to request the recordation of this resolution in the official records of San Bernardino County and to forward copies of this resolution and map or plat to the following: the Registrar of Voters of the County of San Bernardino, the Surveyor of the County of San Bernardino, and the Auditor-Controller/Treasurer/Tax Collector of the County of San Bernardino.
- (d) That there will be no exchange of property tax revenue between the affected taxing agencies as the result of this formation.
