Approval of this appointment will not result in the use of additional Discretionary General Funding (Net County Cost) as there is no cost associated with the appointment.

**BACKGROUND INFORMATION**

In September 1990, California Assembly Bill (AB) 2766 was signed into law, authorizing a \$4 per vehicle surcharge on annual registration fees. This money is used to fund the implementation of programs to reduce air pollution from motor vehicles, pursuant to air quality plans and provisions of the California Clean Air Act. To determine which projects should be funded, AB 2766 called for the creation of the Mobile Source Air Pollution Reduction Review Committee (MSRC), and the Mobile Source Air Pollution Reduction Review Committee – Technical Advisory Committee (MSRC-TAC). The MSRC-TAC is charged with making recommendations to the MSRC, which makes recommendations to the South Coast Air Quality Management District Governing Board (AQMD) regarding projects that should be funded.

On May 9, 2023 (Item No. 24), the Board of Supervisors (Board) approved the appointments of Mark McCullough, Director of Fleet Management, as the County representative on the MSRC-TAC, and Bradley Jensen, Legislative Director, as the alternate.

Approval of the recommendation will appoint the Deputy Director to the alternate County representative seat formerly held by Bradley Jensen.
