IT IS HEREBY AGREED AS FOLLOWS:

The following is Amendment No. 2 to Contract No. 21-482 for NCTI and Enrichment Services.

1. SECTION VIII. TERM is amended to read as follows:

This Contract is effective as of July 1, 2021 and is extended from its original expiration date of June 30, 2024, to expire on June 30, 2026, but may be terminated earlier in accordance with provisions of Section IX of the Contract.

3. All other terms and conditions of Contract No. 21-482 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein.
