IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 1

It is hereby agreed to amend Contract No. 25-502, effective July 1, 2026, as follows:

SECTION C. GENERAL CONTRACT REQUIREMENTS, add Paragraph 69. to read as follows:

- 69. **Byrd Anti-Lobbying Amendment (31 U.S.C. § 1352 (as amended))** - Contractor certifies on Attachment F that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any Federal contract, grant or any other award covered by 31 USC 1352. Contractor shall also disclose to the County any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award.

SECTION D. TERM OF CONTRACT, amend Paragraph 1. to read as follows:

- 1. This Contract is effective as of July 1, 2025 and is extended from its original expiration date of June 30, 2026, to expire on June 30, 2027 but may be terminated earlier in accordance with

provisions of this Contract. The Contract term may be extended for three (3) additional one (1) year periods by mutual agreement of the parties.

SECTION F. FISCAL PROVISIONS, amend Paragraph 1. to read as follows:

1. The aggregate amount of payment under this Contract is a combined total for all CaWORKs Vocational Education and Training Services Contractors identified in the corresponding Board Agenda Item and together shall not exceed \$7,000,000, of which up to \$7,000,000 may be federally funded and shall be subject to the availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

SECTION F. FISCAL PROVISIONS, amend Paragraph 3. Item 3 to read as follows:

3. Completion
Thirty percent (30%) of the total cost as identified in Attachment A, Training Program Sites and Costs, upon successful completion of program and passing relevant state certification/licensing exams. Copies of Referral to Activity (TAD WTW 109), completion certificate, passing test scores and/or skill levels, and attendance/progress verification must be attached to the invoice. For classes resulting in a state issued license or certification, the state issued licenses or certifications are required to validate completion and must be submitted with the invoice. This includes, but is not limited to Certified Medical Assistant, Certified Nurse Assistant, Home Health Aide, Truck Driver, etc.
