Amendment No. 1

This Amendment is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and Canyon Ridge Hospital, Inc. dba Canyon Ridge Hospital referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:

IN THAT CERTAIN **Contract No. 25-513** ("Contract") by and between San Bernardino County, a political subdivision of the State of California, and Contractor, which Contract first became effective July 1, 2025, the following changes are hereby made and agreed to in the Contract, effective upon execution of this Amendment:

I. REFERENCED CONTRACT PROVISIONS

The Aggregate Maximum Obligation of the REFERENCED CONTRACT PROVISIONS is amended to read as follows:

Aggregate Maximum Obligation:

TOTAL AGGREGATE MAXIMUM OBLIGATION: \$89,513,945

II. V. FUNDING AND BUDGETARY RESTRICTIONS

Paragraph E of Section V of the Contract is amended to read as follows:

E. The maximum aggregate financial obligation under this contract shall not exceed \$89,513,945 for the contract term.

All other terms and conditions of Contract No. 25-513 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.

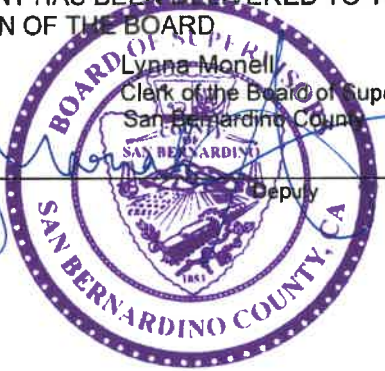
