# AMENDMENT NO. 1 CONSENT AND ASSIGNMENT

**WHEREAS**, on August 9, 2022, San Bernardino County ("County") and Ontario Systems, LLC d/b/a Finvi ("Assignor") entered into an agreement whereby Assignor granted a license to County for the use of the Revenue Plus Collector System Software, effective as of July 1, 2022, for a three-year period ("Agreement"); and

- 4. All references in the Contract to Ontario Systems, LLC d/b/a Finvi. are revised to Columbia Ultimate Business Systems, LLC.
