## EXHIBIT G-2

### SUBCONTRACTOR LISTING

The DBE shall list its Subcontractors, and shall make no substitution except in accordance with Public Contract Code Sections 4100 et seq. ("Subcontractor Listing Law"). As required by Public Contract Code Section 22166(b), following the County's approval of the Contract, the DBE shall award construction subcontracts with a value exceeding  $\frac{1}{2}$  of 1% of the Contract Sum allocable to construction Work as follows: (1) Provide public notice of the availability of work to be subcontracted in accordance with the publication requirements applicable to the competitive bidding process used by the County, including a fixed date and time when qualification statements, bids or proposals will be due; (2) Establish reasonable qualification criteria and standards; and (3) Award the subcontract either on a best value basis or to the lowest responsible bidder – this process may include prequalification or short-listing and does not apply to construction subcontractors listed in the DBE's Proposal. As soon as practicable after award of the Contract, DBE shall provide County with the description of work, name of Subcontractor, business phone and address and contact person for each Subcontractor performing Work on the Project and shall continuously update the County upon selection of each Subcontractor.

The DBE shall list its Subcontractors and shall make no substitution except in accordance with Public Contract Code sections 4100 et seq. ("Subcontractor Listing Law"). As soon as practicable after award of the Contract, DBE shall provide County with the description of work, name of Subcontractor, California Contractor's License number, DIR Registration number, business phone, address and contact person for each Subcontractor performing Work on the Project and shall continuously update the County upon selection of each Subcontractor not required to be listed pursuant to the Subcontractor Listing Law.

The DBE certifies that all subcontractor(s) listed in the Proposal are currently the holder of a valid contractor's license(s) in the State of California, registered with the DIR, and the contractor's license is the correct class of license for the work to be performed by the subcontractor(s).

California Air Resources Board (CARB) In-Use Off-Road Diesel-Fueled Fleets Regulation Compliance Number shall be provided for each listed Subcontractor as appropriate.

Substitution Process. Any request of the DBE to substitute a listed Subcontractor will be considered by the County only if such request is in strict conformity with this procedure and California Public Contract Code section 4100 et seq. All costs and fees incurred by the County in the review and evaluation of a request to substitute a listed Subcontractor shall be borne by the DBE; such costs and fees may be deducted by the County from the Contract Sum then or thereafter due the DBE.
