## Letter of Agreement

The mission of the Foster and Kinship Care Education (FKCE) program at three Community Colleges in San Bernardino County (Barstow College, Chaffey/Citrus College and San Bernardino Valley College) to provide high quality education and training opportunities for Resource Parents of children and youth in out-of-home care in San Bernardino County. The FKCE education/training is offered to assist these providers in meeting the educational, behavioral, and developmental needs of children and youth.

We would like to offer this letter of agreement (Agreement) to enhance the collaborative relationship that exists between the college FKCE program and the San Bernardino County, Children and Family Services (CFS) to illustrate how the college FKCE program and CFS will work together on determining training priorities.

As part of this Agreement the college FKCE program will continue to offer high quality workshops and classes that meet the needs of the San Bernardino County's Resource Parents and agrees to work collaboratively with CFS and the providers in determining what the highest priorities for training will be each year. This collaborative activity may include two quarterly FKCE Curriculum Advisory Committee meetings at each of the three Community Colleges (Barstow College, Citrus College (serving the Chaffey College area), and San Bernardino Valley College) where key county representatives in the local areas and caregivers will be invited to give input in determining training priorities. When needed, the college FKCE program will meet more frequently with the county to ensure the training plans are meeting the county and caregiver needs. The college FKCE program may utilize caregiver training needs assessments in addition to the quarterly meetings.

CFS agrees to collaborate on training plans with the college FKCE Program and will support and encourage caregivers to attend needed training.

This Agreement is effective from February 1, 2025, and will remain in effect for five years, or until terminated by the parties.

Any party may terminate this Agreement for convenience at any time with at least thirty (30) calendar days' written notice of termination of the Agreement.
