**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
TERMINATE MAINTENANCE OF PALM AVENUE, DEVORE AREA**

On Tuesday _____, 2021, on motion of Supervisor _____, duly seconded by Supervisor _____ and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, Section 954.5(a) of the Streets and Highways Code, provides that the Board of Supervisors of San Bernardino County (Board) may, by resolution, terminate the maintenance of any county highway if it finds that the highway is unnecessary for the public convenience; and,

WHEREAS, Section 954.5(b) of the Streets and Highways Code allows the Board to terminate maintenance of any County highway unnecessary for public convenience after hearing evidence at a public hearing; and,

WHEREAS, a public hearing was conducted on the above described date to consider evidence that Palm Avenue, from the north side of Cajon Boulevard north 0.11 mile, in the Devore area, is unnecessary for the public convenience; and

NOW THEREFORE, BE IT RESOLVED, that the Board of Supervisors of San Bernardino County finds and determines that all of the recitals contained hereinabove are true and correct and based on the evidence presented Palm Avenue, from the north side of Cajon Boulevard north 0.11 mile, in the Devore area, is unnecessary for public convenience due to new constructed alignment of Palm Avenue grade separation project between the City of San Bernardino and San Bernardino Associated Governments (SANBAG now known as San Bernardino County Transportation Authority-SBCTA).

BE IT FURTHER RESOLVED, by the Board of Supervisors of San Bernardino County, that the highway listed below shall no longer be maintained by the County and is hereby deleted from the County Maintained Road System:
