THIS CONTRACT is entered into in the State of California by and between the County of San Bernardino, hereinafter called the County, and South Coast Community Services referenced above, hereinafter called Contractor.

### IT IS HEREBY AGREED AS FOLLOWS:

### WITNESSETH:

IN THAT CERTAIN Contract No. 16-406 by and between the County, political subdivision of State of California, and the Contractor for wraparound mental health services, which first became effective July 1, 2016, the contract is hereby amended as follows, effective July 1, 2020:

I. Article IV Funding and Budgetary Restrictions, Paragraph K is hereby amended to read as follows:

K. The maximum financial obligation under this contract shall not exceed \$6,606,687 per fiscal year for fiscal years 2016-17, 2017-18, and 2018-19 and shall not exceed \$9,706,687 for fiscal years 2019-20 and 2020-21. This amendment shall increase the total contract from \$29,526,748 to \$39,233,435. All previously approved Budget Schedules remain in effect. The Revised Comprehensive Children and Family Support Services (CCFSS) Schedules A and B for fiscal year 2020-21 will be submitted to, and approved by, the Director or designee at a later date.

II. Article XIII. Duration and Termination, Paragraph A is hereby amended to read as follows:


A. The term of this Agreement shall be from July 1, 2016 through June 30, 2021 inclusive.
