## **RESOLUTION NO. 2023-159**

RESOLUTION OF THE SAN BERNARDINO COUNTY BOARD OF SUPERVISORS AUTHORIZING AND DESIGNATING THE COUNTY AUDITOR-CONTROLLER/TREASURER/TAX COLLECTOR, IN HIS OFFICIAL CAPACITY AS COUNTY AUDITOR, AND HIS SUCCESSORS, TO EXERCISE THE POWERS SET FORTH IN GOVERNMENT CODE SECTIONS 25257(A), 25258 AND 25259

On Tuesday, August 22, 2023, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, Government Code sections 25257(a), 25258 and 25259 allow for the discharge from accountability for the collection of certain accounts receivable if the amount due and payable is too small to justify the cost of collection, the likelihood of collection does not warrant the expense involved, or the amount due has been otherwise lawfully compromised or adjusted; and

WHEREAS, Government Code section 25259.5 provides that the Board of Supervisors may, by resolution, authorize and designate the County Auditor to exercise the powers set forth in sections 25257 through 25259;

NOW, THEREFORE, BE IT RESOLVED, by the San Bernardino County Board of Supervisors ("Board") as follows:

SECTION 1. The Board hereby authorizes and designates the San Bernardino County Auditor-Controller/Treasurer/Tax Collector, in his official capacity as County Auditor, and his successors, to exercise the powers set forth in Government Code sections 25257(a), 25258 and 25259.

SECTION 2. This resolution shall take effect upon its passage and adoption and, upon such effective date, shall supersede the October 1, 1984, delegation of authority to the County Auditor/Controller in Board Agenda Item No. 51.
