**AMENDMENT 1
ASSET LEASE AGREEMENT #062422A
BETWEEN
San Bernardino County
AND
DMS IMAGING, INC., d/b/a DMS HEALTH TECHNOLOGIES**

This Amendment 1 dated as of May 9, 2023, between DMS Imaging, Inc., d/b/a DMS Health Technologies (“DMS”), having its registered office at 728 East Beaton Drive, Suite 101, West Fargo, ND 58078, and San Bernardino County, a political subdivision organized and existing under the laws and the constitution of the State of California, on behalf of Arrowhead Regional Medical Center (“Healthcare Facility” or “HCF”), having a facility at 400 N Pepper Avenue, Colton, CA 92324. Except as otherwise indicated, all terms defined in the Agreement shall have the same meanings when used in this Amendment 1.

RECITALS

WHEREAS San Bernardino County and DMS Health Technologies have entered into that certain Asset Lease Agreement #062422A dated September 20, 2022, and WHEREAS, San Bernardino County and DMS Health Technologies desire to amend the Agreement to change the Asset Lease Agreement. NOW, therefore, in consideration of the foregoing recitals, the mutual promises and covenants contained herein, the parties hereby agree as follows:

1. The Sections: “Equipment,” “Rent,” and “Term” of the Agreement, is hereby deleted in its entirety and replaced with:

Equipment: One (1) Philips 8 Channel Freewave Intera 1.5T MRI System, in a Ak Specialty Vehicle (or equivalent) mobile medical trailer (collectively the “Equipment”). The following highlights the major Equipment components:

Rent: HCF agrees to pay twenty-eight thousand dollars (**\$28,000.00**) per month beginning on June 12, 2023. As of July 12, 2023, HCF agrees to pay twenty-six thousand fifty dollars (**\$26,050.00**) per month through July 11, 2024. Extensions, if available, of the Initial Term will be based upon the above rate for equal term extensions. Weekly extension of the Initial Term will be prorated based on the calculated weekly rate. All extensions are subject to availability or resources and assets and may include utilization of different assets than the initial term.

All lease payments are to be made in advance at the beginning of the month or lease period, with the delivery transport and first month's rent due upon execution of Agreement for terms eight (8) weeks or longer. For terms less than eight (8) weeks the total rental balance is due upon execution of Agreement.


Term: The Initial Term of the lease shall be a **minimum period of one (1) month, commencing on June 12, 2023**. Beginning as of July 12, 2023, the term of the lease is extended for a **period of twelve (12) months** ("Extended Term"). HCF's ability to extend beyond the Extended Term is strictly subject to Equipment availability, as determined by DMS in its sole discretion. All extension requests should be requested in writing by HCF at least 15 days prior to lease termination.


2. The amendments made to the Agreement by this Amendment 1 shall be effective as of the date of this Amendment 1. Except as amended by Amendment 1 and as specifically stated in this Amendment 1, the Agreement is not modified, revoked or superseded and remains in full force and effect.
