IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 5:

It is hereby agreed to amend Contract No. 20-496, effective July 1, 2023, as follows:

SECTION VII. FISCAL PROVISIONS

Paragraph A is amended to read as follows:

- A. The maximum amount of reimbursement under this Contract shall not exceed \$1,603,664 of which \$1,603,664 may be federally funded and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. These funds are divided as follows:

\$397,672	July 1, 2020 through June 30, 2021
\$416,392	July 1, 2021 through June 30, 2022
\$394,800	July 1, 2022 through June 30, 2023
\$394,800	July 1, 2023 through June 30, 2024

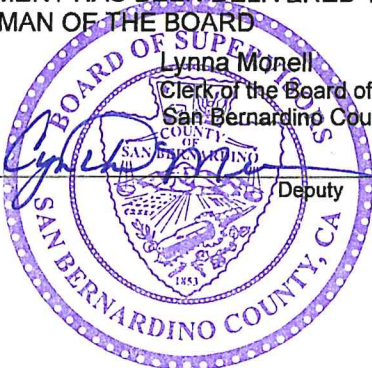
