AMENDMENT NO. 1 TO CONTRACT NO. 22-236

San Bernardino County through the Department of Public Works – Solid Waste Management Division (County) and SCS Field Services (SCS) hereby seek to enter into this Amendment No. 1 to amend Contract No. 22-236 as follows:

1. Delete the first paragraph under Section 5. **Compensation** and replace it with the following:

The maximum amount of payment under this Contract is a combined total for all contractors providing On-Call Landfill and Disposal Site Regulatory Evaluation, Response and Maintenance Services identified in the corresponding Board Agenda Item, and together in the total shall not exceed \$7,500,000. The Total not to exceed amount is an aggregate amount for all Consultants providing On-Call Landfill and Disposal Site Regulatory Evaluation, Response and Maintenance Services for SWMD. Payment shall only be made for work authorized and performed pursuant to the requirements of this Contract.

2. Except as amended herein, all other terms and conditions of the Contract shall remain in effect.
3. This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this
