IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 22-1256 as follows:

SECTION I. DEFINITIONS

Add Paragraph O. to read as follows:

- O. Children's Assessment Center (CAC) – The agency that provides medical and forensic services to examine and diagnose children of suspected sexual and/or physical abuse. This contract refers only to the portion of the CAC that provides medical and mental health services.

SECTION III. CONTRACTOR SERVICE RESPONSIBILITIES

Add Paragraph L. to read as follows:

- L. Provide furnished office space, phones, internet access, locking storage for three CFS Children's Assessment Center (CAC) Staff (including Supervisors, Administrative Social Workers (ASWs), Forensic Interviewers (FIs), Senior Office Assistants (Senior OA) and Office Specialists (OS)) that may be stationed at RICA at any given time, with at least one staff member present during normal business hours to assist with intakes and coordination with RICA.

SECTION V. COUNTY RESPONSIBILITIES

Add Paragraphs F. and G. to read as follows:

- F. Provide computers, a printer, and office supplies for CAC Staff.
- G. Keep CAC staff under CFS supervision and continue performing duties already assigned under the existing agreement, with no additional payment to RICA.

All other terms and conditions of Contract No. 22-1256 remain in full force and effect.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF, or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
