#### IT IS HEREBY AGREED AS FOLLOWS:

### <u>COMMON USE AGREEMENT – AMENDMENT NO. 2</u>

WHEREAS, on October 23, 2012, the San Bernardino County Flood Control District (DISTRICT) and City of Ontario (CITY) executed a Memorandum of Understanding (MOU), Contract No. 12-773 under which the parties agreed to cooperate in the development of a multi-use trail system within portions of DISTRICT right-of-way within the CITY, and

WHEREAS, the parties stipulated in the MOU, that "individual portions of the approved conceptual plan for the trail system shall be accomplished under a separate agreement," and

WHEREAS, on May 24, 2016, the parties executed Common Use Agreement 16-257 (CUA), for a recreational multi-use community trail along segments of the County Line Channel, from Archibald Avenue easterly to the Southern California Edison Easement Area, and Cucamonga Channel, from Chino Avenue to Riverside Drive; and

WHEREAS, Section 13 of the CUA authorizes the parties to amend the CUA in a writing signed by both parties; and

WHEREAS, DISTRICT and CITY now desire to amend the CUA to include approximately 0.25 miles along the east side of Cucamonga Channel from Merrill Avenue to 1,300 feet south of Merrill Avenue as a part of the trail and for which DISTRICT is currently processing Construction Permit No. P-12019121, and

## NOW, THEREFORE, IT IS UNDERSTOOD AND MUTUALLY AGREED AS FOLLOWS:

- 1. This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
- 2. The CUA is hereby amended by adding the following as the Sixth Recital to the CUA:

WHEREAS, DISTRICT is currently processing a construction permit, Permit No. P-12019121, to the CITY to add an additional segment of the multi-use trail along the east side of Cucamonga Creek, from Merrill Avenue to approximately 1,300 feet south of Merrill Avenue (hereinafter called "CITY IMPROVEMENTS NO. 4"), the location of which is shown on attached plans, marked as AREA OF COMMON USE NO. 4 on the attached map marked as Exhibit "!" and;

3. All other terms and conditions of the CUA remain the same.
