BACKGROUND INFORMATION

Assignment and Consent to Assignment for contracts will allow the County of San Bernardino Department of Public Works -Transportation (Department) and the San Bernardino County Flood Control District (District) to continue to utilize the successor of an existing vendor for on-call heavy equipment rental services, as well as tree trimming and removal services.

On June 27, 2017 (Item No. 87), the Board of Supervisors (Board) approved contracts with Porter's Firewood to provide heavy equipment rental services and on July 10, 2018 (Item No. 47), the Board approved contracts with Porter's Firewood to provide tree trimming and removal services. The contract amounts are as follows:

The contracts provide that they are not assignable, in whole or in part, without the written consent of the Department and the District.

On January 2, 2020, the Department and the District were notified that Porter's Firewood incorporated and changed its name to S. Porter, Inc.

S. Porter, Inc. has agreed to accept all obligations, responsibilities, and duties under the above referenced contracts.


