### AMENDMENT NO. 1:

It is hereby agreed to amend Contract No. 18-171, effective February 15, 2020, as follows:

## SECTION IV. COMPENSATION OF CONTRACTOR, Paragraph P is added as follows:

#### P. **BILINGUAL COMPENSATION**

If Contractor is in a position which requires bilingual translation involving the use of English and a second language as part of their regular duties, Contractor shall be entitled to bilingual compensation. Such compensation shall apply regardless of the total time required per day for such translation. Contractors in such positions must be certified as competent in translation skills by Human Resources to be eligible for compensation. Competency Certification is solely determined and administered by Human Resources to be eligible for compensation. Competency Certification is solely determined and administered by Human Resources. Level 1 - verbal skill level is compensable at fifty dollars (\$50.00) per pay period. Level 2 – written skill level compensable at fiftyfive (\$55.00) per pay period.
