WITNESSETH:

IN THAT CERTAIN **Contract No. 18-384** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Comprehensive Treatment Services: Student Assistance Program (SAP) and School-Aged Treatment Services (SATS), which Contract first became effective July 1, 2018, the following changes are hereby made and agreed to,:

I. ARTICLE IV <u>FUNDING</u> and <u>BUDGETARY RESTRICTIONS</u>, paragraph K is hereby amended to read as follows:
