SCHOOL CORNER LAND AQUISITION

All that real property situated in the unincorporated area of the County of San Bernardino, State of California, being a portion of the North half of Section 16, T2N, R1E, S.B.M. according to the official plat thereof, also being a portion of the parcel of land recorded August 29, 1967 in Book 6879 Page 835 of Official Records in the Office of the County Recorder of said county as shown on that certain Record of Survey "19-0022" filed in Book 165 Page 35 of Records of Survey, in the Office of the County Recorder of said, lying northwesterly of the following described line:

BEGINNING at a point on the easterly right-of-way of Stanfield Cutoff from which a three-quarter inch iron pipe tagged L.S. 6856 as shown on said record of survey, being the southwest corner of said parcel of land, and lying 25 feet easterly from and perpendicular to the centerline of Stanfield Cutoff bears South 20°38'48" East, 658.35 feet; thence leaving said right-of-way and **POINT OF BEGINNING** the following three (3) courses:

- 1) North 69°21'12" East, 28.46 feet to a non-tangent curve to the right from which a radius point bears North 81°33'43" East, 150.00 feet;
- 2) thence Northeasterly along said curve through a central angle of 53°27'11", with an arc length of 139.94 feet;
- 3) thence North 45°00'54" East, 77.49 feet, more or less, to **TERMINATE** on the southerly right-of-way of State Highway 38 (North Shore Drive) as described in the "Grant of Easement" recorded April 8, 1969 in Book 7210 Page 630 in the Office said County Recorder and containing

Area of heretofore described property containing 12,760 square feet more or less.

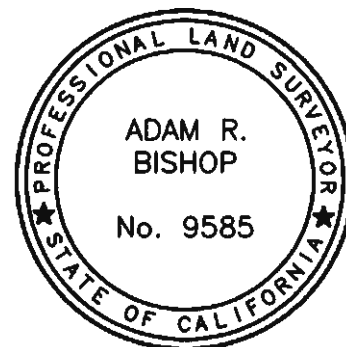

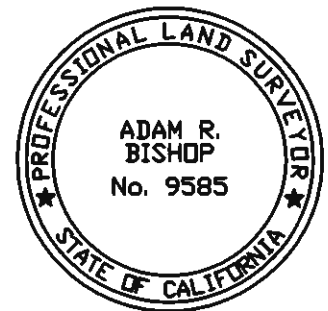
