IT IS HEREBY AGREED AS FOLLOWS:

Pursuant to Section 3.B. of Agreement No. 18-397 (Agreement) between the City of Adelanto (CITY) and the San Bernardino County Fire Protection District (SBCFPD), CITY and SBCFPD agree to amend the Agreement as follows:

1. Section 3.A. is amended to read as follows:
 3. Compensation
 - A. For services provided by SBCFPD to CITY on and after July 1, 2024, CITY shall pay SBCFPD the total lump sum of \$6,227,931 annually, subject to future annual adjustments as described in Section 3.B. CITY shall pay SBCFPD on a monthly basis, in accordance with the payment schedule set below. A cost breakdown of the lump sum annual amount for SBCFPD Fiscal Year 2024-25 is shown in Exhibit "A", attached hereto and incorporated herein by this reference. Payments shall be due by the first (1st) day of each month of service pursuant to Health and Safety Code section 13878. Payments received after sixty (60) days of when due shall include 10% simple interest after the sixtieth (60th) day of when due. SBCFPD shall have the right to terminate this Agreement sooner than provided for in Section 20 if the CITY does not make timely payments of its obligations hereunder to SBCFPD.

Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment No. 8 upon request.

This Amendment No. 8 shall take effect on the date it is signed by both parties.
