## IT IS HEREBY AGREED AS FOLLOWS:

The Fontana Fire Protection District (DISTRICT) and the San Bernardino County Fire Protection District (SBCFPD) agree to amend Agreement No. 18-354 (Agreement) as follows:

- 1. Pursuant to Section 3.B. of the Agreement, Section 3.A. is amended to read as follows:
  - 3. Compensation:
    - A. For the services provided by SBCFPD to DISTRICT, on and after July 1, 2024, DISTRICT shall pay SBCFPD the total lump sum of \$42,500,034 annually, subject to future annual adjustments as described in Section 3.B. DISTRICT shall pay SBCFPD on a monthly basis in accordance with the payment schedule set below. A cost breakdown of the lump sum annual amount for SBCFPD Fiscal Year 2024-25 is shown in Exhibit "A", attached hereto and incorporated herein by this reference. Payments shall be due by the first (1st) day of each month of service pursuant to Health and Safety Code section 13878. SBCFPD shall have the right to terminate this Agreement sooner than provided for in Section 21 if the DISTRICT does not make timely payments of its obligations hereunder to SBCFPD.
